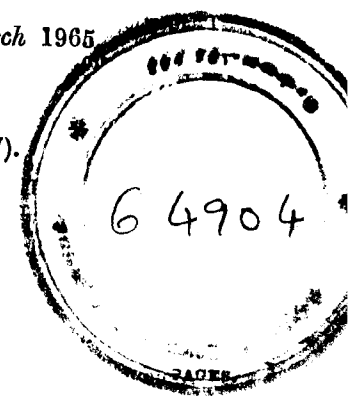

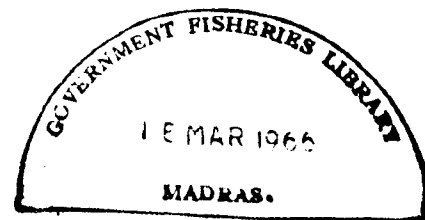
Various Schools, Colleges, Conferences, Ports, temples and similar other broad subjects are shown in alphabetical order under these very Main Headings.

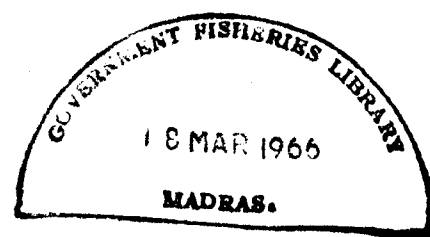
