

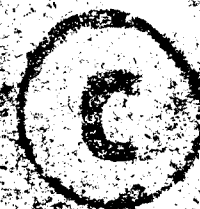

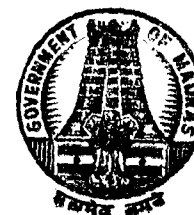

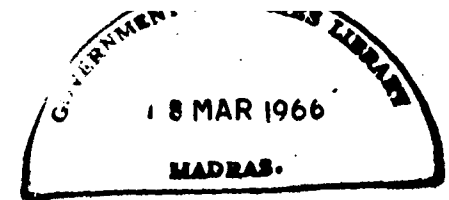

Under every Main Heading including various names, entries pertaining to proceedings other than questions are indicated by printing immediately after the subject matter within brackets, e.g., (M) for Motion, (C.A.) for Calling Attention, (R) for Resolution, (St.) for Statement, etc. An entry without any such indication will mean that it pertains to a question. In the case of Bills and Financial Business, the entry will be self-explanatory.

All the Bills are alphabetically arranged under the main heading "Bill(s)".

Various bodies like Committees, Councils, Boards, Corporations, etc., are consolidated under the said Main Headings, i. e., 'Committee(s)', 'Council(s)', 'Corporation(s)', etc.

Various Schools, Colleges, Conferences, Ports, Temples and similar other broad subjects are shown in alphabetical order under these very Main Headings.

All the Papers laid on the Table of the House are indexed only under the Main Heading "Papers Laid on the Table".

Rulings and Observations from the Chair are indexed under the Main Heading "Chair".
