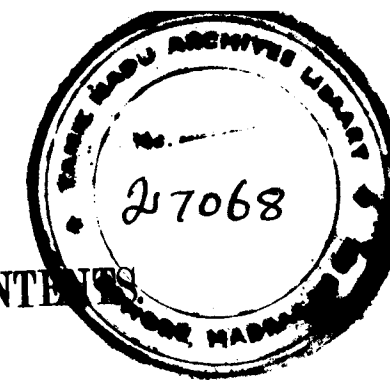
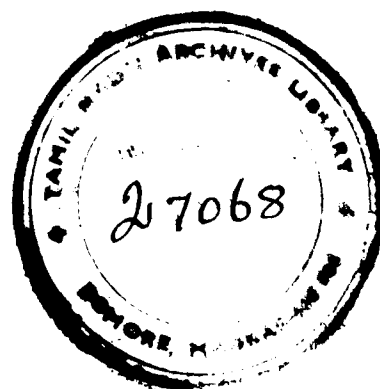

REVIEW OF THE SEA-BORNE TRADE OF THE MADRAS PRESIDENCY FOR THE YEAR 1907-1908.

NOTE.

The total value of the sea-borne trade of the Madras Presidency, including merchandise and treasure, both private and Government, in each of the past five years is set forth in the annexed table, foreign trade being distinguished from coasting trade, which is divided into external, that is, trade carried on with territories and States outside the Presidency, and interportal, that is, trade with ports within the Presidency. The real value of the interportal trade is one-half of that given in the table as the same goods are registered twice—once as exports at one port and again as imports at another.

The trade of the chief port being less than half that of the Presidency has not been separately shown as in the reviews of the trade of other Provinces.

A change has been effected in the tables in the report which relate to the various commodities, by showing the average trade for the five years ending 1905-1906 in addition to the comparative figures of the year under review and of the previous year except in a few instances where change of classification makes this impossible. The actual increase or decrease is also shewn. The figures of foreign trade show, as in previous years, exchanges with countries of export and import respectively, and not with those of production or consumption of commodities.

The total trade of the Presidency is given in the subjoined table.

General Summary.—The total trade of the Presidency in the year under review shows an advance of 253·95 lakhs or six per cent. over that of the previous year, while the foreign trade has increased 10 per cent. the coasting trade has decreased two per cent. The values of the exports of the chief articles of trade excepting hides and skins, viz., raw cotton, seeds, grain and pulse and coffee are all higher, as also of the chief articles of import, viz., cotton yarn, cotton piece-goods and metals. Imports of grain and pulse coastwise dropped about 65 lakhs, while exports of the same commodities and raw cotton to foreign ports increased by 77·5 lakhs and 117·66 lakhs respectively.

The aggregate value of the foreign trade of the Presidency for 1907-1908 exceeded that of the previous year by 283.79 lakhs, which reflected itself in the increase of 121.75 lakhs under imports and 162.04 lakhs under exports, leaving a balance of 40.29 lakhs in favour of the Presidency. The increase under imports was contributed by metals, kerosene oil, gold and silver thread, machinery and millwork, cotton twist and yarn, cotton piece-goods, railway plant and rolling-stock, hardware and cutlery, paper and pasteboard, and glass and glassware. In exports the increase is attributable to the expansion in the exports of raw cotton, grain and pulse, seeds, coffee, tea, oil-cake and provisions, counterbalanced to some extent by a fall in the exports of hides and skins, spices and cotton twist. The causes of fluctuations in each article are shown against the various items in the following pages. Notwithstanding the crisis in the United States of America the money market was easier than last year, probably owing to bad crops elsewhere in India, and for the same reason export freights were also easier.

The following tables give the range of prices for the principal articles of import and export. The year 1873-74 has been taken as the standard price level of some 38 of the principal articles and 1883-84, 1893-94 or 1903-1904 has been taken for the remainder, according to the decade from 1873-74 in which separate values have been first recorded for the articles. These tables show the average value of articles for the year under which the figures are noted, but do not represent variations in the volume of the trade in each particular article.

I.—ANIMALS, LIVING.

During the year under review, 711 horses (689 from Australia) of the aggregate value of 4.39 lakhs of rupees were imported, against 1.52 in the previous year. The higher average value per head during 1907-1908 is due to importation of race horses, six of which were valued at Rs. 84,500, and the decrease in number to smaller remount purchases.

Spices.—Betelnuts form the bulk of imports under this head, and amounted to 25.9 million lb. as against 25.3 million lb. in the previous year. The import from the Straits Settlements amounted to 13.70 million lb. valued at 14.60 lakhs of rupees, and those from Ceylon to 12.2 million lb. valued at 15.58 lakhs of rupees.

Ale, beer and porter.—The decrease of 58,465 gallons shown under this head is probably due to the diversion of a quantity of bulk ale to Bombay whence it was forwarded to this Presidency by rail.

Potable spirits.—The decrease under this head occurs principally in Colombo arrack, the decline in which was 21,486 gallons, due to the competition of Malabar arrack and to a greater demand for low class brandies, resulting in an increase of 6,853 gallons in the imports of the latter. The only other variation of any importance is in gin which shows an increase of 3,963 gallons.

Methylated spirits.—The continued decrease in this is probably due to the excise control by which importations in Madras are limited to 120 gallons while there is no limit at ports in other provinces.

Wines.—The slight decrease under this head is due to smaller imports of champagne, sherry and other sorts, while claret shows an increase in quantity and a decrease in value due to larger quantities of cheap claret imported in bulk.

Provisions.—There were small increases in biscuits, condensed milk and farinaceous foods which are half the total imports under this head.

Sugar.—The imports for the past two years with the average of the five previous years were as follows :—

The decrease of 4.52 lakhs under sugar is the net result of 7.96 lakhs decrease under unrefined sugar and increase under other items, the chief being 1.42 lakhs of refined cane sugar from the Straits. This sugar although shown as from the Straits Settlements is mostly China cane sugar from stocks at Singapore. The quantity of refined beet sugar imported, amounted to 30,072 cwt. against 26,226 cwt. in the previous year. There were no imports of raw cane sugar from Mauritius and Java, but 28,175 cwt. of molasses valued at Rs. 68,894 (mostly from Java) was imported as against 36 cwt. valued at Rs. 132 in the previous year. The variation in the imports of confectionery is very slight, the value of imports from the United Kingdom being 3.40 lakhs against 3.06 lakhs in the previous year.

III.—METALS AND MANUFACTURES OF METALS.

Hardware and cutlery including plated ware.—The hardware and cutlery imported during the year under review was valued at 31.58 lakhs of rupees as against 25.48 lakhs in 1906-1907. The following are the details :—

Copper.—The increase which occurs in all descriptions of copper was about 65 per cent. *Braziers and yellow metal sheets* contribute an increase of 1.07 and 5.33 lakhs respectively. The value of imports of *yellow metal sheets* from the United Kingdom rose from 1.43 lakhs to 9.78 lakhs, while those from Germany fell by 3 lakhs.

Iron and steel.—The imports during the year under review constitute a record, iron showing an increase of 48 per cent. and steel 65 per cent. over the average of the previous five years. This increase is attributed to speculative buying owing to easier prices ruling in the home markets.

The imports of locomotive and other steam engines, although less than in 1906-1907, show an increase of about 45 per cent. over the average of the previous five years. The increase under electrical machinery is due to the more general use of electrical power, and the increase in textile machinery to renewals of plant in spinning and weaving mills.

The chief countries of supply were the United Kingdom and Belgium with 39.10 lakhs and 3.26 lakhs respectively.

Railway plant and rolling-stock.—A continued increase is shown under this head, the increase over the previous year being 7.15 lakhs.

Railway materials for construction.—Increase under this head is attributed to consignments of rails and fish plates for special works on the Madras Railway, and to an extra supply of pot sleepers, etc., for the same railway.

The chief source of supply of *camphor* is Japan, Hongkong and the Straits Settlements, the supplies from the last two places being mostly from stocks of Japanese camphor. No synthetic camphor seems to have been imported yet.

The decrease under *tobacco* is chiefly due to considerably smaller imports of common leaf from Ceylon, but this is counteracted, to a large extent, by increased imports of cigarettes which are 101,676 lb., or 50 per cent. in excess of the previous year, and are 31 times as great as the imports of 1901-1902—they were imported chiefly from the United Kingdom and the United States of America.

Dyeing and tanning materials.—Alizarine and aniline are the chief dyes imported and amounted to 1,330,926 lb. and 229,841 lb. respectively, as against 943,583 lb. and 173,397 lb. in the previous year. The increases indicate the demand for lower priced dyes than the natural vegetable dyes, which are being gradually superseded. These dyes are mostly of German origin though 1,083,005 lb. of alizarine and 166,761 lb. of aniline were actually supplied from stocks in Belgium.

Direct imports show an increase of 2,307,735 gallons, while foreign oils imported through all sources show an increase of 2,193,530 gallons. The stoppage of imports from Russia during 1906-1907 gave an impetus to imports of American case oil which are steadily increasing. During the year the first consignment of *Roumanian* oil in bulk was imported on the West Coast. *Burni* oil shows a decline, the imports being 12,958,050 gallons valued at 41.11 lakhs against 13,117,709 gallons valued at 62.80 lakhs in 1906-1907. Petrol or motor spirit and benzine.—A considerable increase is shown under this, the imports of which in 1906-1907 were 5,064 gallons valued at Rs. 6,955, whereas in the year under review the trade increased to 33,892 gallons valued at Rs. 43,198; this import is included in the figures of "other sorts" of mineral oil.

Vegetable oils.—There is an increase of 19,763 gallons in the imports of cocoanut oil from Ceylon, due to its lower price as compared with the West Coast oil.

Coal, coke and patent fuel.—The increase is due to larger importations of Pacific coal from Australia on account of short supply of Indian coal by rail.

Gums and resins.—*Benjamin* and *rosin* were the chief items under this head; the imports of these amounted to 1.33 and .54 lakhs against 1.06 and .45 lakhs in the previous year.

Hides and skins, raw.—There is very slight variation in this item. The chief source of supply was Ceylon which supplied 3.24 lakhs out of the total 4.80 lakhs.

Seeds.—Imports of rubber seeds show a decrease, the quantity imported in the year under review being 268 cwt. as against 502 cwt. in the previous year.

The increase in value of the medium counts is due to the high level of prices ruling for American cotton during the greater part of the year, while the large increase in quantity and value of counts over 50 may be attributed to the high prices of Egyptian cotton, and to an increasing demand for high counts for the manufacture of fine hand-made cloth.

The large increase of coloured yarn and twist over 50s occurred principally in Turkey red yarn No. 60s and over.

Of the total trade of twist and yarn the United Kingdom supplied 103.04 lakhs.

Owing to a change of classification under the different sub-heads of each class, satisfactory comparisons in several items are not possible. Grey goods show a decrease of 27.48 lakhs, the net result of decreases of 13.26 lakhs under *chadars*, *dhutis*, *saris* and *scarves*, and of 19.63 lakhs under *longcloths* and *shirtings*, counterbalanced, to a slight extent by increased imports of *jaconets*, *cambrics* and *mulls*.

White goods have been in demand throughout the year, especially *nainsooks*, the imports of which were 18.95 lakhs in the year under review, against 7.64 lakhs for the previous year. The increase is also shared by *mulls*, *jaconets* and *cambrics*. The heavy cloths, *longcloths* and *shirtings* showed a decline, the large imports of 1906–1907 in shirtings causing a reaction in the year under review.

Coloured goods show an increase of 17.96 lakhs under *prints* and *chintz* but a decrease under *chadars*, *dhutis* and *saris*, leaving a net increase of 14.94 lakhs in the total trade.

Out of a total of 261.36 lakhs worth of piece goods, the United Kingdom supplied 258.96 lakhs of which 120.13 lakhs were for grey, 53.50 lakhs for white and 85.33 lakhs for coloured goods.

Jute and wool.—The increase of .94 lakh under jute is due to higher prices of old gunny bags as well as to slightly increased imports, the demand in the south being greater than the supply, on account of the large exports of grain to Ceylon. Practically the whole trade in jute manufactures is in old gunny bags. There has been a greater demand for yarn and knitting wool and woollen piece goods, which show an increase of nearly one lakh in value over that of the previous year.

Apparel.—The total value of apparel imported amounted to 42.23 lakhs as against 30.53 lakhs in the previous year. The chief items are—

The only variation of importance is the increase of 10.92 lakhs in gold and silver thread. The imports are the largest on record, and the increase is attributed to keen competition between the different manufacturers' agents, and to imports direct instead of through Pondicherry.

The principal increases are under *paper and paste-board*, *glass and glassware*, *matches*, *soap and cement*. The increase under *paper and paste-board* is 4.05 lakhs and is due to larger imports of *printing paper* for conversion into reading matter of various kinds. Under *glass and glassware* the chief item is *bangles*; the use of glass instead of metal has brought them within the means of the lower classes, and the Austria-Hungarian manufacturers who supply the majority of them are stimulating the demand by turning out gaudy and attractive articles. The increase under *matches* is due to keen competition and low prices, and under *soap and cement* to large shipments imported on consignment sale. The only decrease of importance is under *instruments*, due to smaller imports of *electrical apparatus*; the imports are, however, above the average, for 1906–1907 was an exceptional year owing to large importations by the Electric Supply Corporation.

The fall in exports due to bad crops continued till the end of 1907, when the new crop became available. Since then the exports were above normal for the rest of the official year. The prices were favourable and the short out-turn of the previous year caused rapid export. The United Kingdom and France took 62.12 and 31.11 lakhs against 41.15 and 38.87 lakhs in the previous year.

Fruits and vegetables, fresh.—The exports of coconut kernel or copra which is the chief item under this head amounted to 118,008 cwt. valued at 21.28 lakhs against 125,129 cwt. valued at 18.76 lakhs in the previous year. The increase in price is due to the greater foreign demand for copra which has been found more profitable to import than oil, and the demand caused the rate to rise from Rs. 15 to Rs. 18 per cwt. as the crop was not plentiful. Germany, Belgium and France took 11.82, 3.84 and 2.94 lakhs against 14.68, .55 and 1.89 lakhs in the previous year; onions and potatoes of which 9.26 lakhs were exported during the year were the only other important items under this head; of this Ceylon took 6.55 lakhs and the Straits Settlements 2.71 lakhs.

Rice and paddy are the chief exports, the quantity amounting to 4,729,624 cwt. valued at 293.56 lakhs, of which the paddy trade was small and practically confined to Ceylon. The exports of the year are the largest on record, and shew an increase of 65 per cent. in quantity and 112 per cent. in value over the average exports of the previous five years, and 28 per cent. in quantity and 35 per cent. in value over those of 1906-1907, although that year was above the average. The larger exports to Ceylon and Mauritius are due to the continued deficiency of the supply from Bengal and Assam which also affected the previous year's export. The prices of paddy and rice have risen continuously, and are about 40 per cent. above those of five years ago. The prices of other grains have also risen to a similar extent during the same period. It may also be noted that paddy forms a continually decreasing proportion of the export, indicating that the hulling is done locally.

Provisions.—The increase of 4.59 lakhs in the export of provisions is due to larger exports of salted fish and dried fruit; the increase under the former is 3.49 lakhs and under the latter 1.45 lakhs, tamarind forming the bulk of this. Almost the whole trade in salted fish was with Ceylon.

Spices.—The decrease of 10.07 lakhs under this head is due chiefly to smaller exports of pepper from the West Coast ports. The following table shows the variations in the chief articles included under "spices":—

Pepper.—The decrease of 2,038,855 lb. in the exports of pepper is due to smaller demand combined with short crops. The chief buyers were Italy, Germany, the United States of America and the United Kingdom which took 7.03, 3.08, 2.27 and 1.98 lakhs against 7.85, 6.24, 3.16 and 2.74 lakhs in the previous year.

Ginger.—There was a further fall in the export of ginger during the year, the decrease being 532,558 lb. chiefly in the shipments to the United Kingdom where the demand for Cochin ginger was small. The exports which rose during 1903 and 1904 have since been falling and are now considerably below those of 1902-1903.

Chillies.—The exports of this commodity show an increase of 420,728 lb. in quantity, while the total value remains about the same.

Sugar.—In the year under review 195,068 cwt. of sugar valued at 9.64 lakhs were exported as compared with 157,442 cwt. valued at 7.15 lakhs in the previous year. The increase of 2.49 lakhs in value is due to good sugarcane crops. The United Kingdom took 2.34 lakhs of the 2.49 lakhs increase, the total exports there being 7.86 lakhs.

The quantity remained very much the same as in the previous year, there being a decrease of only 6,010 lb. while the value increased by 7.63 lakhs. This is attributed to a greater demand for the higher grades, and to the high level of prices in foreign markets. The principal consumers were the United Kingdom with 52.35 lakhs worth against 50.75 lakhs in the previous year, Canada with 17.66 lakhs against 16.04 lakhs, and Ceylon with 19.54 lakhs against 15.18 lakhs. As usual the exports of tea registered to Ceylon are merely transshipment cargo of which the final destination was not communicated for record in the trade returns. 79,035 lb. of green tea were exported to Canada.

Cinchona bark.—There is a decrease of 21,387 lbs., the competition of Java bark continuing to affect the demand for the Indian article. As usual the United Kingdom took all the shipments.

Other drugs and medicines.—The bulk of the trade in other sorts consists of *senna leaf* and *nux-vomica*. Larger shipments of senna leaves were made during the year to the United Kingdom and the United States of America from the port of Tuticorin.

Tobacco.—The trade in leaf tobacco shows an increase of 97,337 lbs. in quantity and .3 lakh in value. Low grade leaf had an increased demand in the Straits Settlements, the exports to which were 1.81 lakhs as compared with 1.65 lakhs in the previous year. The fluctuation in cigars is not great as regards quantity but the value shows a decrease of .52 lakh which is accounted for by a greater demand for low grades in the Straits Settlements. The chief exports were 83,534 lbs. to the United Kingdom as against 91,771 lbs. in the previous year, and 350,134 lbs. to the Straits Settlements against 283,599 lbs. in 1906-1907.

Indigo.—The decline of 1.32 lakhs in the value of the exports of indigo is due to smaller out-turn, the area of cultivation being 34 per cent. less than in the previous year, and to the competition of the synthetic article in Egypt and Japan, the exports to which show a decrease of 2.14 and 1.41 lakhs respectively. This decrease is counterbalanced by the increased demand in the United Kingdom, to which the exports were 2.0 lakhs in excess of those of the previous year. This demand is attributed to the use of the natural dye for special purposes for which the synthetic article is not adapted.

Myrabolams.—The quantity exported is about the same as in the previous year, but the value has increased by .54 lakh, due to a higher level of prices. The United Kingdom took three lakhs worth against 2.57 lakhs in the previous year.

Turmeric.—There was an advance of .30 of a lakh in the export of this article, the demand being well maintained; the average value however dropped a point. The United Kingdom and Ceylon took .50 and .79 lakh against .25 and .77 lakh in the previous year.

Castor oil.—The export of this commodity was nearly double that of the previous year, the quantity almost reaching the figure of 1905-1906, and the value being nearly 80 per cent. higher. Ceylon took 1·8 lakhs out of a total of 1·82 lakhs.

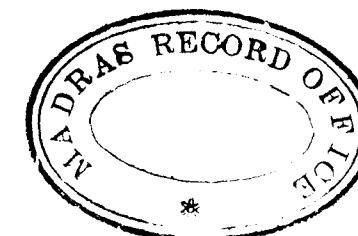
Cocoonut oil.—An increase of 194,458 gallons is shown under the exports of this article with a corresponding increase of 2·12 lakhs in value. The demand noticed in the last year's review continued, and the prices were well maintained, the average price being slightly less than that of the previous year. Shipments to the United Kingdom and the United States of America continued to dwindle, the value of the exports to these countries being 3·75 lakhs and 3·14 lakhs, respectively, as compared with 5·10 lakhs and 4·15 lakhs in the previous year. Germany increased her supply by 2·95 lakhs, the exports to this country in 1906-1907 being much below the average. Consignments to the total value of 2·68 lakhs were exported to France, Belgium, Holland and Austria-Hungary, Belgium taking approximately 1 lakh and each of the other countries 50 lakh.

Bristles and fibre for brushes and brooms.—The exports of bristles and fibre, which consist chiefly of palmyra fibre from Tuticorin and Cocanada, show a decline in value of 2·70 lakhs, the country showing the bulk of the decrease being the United Kingdom which took 1·42 lakhs as compared with 3·19 lakhs in the previous year. The other countries taking an appreciable quantity were Germany and Belgium which took 2·69 lakhs and 2·12 lakhs against 2·61 lakhs and 2·56 lakhs in the previous year.

The gradual decline in the exports of this commodity met with a sudden check in the year under review, the exports showing an increase of 54 per cent. in quantity and 53 per cent. in value over the previous year's figures and an increase of 37 per cent. and 50 per cent. over the average of the previous five years.

The large increase is attributed to good crops and a large demand in Europe and Japan coupled with the high prices of American and Egyptian cotton. The area of cultivation was 5 per cent. more than in the previous year.

Of the total exports of raw skins, the United States of America, France, the United Kingdom and Victoria took respectively 37.71, 8.64, 7.99 and 2.91 lakhs worth as compared with 60.96 (two-thirds of the whole export), 13.27, 13.76 and 2.41 lakhs in the previous year.

The sudden fall after a series of years of increasing exports is attributed to poor out-turn and inferior quality combined with dull prices in the home markets, in expectation of good crops in Bengal.

Manures.—The total quantity of manures exported amounted to 49,352 tons valued at 27.32 lakhs. Oil-cake manure, the exports of which amounted to 24,631 tons valued at 15.06 lakhs, is the chief item under this head. Ceylon, Java, the Straits Settlements and Germany took, respectively, 7.51, 4.83, 1.26 and .99 lakhs against 7.92, 10.20, 1.10 and 5.84 lakhs in the previous year. The export of animal bones amounted to 8,044 tons valued at 4.32 lakhs, the chief consumers being Ceylon and Australia. Fish manures of the value of 5.28 lakhs and 2.23 lakhs were sent to Ceylon and Japan.

Mica.—The decrease of .80 lakh in the value of the exports of this article is due to a fall in quantity exported and not a diminution in the price, which has risen from Rs. 59 to 64 per cwt. on account of the demand for use in electrical apparatus.

The total value of seeds exported shows an increase of 21 per cent. in quantity and 25 per cent. in value,—due to good crops and great outside demand for some of the staple seeds.

Coriander.—The decrease noticed last year continued through the year under review, the exports declining 3 per cent. in quantity and 40 per cent. in value. Ceylon and the Straits Settlements took the bulk as usual, 1.64 lakhs being shipped to the former and .59 lakh to the latter, against 2.72 lakhs and .94 lakh in the previous year.

Castor.—Castor seed advanced by 289,842 cwt. in quantity and 24.11 lakhs in value; this was accompanied by a large increase in the exports of castor oil and indicates good crops and large demand. The principal consuming countries were the United Kingdom, Belgium, France and Italy to which countries 29.58, 9.41, 5.90 and 1.44 lakhs worth was exported, against 13.75, 3.20, 5.77 and .39 lakhs in the previous year.

Cotton.—In spite of a large local demand the exports increased by 4.77 lakhs, the United Kingdom taking 7.19 lakhs as compared with 2.33 lakhs in 1906-1907.

Earthnuts.—The area under cultivation in the year under review was more than in the previous year, but the exports declined 132,004 cwt. in quantity and 2.81 lakhs in value, a considerable portion of the crop having been exported through Pondicherry, the statistics of which are not available here. Of the total quantity exported, France took 89.15 lakhs, Germany 1.37 lakhs and Belgium 4.67 lakhs while in the preceding year these countries took 95.63, .21 and 1.11 lakhs respectively.

Rape.—The quantity available for export was small, and almost the whole was taken by the United Kingdom. The value of the exports exceeded that of the previous year by 1.82 lakhs.

Jinjili.—Combined with local requirements, there was a greater demand from Europe and prices ruled fairly high. Austria-Hungary and Belgium respectively took 6.57 lakhs and 1.53 lakhs against none in the previous year, the poorer classes in the former country preferring the oil manufactured from these seeds for edible purposes, as being cheaper than olive oil. France took 7.51 lakhs against 4.12 lakhs of rupees worth in the previous year.

Silk.—The exports of silk waste declined to a slight extent, France taking 1.66 lakhs worth out of a total of 2.16 lakhs.

Stone and marble.—The trade in corundum stones shows a slight increase, the value of the exports having risen from .40 to .45 lakh. Hongkong, Shanghai and Singapore took practically the whole of the quantity exported.

Wood.—The value of the wood exported exceeded that of the previous year by 1.42 lakhs owing to improvement in the trade under sandalwood, Germany taking 6.14 lakhs worth of this wood as compared with 3.85 lakhs in the previous year; France and the United States of America also took 1.50 and 1.64 lakhs worth against 1.35 lakhs and 1.50 lakhs in 1906-1907.

Wool.—Under this head the chief item of export was goat's hair. Out of the total quantity of 1,608,652 lb. valued at 2.07 lakhs, the United Kingdom took 1,572,914 lb. valued at 2.03 lakhs.

VII.—ARTICLES MANUFACTURED AND PARTLY MANUFACTURED.

A.—YARNS AND TEXTILE FABRICS.

Cotton twist and yarn.—The quantity and value of twist and yarn exported during 1906–1907 and 1907–1908 as compared with the average of five years ending 1905–1906 were as follows:—

The exports during the year fell considerably, the chief cause of the decrease being the same as in 1906–1907, the exports to Hong-Kong and Shanghai dropping from 3,134,400 lb. valued at 15·33 lakhs to 2,033,680 lb. valued at 10·36 lakhs.

Exports in piece-goods show a decrease of 5 per cent. in quantity and 2·63 lakhs in value. Grey goods show a small decrease in the exports to Siam, and coloured goods a decrease of 2·43 lakhs in the exports to the Philippines.

The decreased exports of twist and yarn and piece-goods must not be taken as indicating any depression in the local spinning and weaving industries, but is due rather to increased local demand for locally manufactured goods. The quantity of yarn locally manufactured in mills was in excess of that for the previous year, and the cloth though somewhat less in quantity was of increased value owing to increased out-turn in the better classes for the local markets. The extra out-turn of yarn coupled with less export, and with increased import of Bombay yarn indicates activity in the handloom production of goods for the local market.

Handkerchiefs and shawls in the piece.—The exports of handkerchiefs during 1906–1907 and 1907–1908 with the average of the five preceding years were as follows:—

These are the products of the handlooms round Madras which are now recovering from the effects of the overproduction of 1904–1905. The increase during the year was 3·5 lakhs and the trade may now be said to have reached normal condition. The United Kingdom took almost the whole of the trade.

Woollen goods.—The principal articles exported under this head were hand-made carpets from various parts of the Presidency, and machine-made rugs and carpets from Bangalore. The exports amounted to 3·04 lakhs of which the United Kingdom took 2·25 lakhs. The year's trade show an increase of ·48 lakh.

B.—APPAREL.

The exports under this head consist of a number of articles, such as native cloths, embroidery, hats, boots, etc., and are distributed to many countries. The total exports were 1·93 lakhs against 2·88 lakhs in the previous year. No variation of any importance can be pointed out.

C.—OTHER MANUFACTURED ARTICLES.

Building and engineering materials.—Bricks and tiles from the West Coast ports to Ceylon, the trade in which amounted to 1·14 lakhs as compared with ·94 lakh in the previous year, form the chief exports under this head.

Coir manufactures.—Mattings and other articles made of coir yarn are included under this head: the total trade amounted to 53·09 lakhs against 55·24 lakhs in the previous year.

Hides and skins, tanned.—The subjoined table shows the progress of the trade in tanned hides and skins for a period of five years and of the average value per lb. as deduced from the custom-house declarations—

The decrease in tanned hides is due to short supplies in spite of a large demand and high prices. Tanned skins on the other hand show an increase of 7·82 lakhs in the value of exports which make up to a certain extent the decrease in raw skins. The increase is the net result of an increase under sheep skins and decreases under goat and other skins. The quantities shipped to different countries during the past two years are given below. The United Kingdom continues to be a distributing centre for the Continental and American markets.

Paints and colours.—Of the total trade of 1·28 lakhs of rupees under this head, 1·25 lakhs is the value of 24,919 cwt. of graphite, of which the United Kingdom took 1·22 lakhs.

Wood manufactures.—These consist of casks for cocoanut oil and chests for tea; the exports decreased slightly, the year's trade being ·97 lakh against 1·22 lakhs in the previous year. Of the total quantity exported, Ceylon took ·84 lakh. The industry is confined to Cochin.

BRITISH EMPIRE.

United Kingdom.—The total value of the trade with the United Kingdom shows an increase of 47.03 lakhs or 3.8 per cent. over that of the previous year, which is the net result of an increase of 61.75 lakhs under imports and a decrease of 14.72 lakhs under exports. The increase under imports is chiefly under metals (17.37 lakhs), cotton piece-goods (10.37 lakhs), machinery and mill work (7.27 lakhs), cotton twist and yarn (7.21 lakhs), railway plant and rolling-stock (5.50 lakhs), paper and pasteboard (3.02 lakhs), hardware and cutlery (2.80 lakhs) and dynamite (1.65 lakhs), while the decrease under exports is attributable to decreases under hides dressed (53.59 lakhs), raw jute (21.44 lakhs), and raw skins (5.77 lakhs), counterbalanced by increases under coffee (20.98 lakhs), raw cotton (18.48 lakhs), castor seed (15.83 lakhs), cotton seed (4.86 lakhs) and handkerchiefs (3.50 lakhs).

Straits Settlements.—The value of the imports remains almost stationary, increases being found under tin (1 lakh), gums and resins .34 lakh, sugar (1.41 lakhs), counterbalanced by decreases under kerosene oil (1.93 lakhs) and betelnuts (.50 lakh), while under exports the value of total trade shows an increase of 4.76 lakhs, of which only one item has increased to any extent, viz., “hides and skins” by 3.77 lakhs.

Ceylon.—Ceylon shows an advance of 1.29 lakhs under imports and 74.48 under exports. The increase under the former is confined, chiefly to betelnuts, (1 lakh), coconut-oil (.70 lakh), while the increase under the latter is due to increases under rice and paddy (59 lakhs), postal articles (6.88 lakhs), black tea (4.37 lakhs) and fish manure (2.71 lakhs).

Other countries in the British Empire.—The increase of .82 lakh in the imports from *Hongkong* is chiefly in camphor, other kinds (.56 lakh); the increase of imports from *West Australia* is due to increases under wood (1.60 lakhs) and the decrease of 3.96 lakhs from *Victoria* to less imports of horses. Under exports the increase of 15.59 lakhs in export to *Mauritius* is due to rice, and the increase of 1.50 lakhs to Canada chiefly to tea.

FOREIGN COUNTRIES.

Germany.—Larger imports of sugar and hardware account for the increase under imports from Germany, while the increase of 7.72 lakhs in the exports to that country is the net result of increased exports of raw cotton (10.57 lakhs), oil-cake (7.12 lakhs), coconut oil (2.94 lakhs), and sandalwood (2.30 lakhs) counterbalanced by less shipments of raw jute (7.45 lakhs), pepper (3.16 lakhs), copra (2.85 lakhs), and mica (1.68 lakhs).

France.—Gold and silver thread is responsible for the large increase under imports, the total increase being 12.91 lakhs, of which 10.92 lakhs are for this item, while under exports the decrease of 15.52 lakhs occurs under coffee (7.76 lakhs), seeds (6.58 lakhs), and hides and skins (4.63 lakhs), partly met by an increase of 4.65 lakhs under raw cotton.

Belgium.—The imports from Belgium increased by 55 per cent. which was distributed chiefly amongst metals (14.02 lakhs), machinery and millwork (2.66 lakhs) and alizarine dyes (2.16 lakhs) while the increase of 64.46 lakhs under exports is due to increased exports of raw cotton (49.39 lakhs), seeds (11.39 lakhs) and copra (3.28 lakhs).

United States of America.—An increase of 14.11 lakhs is shown under imports from the United States of America which is chiefly due to an increase of 10.45 lakhs under kerosene oil while a decrease is shown under exports, hides and skins being responsible for 32.97 lakhs.

Other foreign countries.—Imports from *Russia* increased by 2.86 lakhs, owing to the revival of the kerosene oil trade, while larger imports of iron (.70 lakh) and matches (1.72 lakhs) account for increased imports from *Sweden*. The trade with *Holland* increased by 6.89 lakhs due to increased exports of raw cotton (7.45 lakhs) to that country. *Italy* took more raw cotton (2.02 lakhs), hemp (1.08 lakhs) and castor seed (1.05 lakhs) than in the previous year, while the large increase in the trade with *Austria-Hungary* is due to larger imports of glass bangles and beads (2.04 lakhs) and to larger exports of jujili seed (6.57 lakhs) and raw cotton (1.7 lakhs). *Egypt* shows a decrease of 2.14 lakhs in its imports of Madras indigo. The trade with *Java* fell owing to less imports of sugar (4.47 lakhs) and to a decrease in exports of oil-cake manure by 5.37 lakhs. The exports to *China* also shew a decrease of 4.37 lakhs under cotton twist and yarn and *Sumatra* supplied less kerosene oil to the extent of 5.37 lakhs. *Japan* increased her imports of raw cotton by 15.09 lakhs.

The net imports of gold and silver together absorbed by the Presidency during the year under review was Rs. 42.92 lakhs against Rs. 66.56 lakhs in the previous year.

Imports.—Gold bullion shows an increase of 18.41 lakhs and sovereigns a decrease of 12.85 lakhs. The imports of gold from the United Kingdom, Natal, Ceylon, Australia and Egypt were 55.30, 3.00, 2.31, 1.41, and .12 lakhs respectively against 30.66, 4.91, 9.03, *nil*, and 3.75 lakhs in the previous year.

The import of silver from the United Kingdom was purely bar silver and amounted to 13.94 lakhs as against 8.77 lakhs in the previous year, while the imports from Ceylon were Government of India rupees which fell from 16.20 lakhs in 1906-1907 to 12.18 lakhs in 1907-1908. The increase in the imports of bar silver is due to the low level of prices for silver, and to industrial requirements stimulated by good crops in the Presidency. The import of Government of India rupees follows the exports of rice and other staple articles to Ceylon, and the fall in same is attributable to the adjustment of demand in spite of the heavy shipments of rice, large imports of rupees having been made in 1906-1907 in adjustment of dues for 1907-1908.

Exports.—Bar gold to the value of Rs. 4,446 was exported to the United Kingdom and Ceylon while Government of India rupees to the value of 45 lakhs and bar silver worth .35 of a lakh were sent to Ceylon. The increase in the exports of Government of India rupees is due to the requirements for financial purposes by the Bank of Madras in Colombo.

GOVERNMENT TRANSACTIONS (FOREIGN TRADE).

The total value of imports and exports of Government Stores amounted to Rs. 57,70,028 and Rs. 88,581, respectively, during the year under review against Rs. 62,29,704 and Rs. 94,641 in the previous year. The decrease under imports is the net result of decreases in the imports of carriages, cotton goods, hardware, machinery and woollen goods, and of increases under apparel, arms, ammunition, chemicals and stationery. Exports were small and the transactions were chiefly with the United Kingdom and with Aden and dependencies.

The value of the total coasting trade shows a decrease of 29·84 lakhs of rupees, 15·25 of which appertains to the trade with other Provinces in British India, 13·45 to the interportal trade and 1·14 to the trade with Indian ports not British. The distinctive features of the trade are the contraction in the imports of grain and pulse from other Provinces owing to good crops here and to scarcity elsewhere and the expansion in the exports of earthnut seed to Bengal and earthnut oil to Bombay and Burma.

The exact extent of the trade with the other parts of India both British and non-British, with the exception of Burma, and the fluctuation in each article cannot be accurately ascertained, as the trade is carried on both by rail and sea and the proportion varies in accordance with rates of freight which from time to time prevail on both systems.

Bengal Presidency—Imports.—The slight increase of 78 lakh in the imports of country produce was contributed by an increase in *coal* (8·24 lakhs), *jute gunny bags* (6·29 lakhs), *raw cotton* (2·99 lakhs), and *wheat flour* (1·21 lakhs), counter-balanced by a decrease in *rice* (9·64 lakhs), *kerosene oil* (4·50 lakhs) and *pulse* (3·52 lakhs). The increase in the imports of coal is due more to substitution of sea for rail transit than to increased consumption, and that in jute gunny bags to the larger shipments of rice to Ceylon. The decrease in rice and pulse was due to the scarcity of those products in Bengal. Importation of Burma oil from Calcutta has decreased as this oil is now imported direct.

The only item of importance in the imports of foreign merchandise is an increase of 1·24 lakhs in *bleached cotton goods*.

Exports.—In the exports of Indian produce and manufacture, *earthnut seeds*, *niger seeds*, *turmeric* and *gram* show increases of 37·35 lakhs, 4·47 lakhs, 3·24 lakhs, and 2·27 lakhs respectively, while there is a fall in *castor seeds* (6·48 lakhs), *essential seeds* (4·91 lakhs), *rice and paddy* (2·40 lakhs), *pulse* (1·76 lakhs), *cocoanut oil* (2·37 lakhs), *refined sugar* (1·53 lakhs), and *jinjili seeds* (1·23 lakhs). The increase under earthnut seeds is due to the scarcity of the seed crop in Bengal which has caused a demand for earthnut oil as a substitute for other edible oils and to the development of the soap industry, and that under niger seed to a good out-turn in Madras and favourable rates in Bengal. The decrease under castor and essential seeds is attributable to high prices and short crops.

Bombay Presidency—Imports.—Among the imports of Indian produce and merchandise, *coffee*, *ornamental wood*, *essential seeds*, and *cotton twist and yarn* show increases of 5·72, 2·55, 2·50 and 2·38 lakhs respectively, while *salt*, *jawar* and *bajra*, *wheat flour*, *gram*, *pulse*, and *til seeds* show decreases of 5·76, 2·13, 2·03, 1·57, 1·55, and 1·03 lakhs respectively. The decrease under Bombay salt is stated to be due to more favourable rates by rail. In the imports of foreign merchandise increases occur under *copper*, *wrought* (2·03 lakhs), *grey piece goods* (1·22 lakhs) and *refined sugar* (1·02 lakhs), while *kerosene oil* fell by 1·12 lakhs.

Exports.—Indian produce and merchandise exported fell by 1.76 lakhs, which is the net result of decreases under *raw cotton* (6.73 lakhs), *pepper* (2.26 lakhs), *coffee* (2.04 lakhs), *betelnuts* (1.56 lakhs), *gunny bags* (1.21 lakhs) and *bricks and tiles* (1.09 lakhs), and increases under *earthnut oil* (5.84 lakhs), *cocoanut oil* (2.20 lakhs), *ginger* (1.85 lakhs), *jinjli seeds* (1.30 lakhs), and *oil-cake* (1.17 lakhs). The decrease under raw cotton is due to larger exports to foreign countries, and that under pepper to the failure of crops, while the increase under earthnut oil is attributable to the scarcity of the earthnut crop in Bombay, and the increase under cocoanut oil to the demand in the Punjab and the United Provinces for the manufacture of soap, candles, etc.

Burma—Imports.—The imports of country produce from Burma show decreases of 24.58 lakhs under *paddy*, 7.04 lakhs under *rice*, 5.03 lakhs under *pulse* and 17.13 lakhs under *kerosene oil*; this is partly met by an increase of 4.17 lakhs under *teakwood*. The fall in the imports of rice, paddy and pulse is due to good crops in this Presidency and the scarcity in Bengal. The decrease in kerosene oil does not indicate that smaller trade was done, but is attributable to large stocks in hand at the end of 1906–1907. The fluctuation under *teakwood* is due to competition with Siamese teak.

Exports.—Indian produce and manufactures advanced by 26.95 lakhs in the export trade to Burma; the principal increases were 11.74 lakhs under *earthnut oil*, 5.52 lakhs under *provisions*, 3.66 lakhs under *cocoanut oil*, 3.19 lakhs under *tobacco leaf* and 2.04 lakhs under *fresh vegetables*.

Sind—Imports.—The imports of country produce from Sind fell by 4.30 lakhs due to less imports of *rice* (5.15 lakhs), and *paddy* (4.62 lakhs) partly counterbalanced by increased imports under *jawar* (2.04 lakhs) and *wheat flour* (2.57 lakhs).

Exports.—Very little variation is shown under this head.

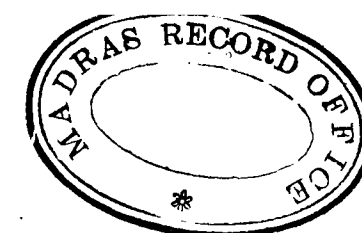

The fluctuations in this branch of the trade are very small, the only differences of importance being a decrease of 1.41 lakhs in unmanufactured tobacco exported to Travancore, and an increase of .66 lakh in rice exported to Goa.

TREASURE (COASTING TRADE).

The total movement of treasure by sea during the year only amounted to about two and a half lakhs in value and calls for no remark.

GOVERNMENT STORES (COASTING TRADE).

The total value of Government stores dealt with during the year amounted to 25.75 lakhs, of which 12.47 lakhs represent imports and 13.28 lakhs exports. The principal imports were *arms and ammunition* (4.34 lakhs), *stationery* (2.44 lakhs), and *metals* (.83 lakh) while the chief exports were *arms and ammunition* (6.06 lakhs), and *apparel* (2.79 lakhs).

SHIPPING.

The subjoined statement shows the number and tonnage of all vessels that either entered or cleared at ports in the Presidency during the past five years. The total number of vessels entered and cleared during the year exceeded that in 1906–1907 by 1,970, and the tonnage increased by 1,521,142.

The entries and clearances in the coasting trade with other provinces, the coasting trade with foreign ports in India and the interport trade within the Presidency were 7,229 vessels of 4,010,650 tons, 1,979 vessels of 111,762 tons and 32,776 vessels of 11,651,652 tons, respectively, as against 7,195 vessels of 3,982,439 tons, 1,779 vessels of 95,111 tons and 31,110 vessels of 10,580,494 tons in 1906-1907.

Vessels built and registered.—During the year under review 28 vessels of an aggregate tonnage of 796 tons were built, and 31 vessels were registered under Act X of 1841 at the several ports in the Presidency. The greater portion was built and registered at Cocanada, Masulipatam, Mangalore, Tellicherry, Calicut and Cochin.

ADMINISTRATION.

I. Ports—General.—There were 148 ports in the Presidency at the beginning of the year, 45 open to general trade, coasting and foreign, and 103 to coasting trade only. Of the latter, Baruva in the Ganjam district was thrown open to foreign trade during the year, while Damodarapatnam in the Madura district was closed and a new port—Vattanam—in the same district declared open under section 12 of the Sea Customs Act. Customs establishments are maintained at 44 of the ports open to foreign trade, and at 9 of the 102 ports open to coasting trade. The rest are under the control of the Superintendents at the nearest ports having establishments. Proposals were made for formally closing 35 coasting ports at which there had been no trade for six years, and since the end of the year the Indian Ports Act has been withdrawn from these ports by the Government of India, and no doubt the Sea Customs Act will be withdrawn shortly by the Local Government. The suspension of trade at these ports is a result of the collection of produce by means of the railways at ports with greater facilities.

A comparative survey of the total trade of individual ports as exhibited in the foregoing statement discloses a general decrease of trade in ports on the west coast and an expansion in the trade of east coast ports. How much of this may be attributed to entire loss of trade and how much to mere diversion of trade from one port to another resulting from increased landing facilities and the extension of railway communication, it is at present hazardous to conjecture. Compared with the average of the six years preceding, the ports of Tellicherry, Calicut, Mangalore, Badagara and Cannanore show a decrease of 28.69, 21.24, 12.29, 2.59 and 0.62 lakhs respectively in their total trade value, while Cochin shows an advance of 49.53 lakhs. A dissection of the total trade into *foreign* and *coasting*, however, reduces the shrinkage under the former to 16.96, 7.13, 8.42, 2.53 and 1.73 lakhs respectively for the ports enumerated and the expansion at Cochin to 7.18 lakhs. This contraction in foreign trade is due to shrinkage in the exports of coffee and pepper from Tellicherry, of coffee, ginger and pepper from Calicut, of coffee from Mangalore and of copra from Badagara, while Cochin's expansion is the result of increased exports of tea, coir and copra coupled with larger imports of kerosene oil. Of the ports on the East Coast, Madras shows an advance of 5 per cent. on the trade of 1906-1907 and 27 per cent. on the average of the preceding six years, 25 per cent. of which represents development in foreign trade. Tuticorin which comes next in importance shows an increase of 27 per cent. on the foreign trade of 1906-07 and 40 per cent. on the average of six years preceding. Cocanada, the third port in importance, shows an increase of 129.6 lakhs or 71 per cent. in advance of the foreign trade of 1906-07 and 205 per cent. above the six years' average, while Negapatam shows an advance of 2 per cent. over the trade of 1906-1907 and nearly 29 per cent. over the average of the six years preceding. The remaining important ports, *viz.*, Bimlipatam, Vizagapatam and Cuddalore show a diminution of 59, 3 and 22 per cent. respectively in their foreign trade as compared with the trade of the year preceding. The items which so favourably affected the trade of Madras were *cotton piecegoods, Railway materials, metals, machinery, gold and silver thread and hardware* under imports and *raw cotton* under exports. Increased exports of *rice, raw cotton, and castor seed* contributed towards Cocanada's prosperity, while Tuticorin's advancement was due to increased imports of *cotton twist* and to increased exports of *raw cotton, rice, and tea*. The diversion of the earthnut trade from Cuddalore gave an impetus to the trade of Negapatam. The trade of Bimlipatam was affected by the condition of the jute crop, while that of Vizagapatam remained practically the same.

3. Receipts and disbursements of the port of Madras.—The statement below compares the receipts and disbursements of the Madras Custom-house for the years 1906-07 and 1907-08:—

NOTE.—This statement excludes the sum of Rs. 524 being the charges incurred towards the temporary establishment of three clerks for the Statistical Department during 1907-1908 and also the sum of Rs. 704 being compensation allowance for dearness of provisions granted to all full-time servants drawing Rs. 16 and under from October 1907 to February 1908 inclusive.

Receipts.—The increase of nearly five lakhs over the receipts of the previous year under "Import duty" is distributed over *Spirits and liqueurs, petroleum, chemicals and drugs, cotton manufactures, other metals and manufactures of metals, and raw materials*, while the decrease under "Export duty" is due to smaller exports of *rice* to Ceylon from Madras.

The slight increase in cotton excise duty is explained in paragraph 8 and the increase under penalties in paragraph 6. The fluctuations under other heads are slight and call for no remarks.

Disbursements.—The increase under establishment is due to the posting of an additional Assistant Collector of the Imperial Customs Service to Madras, and that under refunds of import duty to larger grants of refunds on *arms, and manufactured articles, viz., electrical fittings* on which duty was erroneously collected. The increase under "Travelling allowance" is due to inspection of outposts by the Collector and his Assistant. Smaller exports of kerosene oil under claim for drawback is responsible for the decrease under "Drawback."

4. Receipts of outports.—The following figures compare the receipts of customs duties at outports during the year under review with those of the previous year:—

Of these receipts Tuticorin with 4.64 lakhs and Cocanada with 7.41 lakhs account for about 58 per cent. The increase under import duty which is distributed chiefly among the ports of Negapatam (Rs. 17,078), Tuticorin (Rs. 36,653), Calicut (Rs. 17,061) and Cochin (Rs. 54,888) is due to increased trade in betelnuts at Negapatam and in kerosene oil at the other three ports. Cocanada and Tuticorin are responsible for increases of Rs. 1,93,480 and Rs. 52,490 respectively under export duty due to increased export of *rice* to Ceylon.

5. Receipts of Land Customs Chowkies.—There was a slight increase in the receipts of Land Customs chowkies which amounted to Rs. 1,86,170 during the year as against Rs. 1,77,987 in the previous year.

6. (a) Cases adjudged under the Sea Customs Act.—The total number of cases adjudicated under the Sea Customs Act during the year under report was 1,684 as compared with 1,647 in the preceding year. The amounts collected under penalties and extra duty were, respectively, Rs. 14,727 and Rs. 1,796 against Rupees 11,799 and Rs. 1,058 in 1906-1907. The increase under the former is due to heavy penalties amounting to Rs. 3,000 having been imposed in cases of exportation of osprey feathers from Madras. Of the 1,684 cases, 1,184 were disposed of by the Collector of Sea Customs, Madras, and 500 by the Superintendents of Customs at outports. The nature of the cases and the amount of penalties imposed were as follows:—

The amount granted in rewards was Rs. 1,890.

(b) **Offences under the Land Customs Act.**—Under the Land Customs Act 1,636 offences are reported to have occurred during the year against 1,915 in 1906–1907. Of these, 1,258 occurred on the Pondicherry and 390 on the Karikal frontier. In 1,354 of these cases the articles seized were confiscated, in 158 the goods were returned to the owners on payment of duty and in 78 they were released without payment of duty, while 40 cases remained undisposed of at the end of the year. There were three prosecutions before the Magistracy in one of which the accused was fined Rs. 15 for importing gunpowder and percussion caps across the Karikal frontier into British India.

(c) **Cases under the Merchandise Marks Act.**—Eighty-six cases of infringements of the Merchandise Marks Act were brought to notice, eighty-five at Madras and one at Tellicherry. Of these cases, fifty were under clause (d), fifteen under clause (e) and twenty under clause (f) of section 10 of the Act.

Of the cases under clause (d), forty-eight were in respect of the use of English words of description without sufficient counterindication of the country of origin. In three cases the goods were passed with a warning, in five cases where an attempt had been made to comply with the law, but the indication of the country of origin was not sufficiently distinct, and there were some shipments *en route*, time was given to cover these shipments before enforcing strict compliance. In the remaining cases the law was complied with before the goods left customs control. Penalties were imposed in 19 of these cases. The two remaining cases related to a false trade description as to the material of which the goods were composed, one in respect of mock gold jewellery from which the offending words were removed before the goods were passed, and one in respect of adulterated red lead on which the percentage of adulteration was marked before being passed. In both these cases penalties were imposed.

The 15 cases under clause (e) were in respect of the use of the names of British-Indian traders in goods of foreign manufacture without counterindication of the country of origin. In all cases the goods were stamped with the country of origin before leaving customs control and penalties were imposed in six cases.

In the 20 cases under clause (f) the length was not stamped on piece-goods. The goods were passed after being stamped, and penalties were imposed in 19 cases. All the cases at the Madras Custom House were discovered by the Appraisers in the ordinary course of their duties. Penalties amounting to Rs. 314 were imposed for breaches of the Act. The Merchandise marks Manual compiled by Mr. Morshead has been found a complete guide in the adjudication of cases which occurred since its publication.

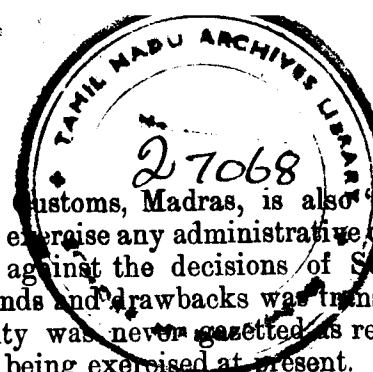
7. Appeals.—There were 43 appeals preferred under the Sea Customs Act against 35 in the previous year, 7 to the Board of Revenue, and 36 to the Collector of Sea Customs, Madras, and the local Assistant Commissioners against the decision of the Superintendents of Customs at out-ports. In 20 cases the original orders were reversed—1 by the Board of Revenue, 1 by the Collector of Sea Customs and the remaining 18 by the Assistant Commissioners. In two cases the amount of the penalty inflicted was reduced.

8. Cotton Duties Act.—The total amounts of yarn and cloth produced in the mills of the Presidency during the year 1907–1908 were 36,935,891 lb. and 7,593,323 lb. against 36,723,575 lb. and 7,952,560 lb. in the previous year.

There is thus an increase in the production of yarn but a decrease in the production of cloth.

The increase in the quantity of yarn produced, coupled with the decrease in exports of yarn already noticed, indicates increased demand for the yarn of local manufacture principally in the lower counts for handloom work. The decrease in the production of cloth was accompanied by an increase from Rs. 1,32,693 to Rs. 1,35,130 in the amount of cotton excise duty, while the amount of drawback granted fell from Rs. 5,510 to Rs. 2,666. The increase in the duty receipts notwithstanding the falling off in the quantity is due to the cloth produced being generally of higher grade, while the decrease in drawback which means less export, indicates a growing local demand for the products of the mills.

There were no breaches of the law and the Act worked smoothly during the year.



9. Administration.—The Collector of Sea Customs, Madras, is also "Chief Customs Officer" for the Presidency, but does not exercise any administrative control over out-ports. The power of hearing appeals against the decisions of Superintendents of Customs at out-ports in cases of refunds and drawbacks was transferred to him by Government in 1900, but the authority was never gazetted as required by section 204 of the Sea Customs Act and is not being exercised at present.

Proposals were made for the reorganization of the Customs establishments throughout the Presidency and for the transfer of the control of the out-ports from the Salt and Abkari Department to the Collector of Sea Customs, Madras, and are now under the consideration of Government. In the meantime the Collector of Sea Customs, Madras, advises on questions referred to him with regard to the procedure at out-ports, and brings to the notice of the Superintendents errors in classification and assessment of duty when discovered from the bills of entry sent to the Statistical Department of the Madras Custom-house for inclusion in the trade returns of the Presidency. Extra duty amounting to Rs. 757 was recovered through this scrutiny of bills of entry from out-ports, besides which, the short levy of about Rs. 3,000 the recovery of which was barred by limitation was also discovered. The systematic audit of the procedure at out-ports, which forms part of the reorganization proposals, may be expected to improve this working.

The system of "prior entry", under which the greater part of the Customs procedure can be finished before the arrival of goods, was introduced during the year, and greatly facilitated clearances at Madras.

Other changes were the clearance of goods against a cash deposit instead of against a deposit of security in Government Promissory-notes, and the licensing of clearing agents and brokers on deposit of security.

The irregular system of landing goods which was alluded to in last year's report continued to be under consideration throughout the year under review.

The Collector of Sea Customs visited nineteen ports during the year while preparing the scheme for the reorganization of establishments, and submitted a series of inspection reports on them to the Board of Revenue. Six ports were also inspected by an Assistant Collector.

10. Documents.—The documents handled comprised the following:—

Fifty-four thousand eight hundred and eleven bills of entry, 84,129 shipping bills, 23,077 import manifests, 23,298 export manifests and 28,959 other documents or 214,274 in all. The number of packages examined was 1,001,695, the number of amendments of documents was 9,139, and the fees realised thereon Rs. 5,145.

11. Statistical publications.—The sale-proceeds of these publications rose from Rs. 6,936 to Rs. 7,894 during the year. The charges for printing and establishment amounted to Rs. 6,273 against Rs. 5,986, leaving a net balance of Rs. 1,621 against Rs. 950 in the previous year. Sixty special statements were compiled on the application of private individuals against 77 in the previous year. The decrease in the demand for special statements is due to more detailed information being furnished in the statistical publications which popularized them and increased the number of subscribers.

12. Personnel.—Mr. C. G. Todhunter, I.C.S., continued to hold the office of Collector of Sea Customs, Madras, till 12th January 1908, when he was succeeded by Mr. J. S. Heaney, I.C.S., who held the office for the rest of the year. Mr. A. Wolferstan, an Assistant Collector in the Imperial Customs Service, joined the office with effect from 5th August 1907. Mr. C. R. Watkins continued to hold the office of Assistant Collector during the whole of the year. Mr. C. F. Deane held the office of Head Appraiser till 13th June 1907, when Mr. T. H. Puddephatt, the permanent Head Appraiser, rejoined his appointment from furlough. The office of the Superintendent of Statistics was held by Mr. R. M. Thurley till 2nd September 1907, when he proceeded on leave and was succeeded by Mr. C. F. Deane who continued in charge for the rest of the year.

I am indebted to Mr. Deane for the portion of this report dealing with the trade and navigation.
