**REPORT ON THE WORKING OF THE INDUSTRIAL DISPUTES ACT, 1947
(CENTRAL ACT XIV OF 1947), FOR THE CALENDAR YEAR 1962.**

Personnel.—Sri T. N. Lakshminarayanan, I.A.S., continued to be the Commissioner of Labour, Registrar of Trade Unions and Director of Employment during the year 1962.

Sri K. V. Parthasarathy, M.A., B.L., continued to be the Deputy Commissioner of Labour during the year 1962 and was in charge of the administration of the non-technical Acts and was also Certifying Officer under the Industrial Employment (Standing Orders) Act, 1946.

Sri T. S. Ramakrishnama Raja, B.Sc., continued to be the Assistant Commissioner of Labour-I, the Additional Commissioner for Workmen's Compensation and the authority under section 15 of the payment of Wages Act, 1936, and under section 41 of the Madras Shops and Establishments Act, 1947.

Sri G. Kamalaratnam, M.A., B.L., continued to be in charge as Assistant Commissioner of Labour-II during the year 1962 dealing with evaluation and implementation of Labour laws, awards, codes, etc.

Sri R. Seshadri, B.A. (Hons.), Assistant Commissioner of Labour (Administration) has been deputed to the Madras State Electricity Board for appointment as Labour Relations Officer under the Board on foreign service terms. He was relieved by Sri D. K. Purushotham, B.A., on 17th December 1962 forenoon.

Sri W. S. Sivasankar, B.A. (Hons), Gazetted Assistant to the Commissioner of Labour, continued to be in charge of the preparation and publication of the *Madras Labour Gazette*, a monthly publication of the department.

The Commissioner of Labour was the Chief Conciliation Officer under the Industrial Disputes Act, 1947 for the entire State of Madras. He was assisted in his work by the Assistant Commissioner of Labour-II, Assistant Commissioner of Labour (Administration) and 14 Labour Officers in the districts, all of whom have been appointed as Conciliation Officers under the Industrial Disputes Act, 1947.

Labour Policy.—During the year 1962, the State continued to be geared to the needs of the industry and labour within the frame work of a planned economy and achieved satisfactory results during the year. The need for harmonious relationship between management and labour was emphasized in the State by the workers as well as employers. Due emphasis was laid on the objectives of the Third Plan which are the strengthening of the trade union movement, granting them representative character, promotion of leadership from within the workers and the training of workers in trade union philosophy and methods, settlement of disputes through mutual negotiation, conciliation and voluntary arbitration, effective implementation and enforcement of awards increased association of labour with management, prevention of tendencies to violence and indiscipline, a progressive wage policy with a view to accelerating progress towards fair wages, etc.

In view of the National Emergency, the Union Minister of Labour and Employment convened a Conference of Employers and Employers' Central Organizations on 3rd November 1962 at New Delhi and a Resolution on Industrial Truce and for increased production was adopted at that meeting. To implement this Resolution in this State, the Minister for Finance and Labour convened a joint meeting of employers' and workers' representatives on 14th November 1962 at Madras. The terms of the resolution on Industrial Truce were accepted. Labour and management agreed to maintain cordial relationship and work in harmony and resolved to maximize output by working additional shifts, cutting down costs and avoiding waste. It was also agreed that as far as possible all disputes affecting individual workers such as dismissals, discharges, retrenchment, etc., should be referred to the Commissioner of Labour for informal arbitration and his decision accepted by both parties. The Conference has generated a very healthy atmosphere of industrial peace and goodwill and it is bound to have a beneficial impact on production.

The following special measures in the context of the National Emergency have also been taken :—

All factories wherein workers desire to work overtime or on weekly holidays with a view to making contributions to National Defence Fund have been exempted from the provisions of various sections of the Factories Act, 1948; exemption from the provisions of Factories Act has been granted to factories connected with Defence to step up Defence production. The Government of India have also amended section 7 (2) of the Payment of Wages Act, 1936, to permit deductions from wages of the workers for contribution to the National Defence Fund or any Defence Savings Scheme. A new understanding and identity of interest has been forged between labour and management in this regard. Emergency production committees have also been set up. Not only has there been a significant improvement in labour relations in the last few months but workers have out of their savings and by working additional hours contributed liberally to the National Defence Fund.

Implementation of Labour Enactments.—Out of the 228 awards published during the year 1962, 148 required implementation. Of these, 72 awards were implemented on the date of enforcement. Out of the 76 cases of non-implementation, in 5 cases prosecutions were launched against the defaulting managements and the other cases were under appeal in courts of law or under investigation.

Evaluation and Implementation Committee.—The State Evaluation and Implementation Committee, of which the Commissioner of Labour is the Chairman and the Assistant Commissioner of Labour-II is the Secretary met twice on 14th March 1962 and 22nd September 1962 to consider the subjects relating to the breach of Code of Discipline by managements as well as trade unions. Subjects requiring clarification of certain points relating to recognition of trade unions under the Code of Discipline and the Model Grievance Procedure drawn up by the United Planters' Association of South India were also discussed.

Industrial disputes.—The state of industrial relations was very satisfactory during the year and reflected an improvement over the record of the previous year.

The officers of this Department received 6,920 disputes during the year as against 8,265 during the previous year. During the year they settled 1,051 disputes by conciliation and 7,662 through mediation as against 1,192 by conciliation and 4,512 through informal mediation during last year. (A statement showing the details is given in Annexure I).

Industrial Disputes referred to the Industrial Tribunal and the Labour Courts for adjudication and published in the Fort St. George Gazette.—During the year 221 industrial disputes were referred for adjudication to the Industrial Tribunal and the Labour Courts. Besides these 3 disputes were referred for arbitration. (A statement showing the details is given in Annexure II).

Awards including the decisions of the Industrial Tribunal and the Labour Courts on the applications filed by the workers under section 33-A of the Industrial Disputes Act, 1947, were published in 228 cases during the year. (A statement showing the details of the awards, etc., published in the year is given in Annexure III).

Important settlements of disputes.—Of the settlements reached between employers and their workers during the year, special mention may be made of the settlement relating to the rationalisation in textile mills in the Coimbatore region before the Commissioner of Labour, Madras. The agreement provided for the following :—

(1) Revision of workloads and wage rates in spinning department and for doffing boys and reserve piecers in respect of 73 textile mills was to be made on the agreed terms.

(2) The work assignments for other categories of workers in these mills were to be discussed further. [If no settlement was arrived at by 1st March 1963, the issue was to be decided by the umpire already appointed by the Government (Industrial Tribunal, Madras).]

(3) In respect of the 11 new mills, wages payable for existing work assignments shall be submitted to the Minister for Finance for arbitration and his decision would be final and binding.

(4) A bipartite committee should be constituted to which the issues relating to the feasibility of work assignments or other questions arising out of implementation of this settlement would be referred. In the event of disagreement between the committee members, the question should be referred to an umpire to be nominated by them.

Strikes and Lockouts.—There were 152 strikes and lockouts during the year in the various industries including those falling under the central sphere, out of which three strikes continued from the previous year.

The 152 stoppages of work involving 30,654 workers resulted in a loss of 159,845 mandays. Of these, 12 related to industrial establishments which declared lockouts consequent on the strike by the workers. On account of these lockouts 847 workers were affected and 12,830 mandays were lost. Of the 152 stoppages of work 85 were settled by conciliation. In 18 cases agreements were reached between the parties by direct negotiations and the workers voluntarily resumed work in 48 cases (one case was pending at the end of the year). (Details are given in Annexure No. IV).

Of the 152 strikes and lockouts including 3 under the central sphere, the following strikes may be made mention of :—

(1) About 2,000 workers of the Sasantha Mills, Singanallur, Coimbatore, struck work from 2nd March 1962 protesting against the action of the management in having recruited some outsiders as piecers. The workers, however, resumed work on 13th March 1962 on the intervention of the Labour Officer, Coimbatore.

(2) About 1,180 out of 1,447 workers employed by the management of the Combodia Mills Limited, Coimbatore, belonging to (1) The Coimbatore District Textile Jobbers' Union (INTUC) and (2) Textile Employees' Association (HMS) struck work at 1-00 a.m. on 16th March 1962 as a protest against the change proposed in the method of calculation of production bonus to Jobbers. The strike was called off and the workers resumed work at 1-00 p.m. on 21st April 1962 on the advice of the Labour Officer.

Prosecutions.—During the year under report Government sanctioned prosecution against the following management for non-implementation of awards, settlements, etc. :—

(1) Swarnambikai Bus Service, Salem, for non-implementation of the settlement. The Manager and Managing Director were convicted and sentenced to pay a fine of rupees 25 each.

(2) Sarada Dyeing Factory, Salem.

(3) M/s N. V. Abdulla Saheb and Company, Madras.

(4) Bharathi Press, Madras.

(5) M/s Pakshiraja Studios, Coimbatore.

Recoveries.—During the year orders for the recovery of the arrears due to the workers under section 33-C (1) of the Industrial Disputes Act were issued in 65 cases and an amount of about Rs. 1,39,057 was ordered to be recovered from the employers as arrears of land revenue.

Public Utility Services.—The following industries were declared as Public Utility Services for the purposes of the Industrial Disputes Act, 1947, from time to time.

(i) All labour in minor ports.

(ii) The Sugar Industry.

(iii) The Motor Transport Services.

(iv) The Cotton Textile Industry.

(v) The Cement Industry.

(vi) Air-transport Services.

Besides, in view of the national emergency the following industries have been declared to be Public Utility Services.

(i) Iron and steel.

(ii) Services in Hospitals and Dispensaries.

(iii) Fire Brigade Services.

(iv) Dhall Mills and Mills producing flour used as food-stuffs.

(v) Rice-Mills and Mills producing oil used as food-stuffs; and

(vi) Milk and Milk products.

(The details are furnished in Annexure V below.)

Works Committees.—Government have been emphasising the importance of Works Committees for promoting good understanding and cordial relations between labour and management. Works Committees were functioning in 380 establishments in the State at the end of the year 1962, as against 301 in the year 1961. (The details of the newly formed works committees are given in Annexure VI).

Unit Production Committees.—These committees were functioning in 71 industrial establishments. In many cases Works Committees also functioned as Unit Production Committees.
