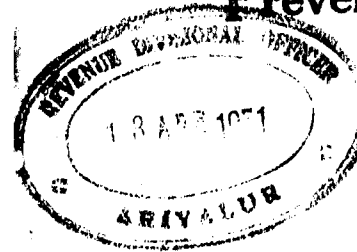

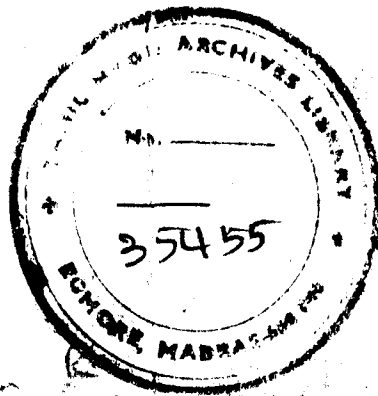

Report for the year 1950.

The time has come once again when it is my pleasant duty to place before the General Body and through them to the public at large, a brief resume of the activities of the Society for the year ended 31st December, 1950.

2. This Society was established in the year 1909 and has therefore completed 41 years of useful work in connection with the prevention of cruelty to and improper treatment of animals, and the amelioration of their conditions generally in this District. The Society has good cause to congratulate itself on the record of good work and useful service it has been able to render to the dumb animals of this District during the long period of its existence. Looking back over the past 41 years one has reason to be satisfied with the progress that the Society has been making. The Society has also been able to secure some amount of public support and recognition.

3. The outstanding features of the year are the unveiling of the Portraits of Mahatmaji and Pandit Jawaharlal Nehru in the Stanley Building—the gifts of Sri. Moolji Ramjee, by the Hon'ble Dr. T.S.S. Rajan, Minister for Public Health with the Government of Madras on 29th January 1950, and the extension of the activities of the Society to Pudukottai Municipality.

4. This Branch was affiliated with the All India S. P. C. A., in the year 1947.

Members.

5. The year commenced with 36 members and ended with 65 members. I am glad to record that Messrs. N. Gopaldas & Co., Sri. P. R. Narayanasamy Aiyar, Sri. G. Radhakrishna Chettiar and His Highness The Raja of Pudukottai became Life Members of the Society during the year. Measures are being taken to increase membership.

7. The subscriptions and donations collected during the year amounted to Rs. 636. A list of subscribers and donors is attached to the Report as Appendix A.

Annual General Meeting.

8. The Annual General Meeting of the Society was held in the Stanley Building, Puthur, Tiruchirapalli, on 13th April 1950 under the Presidentship of its President T.J. Jacques Esq., (Collector & District Magistrate, Tiruchirapalli). In addition to the adoption of the Report for the year ended 31st December 1949, most of the retiring Office Bearers and members of the Executive Committee for the year 1950 were re-elected. (A copy of the Proceedings appears as Appendix B to the Report).

9. The General Body also decided to bifurcate the offices of the Honorary Secretary and Treasurer into two separate posts—viz., Honorary Secretary and Honorary Treasurer.

10. The Executive Committee met 4 times during the year and papers were circulated on other occasions.

Office Bearers.

11. J. I. Ronson Esq., I. P., District Superintendent of Police, Tiruchirapalli was elected as the Vice-President and Messrs. V. D. Shadagope and Rajyaseva Pravina Khan Bahadur G. S. A. Karim Suhrawardy, M. B. E. were elected as the Honorary Secretary and Honorary Treasurer respectively for the ensuing year.

12. A list of Office Bearers as it stood on 31st December 1950 shown on the front page of the Report.

Activities of the Society.

13. The Tiruchirapalli Branch was established in 1909 with the object of preventing cruelty to animals and propagation of kind and better treatment to them. The Local Government at first decided that the work of the Branch should be confined to the application of the provisions of the Town Nuisance Act to the Municipalities of Tiruchirapalli and Srirangam.

14. A representation was then made in 1913 to the Local Government bringing to their notice that the provisions of the Town Nuisance Act do not enable the Magistrate to deal satisfactorily with cases of cruelty as injured animals cannot be detained till they recover and are consequently taken away and used again while still suffering, and recommending therefore that the provisions of the P. C. A., Act XI of 1890 (India) be extended. The Government approved of this extension from 1st September, 1913.

15. The activities of the Society were next extended to Karur in 1928, to Ariyalur in 1933 and to Manaparai in 1945, the Veterinary Hospitals in these places have been declared as "Infirmaries" for the purpose of remanding S. P. C. A., animals for treatment.

16. With the approval of the Madras Government, the activities of the Society were extended to Pudukottai Municipal limits during the year and an Inspector is in charge of the outpost from 1st May 1950.

17. There is a proposal to open an outpost at Jayamkondam in the course of the year 1951.

* These cases were withdrawn as the accused were not traceable due to the wrong address furnished by the concerned Inspectors. This has received disciplinary attention.

19. 24 Oil Mill cases were charged during the year under review, all of which ended in conviction. The Inspectors also charged 5 cases in which animals were made to draw loads far beyond their capacity and all the cases ended in conviction.

20. As cruelty to animals is not confined to any particular part of the day and is also being committed at nights, and as most of the carts come into the Town after sunset, night raids have been in vogue from the year 1947. During the year under review 199 cases were charged during night raids.

21. It may be pointed out for information that out of 3268 cases which were tried during the year 3177 cases ended in conviction and there was no acquittal. The Executive staff have standing instructions to exercise their powers with tact and care and without causing undue offence or inconvenience to the Public. It may be seen that the staff have adhered strictly to the instructions and further that there has been no harassment although at times they have to carry out their duties in the face of obstructions and opposition and not entirely without risk of assault.

22. The fines levied by the Courts which try S. P. C. A., cases and remitted into the Treasuries to the credit of the Society for the year 1949-50 amounted to Rs. 8718. Only a sum of Rs. 5352-9-0 was actually received before the calendar year 1950 closed, but the entire amount has been taken into account for purposes of preparation of the annual statement of accounts.

23. I have to emphasize here, that in order to maintain and increase the scope of the Society's humane activities, an assured income is most essential. This can be obtained only from invested funds, and this Society invokes the general public and philanthropically minded persons to make permanent endowments to enable it to achieve the objects it has in view.

Animal Shelters etc.

24. The Society has been responsible for the erection of 4 Animal Shelters in Tiruchirapalli Town and one at Karur to protect the animals from sun and rain, either out of its funds or with the help of benefactors. There is a proposal to construct a water trough and a cattle shelter at the Hay Market in Tiruchi Town in memory of Major R. H. Wigfall, a former president of the Society, and it is hoped, it will come to fruition at an early date.

25. The Inspectors are also inspecting the water troughs and submitting reports as to their condition and maintenance etc.

Cases brought to notice by the Public.

26. The services of the Inspectors were requisitioned by the public either in cases of cruelty to animals witnessed by them or to sick animals left uncared for on public roads. Necessary action was immediately taken against the offenders and necessary treatment was arranged to be given to the animals in the Veterinary Hospital.

27. A Resident Inspector, selected from the staff of Inspectors, lives in the premises of the Society to attend to public reports at all times and deal with them promptly.

Pinjrapole.

28. The absence of a Pinjrapole for the detention of old and infirm animals is keenly felt and the Society is engaging its earnest attention in this direction. Unless there is a separate fund of Rs. 25000/-, it will not be possible to take steps to bring the Pinjrapole into existence. The financial considerations are a great set back for an early establishment of the Pinjrapole and it is fervently hoped that with the co-operation of the public, a Pinjrapole in Tiruchi would become a "fait-accompli".

Prize Essay Competition.

29. As a means of educative propaganda, essays in English and Tamil on subjects connected with Animal Welfare were called for from the students of High Schools in the Tiruchirapalli District. 14 essays in English and 17 essays in Tamil were received and sent to the District Educational Officer, Tiruchirapalli, for selection of the best and the next best in English and Tamil. The Society is glad to report that the competition is becoming more popular every year. It is proposed to award prizes in the shape of books to the winners and the runners up.

Training of Apprentices.

30. With a view to replace Inspectors who may have to leave service, consequent on superannuation or other causes, the Society trains Apprentices.

31. In accordance with the rules framed by the Executive Committee for the recruitment and training of Apprentices, 2 men were recruited as Apprentices and sent up for training this year.

Staff.

32. The staff consists of 1 Chief Inspector and 10 Inspectors. The Chief Inspector looks after the office work and generally supervises the work of the other Inspectors. The staff worked cheerfully and well throughout the year and gave me every assistance that I required of them.

33. Inspections of outposts were made during the course of the year and difficulties in the matter of working set right.

Staff Provident Fund.

34. The year opened with a balance of Rs. 2,451-5-2. A sum of Rs. 339-9-0 was contributed by the staff, during the year under review. A sum of Rs. 223-12-5 representing the contributions made by Sri R. V. Natesan who retired was returned to him. The closing balance stood at Rs. 2,588-12-1 including the interest accrued on it.

Finances.

35. Sri K. Narayanaswami, G. D. A., R. A., Chartered Accountant audited the accounts this year also. The Statement of Accounts and his report appear as Appendices F. G. H. and J. It will be seen from Appendix H that the total finances of the Society after giving credit to the sum of Rs. 3,520-7-0 still due from the Government by way of Magisterial Fines for 1949-50, which were not received before the calendar year of 1950 closed stood at Rs. 21,350-9-5, exclusive of Stanley Building and Furniture, and this sum has been invested in various Banks and Post Office National Savings Certificates with the approval of the Executive Committee.

Appeal.

36. I express my indebtedness to the Magistrates of the various courts who try S. P. C. A. cases, to the Police Authorities for their kind co-operation with our Inspectors in their work of prosecuting the offenders under the Act and to the President, the Vice-President and the Executive Committee for the very keen and personal interest taken by them in the work of the Society which largely accounts for the success achieved during the year.

37. I have to appeal to the various Courts that try S.P.C.A. cases for imposing adequate sentences in cases of cruelty to animals and also order the ill-treated animals to be sent to the Infirmarys for rest and treatment.

38. I gratefully acknowledge the Society's indebtedness to all the members and donors who by money and personal service, have rendered help to the Society in promoting the cause of dumb and suffering animals. The number of members is not very much inspite of our frequent invitations. The Society appeals for good-will and kindness to all living creatures and draws attention of all to the noble view expressed by great leaders on the avoidance of cruelty to animals—"the more helpless a creature, the more entitled it is to protection by man from the cruelty of man". Every person witnessing any act of cruelty is requested to report it to our office. I once again appeal to the public that the maintenance of an Institution like the S. P. C. A., largely depends upon the support of the public in general and sympathy and support of the local bodies and other public Institutions. Our activities, I am sure, will win your approbation and receive your most sympathetic consideration.

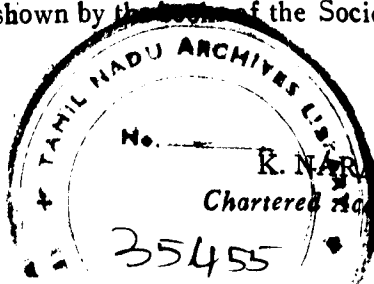

You will incur no expense for summons or prosecution.

It would always be better to secure another witness to the offence so that, in the event of denial, the case may be clearly established.

Any repeated acts of cruelty may please be reported to the Honorary Secretary, and a *Special* Inspector will be deputed to do the needful.
