MY LORD, AND GENTLEMEN,

1. We now do ourselves the honor to forward the Report upon our Investigation of the Cassimcotah Division of the Chicacole Circar, and however late it may be considered we can assure you has been pursued with unceasing application, and a dispatch that the complex accounts of the Country would admit of the obstacles we had to encounter in the commencement of this business, by no means gave us room to expect that minuteness, or even expedition with which it has been since effected, and it would be the height of injustice not to acknowledge the hearty co-operation and assistance of Vezieram Rauze who, besides ordering the village accounts, and every other source of information to be open to our inspection, has without hesitation laid his original Mutchilkahs before us of which the Zemindars are in general extremely tenacious. With such assistance not perhaps to have been obtained at any other period, we flatter ourselves the accounts now laid before you will be found sufficiently explanatory and satisfactory.
