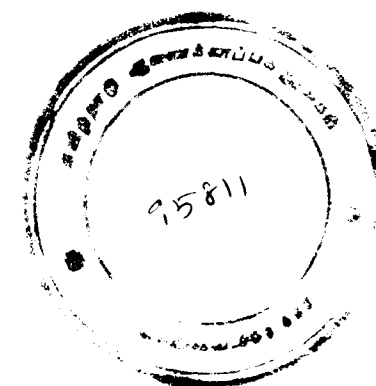

The Tinnevelly District Discharged Prisoners' Aid Society, ————— Annual Report for 1928. —————

This Society was started in the year 1923. For a period of 3 years, it was not functioning at all; and though it was revived in 1926, the work turned out in that year, and in 1927, was very little. In December 1927, our Collector, Mr. Galletti took charge of the District. He was invited to be the President of the Society. He complied with the request, forthwith called a Public Meeting, and issued an appeal announcing the object of the Society, and its usefulness for the safety of the Society in general, and calling for co-operation from the public and from all public bodies. Since, the existence of the Society, the scope and beneficial results of this great movement came to be widely known, and the Society, at the close of the Annual Report for 1927, ventured to express its hope to show a marked record of progress in all directions during 1928.

Office Bearers

During the year under report A. M. A. C. Galletti, Esq., I. C. S was the President of the Society. M. R. Ry. Rao Bahadur P. Nellayappa Pillai Avl., Advocate, was its Honorary Secretary. In August 1928, the Sub-Magistrate of Tinnevelly, M.R.Ry.V.S. Padmanabha Ayyar Avl. was elected

as Honorary Assistant Secretary. The management of the Society vested in the General Body till August 1928, and subsequently, in an Executive Committee consisting of 12 Members. The District Medical Officer Mr. B. Eswarayya, who was the member of the Executive Committee left the District during the latter part of 1928, and his place was not filled up. There is a lady member on the Committee. A list of the Office Bearers and of the Executive Committee Members is annexed as Appendix A.

Office

The District Magistrate, Mr. Galletti, was pleased to permit a room within his compound to be utilised as Office of the Society. A name board has been hung, and the Honorary Secretary has furnished it at his own cost. The clerical work has been done during the year by one Krishna Ayyar, who is a Typist. He is devoting his full time to the Society's work since 10th September 1928.

Strength of the Society

The Society consisted of 270 Members as against 46 in 1927. Of these, the Life Members were 60 in number as against 4 in 1927. 2 members left the station. 1 member died, and 5 persons were allowed to withdraw leaving 262 Members on the roll.

Meetings

6 meetings were held during the year under report as against 2 in 1927. The meetings were held in the Collector's Bungalow and were well attended. At the meeting held on 1—2—28, the

Honorary Secretary was requested to represent the Society at the Conference of representatives from Districts held in Madras, and the Honorary Secretary attended the Conferences at his own expense.

Finance

The receipts during the year amounted to Rs. 29,660—9—9 as against Rs. 42—12—0 during 1927. The expenditure during the year under report was Rs. 5,152—1—9 as against Rs. 50—1—3 in 1927 leaving a balance of Rs. 24,508—8—0 as against Rs. 6—10—9 in 1927. A statement of receipts and expenditure is shown in Appendix B.

Details of Income

A sum of Rs. 956 was realised during the year as subscription from Ordinary Members. Several gentlemen gave liberal donations for the construction of a Home for the Discharged Prisoners and Ex. Borstal School Inmates of this District and for forming an Endowment Fund. Where the donations consisted of Rs. 100 and above the donors were registered as Life-Members. The income under the head of donations amounted to Rs. 8,475. The collection from and in connection with the Performances came up to Rs. 19,724—11—0. The contribution given by Municipal Councils and Local Bodies for the year 1928 was Rs. 225. The sum realised from the Charity Box at the District Jail was Rs. 14 while the sum, collected as above and invested in the Imperial Bank, Tinnevely, realised an interest of Rs. 259—4—0.

A sum of Rs. 15 due for 1928 was collected in December 1927. The arrears from Ordinary

Members and Donors as on 1st January 1929 amounted to Rs. 289. A sum of Rs. 3 paid by three Ordinary Subscribers who were allowed to withdraw and a miscellaneous receipt of One Rupee are credited as Donations. A sum of Rs. 3,272 received as Donations at the time of Performances at Alwarthirunagari is shown under the head of Performances.

A list of members with the amounts subscribed by them is shown as Appendix C. The list of Donors showing also amounts given by them is shown as Appendix D. The list of Contributions from Municipal Councils and Local Bodies is shown as Appendix E. The receipts from Performances are shown as Appendix F.

Benefit Performances.

The Income under this head was the largest, as will appear from Appendix B. These Benefit Performances were undertaken by the Literary Association, Koilpatti, and the Indian Officers' Association, Tuticorin. Seven plays were staged by these two Associations. The Benefit Performance in one Taluk namely Ambasamudram was in the shape of Athletic Feats by Professor Ramamurti. In addition, the Borstal Boys of the Modified Borstal Institute, Palamcottah, enacted "Kovilan" on the second day, at Alwarthirunagari.

This method of raising Funds was adopted, since it enabled the masses also to contribute their mite to the objects of the Society, and since it enabled the Society to take their contribution for a consideration in the shape of Performances. One

other important reason for adopting this method was to attract people to Dramatic Performances, and entertainments, and to seize the opportunity to do propaganda work to an audience ranging from 2000 to 4000 at each Performance.

In organising these performances considerable support was received from the following gentlemen :- M. R. Ry. Sultan Mohideen Sahib Bahadur, then Divisional Officer, Koilpatti, M. R. Ry. K. S., then Sub-Collector, Tuticorin, Roche Victoria, Esq., Chairman, Tuticorin Municipal Council, and M. R. Ry. G. Sundararaja Ayyangar Avl., M.A., Deputy Tahsildar, Tuticorin, M. R. Ry. Adaikalam Pillai Avl., then Tahsildar, Tenkasi, M. R. Ry. T. S. Sabapathy Pillai Avl., District Registrar, Tinnevelly, M. R. Ry. Medai Dalavoi Renganatha Mudaliar Avl., M. R. Ry. Gnaniah Avl., Tahsildar of Ambasamudram, P. Chandrasekara Menon, Esq., I.C.S., Sub-Collector, Shermadevi, M. R. Ry. Moses Srinivasagam Avl., Tahsildar of Nanguneri, M. R. Ry. It will also appear from Appendix F that the attendance at and Income from Performances were gradually rising at each successive performance except that at Ambasamudram and the largest amount was realised at Alwarthirunagari. Here, it is worthy of mention that in connection with the Performance at Alwarthirunagari several gentlemen gave large donations of varying amounts to the extent of Rs. 3,272 for the Endowment Fund, and that those individuals like those who paid Rs. 100—and above were enrolled as Life-Members. Another notable feature of the performance at Alwarthirunagari was that the Second day play “Kovilan” was staged by the Borstal Boys of the Modified Borstal Institute at Palamcottah. The Superintendent, District Jail, Mr. Schmidt prepared a Silver Medal and Mrs. Galletti presented it at the Dramatic Pandal as desired, to the harmonist and musician who trained the Borstal Boys for the play.

The Society is thankful to the Members of the Literary Association and the members of the Indian Officers' Association and the Official and Non-Official gentlemen, who by their hard work and unstinted support made the attempts of the Society at collections by performances such a great success. The thanks of the Society are specially due to the Kumara Zemindar Avl., of Singampatti, and to M. R. Ry. I. C. Eswaram Pillai Avl., President Taulk Board, who devoted a considerable

portion of their time and energy to co-operate with the Officials for popularising this movement.

After-Care

In the matter of rendering Aid on Discharge the following procedure was adopted. Of the prisoners released from Palamcottah District Jail some belonged to other Districts while others were natives of this District. With regard to the former the Honorary Secretaries of those Districts were informed about the dates of their release, their previous occupation, the nature of the Industrial Training they had in the Jail, their relations in their villages, their pecuniary circumstances and the help they required if any. The Honorary Secretaries were also requested to have Parole Officers appointed for them. With regard to the prisoners and persons released from the District Jail, Palamcottah, and from other Jails and Institutes and belonging to this District, like information on the above heads was also gathered. Parole Officers were also appointed to find them occupation and to watch and guard their interests.

“Galletti Home”

In some cases it so happens that released prisoners cannot be provided with occupation soon after their release. It also happens that they have no abode to wait till they get employment. To provide for such cases a Home becomes absolutely necessary. The Society in this District waited to raise sufficient capital for constructing a Home, for running it, and for meeting other expenditure necessary to carry on the work of After-Care. As

soon as the financial condition of the Society became satisfactory the Executive Committee resolved on 10—8—28, to construct a Home at a cost not exceeding Rs. 9,500. The site was selected by Mr. Galletti and Lieutenant Colonel J. P. Cameron, Inspector-General of Prisons, and was purchased for a sum of Rs. 1,000. It measures 4 acres 66 cents. The building is estimated to measure 96 ft. North to South and 36 ft. East to West. Provision has been made for a Workshop, a Dining and Sleeping Hall, Two Sets of Kitchens and Store Rooms, a Well, a Latrine and an Office for a Superintendent.

The plan and estimate for the building were prepared by M. R. Ry. K. V. Sankara Ayyar Avl., D. P. W. Executive Engineer, Tinnevely, and the construction has been left to be supervised by Mr. Schmidt, Superintendent, District Jail, Palamcottah. He is having the work executed by Convict labourers. In connection with the Home useful suggestions were given by E. C. Smith, Esq., then Private Secretary to His Excellency and M. R. Ry. Dewan Bahadur G. Narayanasamy Chettiar Avl. The Home is intended only as a temporary residence for the Discharged Prisoners and Ex. Borstal Boys till they are found employment. During their stay at Home, the Inmates are to be fed at the Society's expense, and are to be employed in the Cottage Industries to be started in the Home. The Home is called after the President Mr. Galletti.

The "Galletti Home" was opened by the Hon'ble Dewan Bahadur M. Krishnan Nair, Member, Executive Council, on 27—10—28. So far, a sum

of Rs. 3,500 has been paid to Mr. Schmidt towards the expenses of the construction. The Building is rising, and is expected to be finished in 3 more months.

The Society tenders its heart-felt thanks to the Hon'ble Dewan Bahadur M. Krishnan Nair, for having laid the Foundation stone, and to M. R. Ry. M. V. E. Kasichami Nadar Avl., for his liberal donation of Rs. 3,000 towards the cost of the construction of the Home, to the late M. R. Ry. Rao Sahib S. Subramania Karayalar Avl., Shenkottah, Mittadar of Urmelalagiyan, Tinnevely District, who promised a sum of Rs. 2,000 for purchasing the necessary Machinery and Implements to start the Industries in the Home, and to his son M. R. Ry. S. Chattanatha Karayalar Avl., M. A., B. L. who dutifully fulfilled the promise of his revered father.

Probation Officers

During the year under report the number of persons released from Jail or after detention was 198. Of these 86 belonged to other Districts, and 112 belonged to this District. The Honorary Secretaries of the various Districts were duly informed of their release and parole officers were required to be appointed. So far as this District was concerned 57 Parole Officers were appointed by the District Magistrate. The members of the Society were made *per se* Parole Officers. The Society gave pecuniary assistance and other help to some of the released prisoners and to Ex. Borstal Boys. From the reports received from Parole Officers, barring a few cases and the case of an Ex.

Pupil, Chingleput, it is gratifying to note that the persons entrusted to them, are employed, do not associate with bad characters, and live as honest and peaceful citizens. As regards the few cases, their whereabouts at present are not known, and in one case the released prisoner is reported to keep bad company. The Ex. Pupil referred to above is one Kondappa Naick. He came out of the Senior Certified School Chingleput. He gave false address of his parents, and ran away. The Society is thankful to the Parole Officers for the honorary work they have done to advance the interests of the released prisoners and pupils. A list of such Parole Officers is appended as Appendix G.

Pecuniary and other help rendered during the year

Eight Moppilla Prisoners were paid each Rs. 25 as a loan to enable them to start petty trade.

A sum of Rs. 3 was given to Paramanantham Pillai, released prisoner 7776, by the President Mr. Galletti, from his pocket to enable him to reach home.

A sum of Rs. 20 was paid, to Borstal Inmate No. 8110, Chockalakkal Ispiriyan, who was released on license on 20—9—28, to provide himself with private clothing, bedding and for subsistence allowance for one month, from the date of release. He is employed as a private servant on a monthly salary of Rs. 10 by Captain Sundaresa Ayyar Avl., Assistant to the District Medical Officer, Tinnevely.

A. Swaminathan, Borstal Inmate No. 8106, was released on license on 1—11—28. He is being trained in the Head Quarters Hospital for a Compounder's appointment. The Society had resolved to pay him a monthly allowance of Rs. 10 as a loan for his maintenance charges to be supplemented by a monthly contribution of Rs. 5 by his parents during the period of his training i.e. 9 months from November 1928. He has been paid Rs. 20 for November and December 1928. The payment is continued.

Velukutti, son of Sankaran alias Pichumani, aged 22, accused, in S. C. No. 76 of 28, Tinnevely District and Sessions Court, for offences under Section 379 and 75 I. P. C., was sentenced to imprisonment till the rising of the Court. He was recommended by the Sessions Judge to be sent home to his parents at the expense of the Society. He was accordingly taken to his native village and entrusted to his uncle at a cost of Rs. 7—12—6.

One Seyyed Modideen, aged 22, Convict No. 8088, was released after serving a sentence of 3 years. He is residing in Courtallam Road, Tinnevely Town. He knows Tamil, English and Hindustani. He was a well-behaved boy in Jail. He knows drill well, possesses a good physique. He learnt tailoring in the Modified Borstal School, Palamcottah. At present he has been given an employment, as an Acting Peon in the Tinnevely Taluk Office. A list of these persons is given in Appendix H.

The amount of money spent on Aid on Discharge is Rs. 248—3—0.

Advance After-Care Officers

In practice it was found difficult to select and appoint probation officers just after information from the District Jail about the release of prisoners was received. There was consequent inevitable delay. Before the probation officers were appointed, the released prisoners were left to themselves to chalk out their own line of life and the parole officers were not able to get at them. It was therefore decided to appoint Parole Officers in advance, and to publish their names in the District Gazette, so that immediately the release of a prisoner came to be known the parole officer for the village or group of villages already appointed might be told about it. This happens long before the prisoner arrives in the village, so that the parole officer takes charge of him immediately after the arrival of the prisoner. With this end in view advance parole officers have been appointed. The Society expresses its thanks to those gentlemen for having consented to look after the interests of the released persons. A list of the Advance After-Care Officers appointed is shown in Appendix J. The total number of Parole Officers is 762.

Propaganda Work.

The Society rejoices to note and record, that almost the entire District is now aware of the existence of the Discharged Prisoner's Aid Society, and the useful work it is doing. This result was achieved to a great extent, as was stated already, by addressing the people, who gathered in large

number at Performances in the various Taluks about the objects of the Society, the ways in which those objects were intended to be gained, the work done till then, and the work which remained to be done.

The District Magistrate, Mr. Galletti, held a Conference with the Divisional Officers, the Tahsildars and the Deputy Tahsildars, and the Honorary Secretary at Koilpatti on 16—11—28. The work ahead in respect of After-Care was carefully discussed and scrutinised; and it was resolved to enroll a large number of parole officers all over the District, and to educate them about their work by convening meetings of parole officers at suitable centres. Printed instructions with forms to be filled up by parole officers, were prepared and sent to all Divisional Officers for distribution through Tahsildars to the parole officers appointed. They are shown as Appendix K and L. A copy of the resolutions passed at Koilpatti was also directed by the Collector to be sent to all Divisional Officers, Tahsildars, and Deputy Tahsildars. This was done. In pursuance, Meetings were convened and parole officers were invited. The Divisional Officers, Tahsildars and the Deputy Tahsildars concerned were also present. In these Conferences the persons assembled were informed about the importance of the work of aid on discharge, how best it served to prevent and reduce crime, and about the duties and functions of the parole officers. So far such meetings were held in Tinnevely and in Tenkasi. At those Meetings the pamphlets aforesaid relating to the functions of parole officers were distributed.

Another meeting was held on 30—12—28 at Vilathikulam, an outlying station of the District. The meeting was convened at the instance of the Honorary Assistant Secretary. There was a large gathering. The Assistant Secretary addressed the meeting about the aims and objects of this Society and appealed to the public to advance the cause of the Society by enlisting themselves as members and by serving as Parole Officers. A sum of Rs. 100 was subscribed and paid on the spot, and about 25 persons gave their consent to serve as parole officers. The Deputy Tahsildar Mr. Fernandez rendered help to the Honorary Assistant Secretary in his propaganda work.

Expression of Loyalty

At the meetings held in Vilathikulam, Tinnevely and Tenkasi, the public and the parole officers assembled recorded their sympathy with His Majesty the King Emperor, for His Majesty's illness, and prayed to God Almighty for his Majesty's speedy recovery.

The Honorary Assistant Secretary

In addition to the help which the Honorary Assistant Secretary rendered in the matter of propaganda work, he assisted the Honorary Secretary a good deal in marshalling facts and figures in regard to the released prisoners, in the matter of appointment of parole officers, and in gathering information from them about the prisoners entrusted to their care. He was bestowing attention to receipts and disbursements and was affording great relief to the Honorary Secretary to enable him to

attend to the work of organisation. It must also be said that, while the Honorary Secretary was away at Koilpatti in connection with the Sedition Cases, the Assistant Secretary was attending to all the work of the Society and paid full and personal attention to the success of the Foundation Stone Ceremony of the "Galletti Home". It needs scarcely be said that the Honorary Secretary was getting much help from the Assistant Secretary in getting through the office routine work, and the Honorary Secretary takes this opportunity to express the Society's indebtedness to him for the multifarious ways in which he enabled the Honorary Secretary to discharge his duties.

Audit

The Registers, Accounts and Vouchers were audited by M. R. Ry. I. C. Eswaram Pillai Avl., Member of the Society, Banker, Mittadar and President Taulk Board, Tinnevely, in pursuance of a resolution passed at the meeting of the Executive Committee held on 7—1—29. The Honorary Auditor closely scrutinised the accounts and records, verified them and found them correct. The Society is indebted to him for his disinterested labours. The Audit Report is appended as Appendix M.

Securities and their Safe Custody

The Securities belonging to the Society are the Sale Deed relating to the Galletti Home Site, and the prior title deeds and the Pass Books two in number. They are in the Safe Custody of the President.

General

The above is the summary of the work done by the Society during the year 1928. The Society feels glad, that it was able to realise during 1928, the hope it expressed in the Annual Report for 1927, to show a marked record of progress.

The thanks of the Society are due in abundance to the public and the public bodies for their generous help and the Society requests them to continue their help and support every year. The thanks of the Society are due to M. R. Ry. Dewan Bahadur G. Narayanasamy Chettiar Avl., who was giving the Honorary Secretary suggestions on different occasions. In conclusion the Society wishes to place on record that the progress achieved during 1928 was due in no small measure to the hearty co-operation of all officials of all grades in this District, and the Society hopes to turn out ideal work during 1929 with their continued support and with a liberal grant from the Government in pursuance of their declared policy to render financial help to the work of Aid on Discharge in proportion to the sum raised by subscriptions and donations. This two-fold support has been rendered possible by the Orders issued by the Government of Madras of which His Excellency Lord Goschen is the head. To His Excellency therefore the Society pays its heart-felt gratitude and its humble homage.

Instructions regarding Parole Officers.

Parole Officers are intended to look after the interests of persons released from jails, from Reformatory schools or from Borstal institutes, after they reach their village. It is desirable that men of means possessing influence and commanding respect in the locality are selected as such officers. They must not belong to the village factions if any. Non-officials are to be preferred. A Parole Officer must be selected for each village unit, and for each prisoner, if possible. Immediately after Parole Officers are selected their signatures must be taken in a form printed for the purpose, in token of their assent. A member of the Society is *per se* a Parole Officer.

2. As soon as the liberated person reaches his village, the Parole Officer will have to ascertain and inform the Secretary of the Society about his arrival, his future residence, his means, his relations if any, and the nature of the calling or occupation, for which the released prisoner is fitted, and which he desires to follow. If he wants a Parole Officer's help to find him occupation, he must render the necessary help. A Parole Officer will also inform the Secretary for what calling or occupation there is demand in the village and in the neighbourhood. If any help is required from the Society, the nature of the help required may be communicated to the Secretary. A Parole Officer must prevent the released prisoner from associating with bad characters. If he gets into trouble, the Officer will have to help him, extricate him out of it, advise and guide him to lead a peaceful and honest life.

3. In cases where prisoners are released before expiry of their term of sentence, subject to certain conditions, the Parole Officer will be informed about such conditions of release, and he will have to observe whether the conditions of release are fully complied with.

4. In cases where the released persons commit crime again, the Parole Officer will have to enquire or find out the nature of the offence and the circumstances alleged in relation to the commission of such offences.

5. The Parole Officer must be in constant correspondence with the Secretary of the Society. At least once every month or oftener, if necessary, the Parole Officer will have to communicate to the District Magistrate and to the Secretary all information relating to the released persons entrusted to his care, and concerning their occupation, welfare and progress. Printed forms containing the nature of the information will be sent to the Parole Officers, and they may fill up those forms and post them to the Secretary.

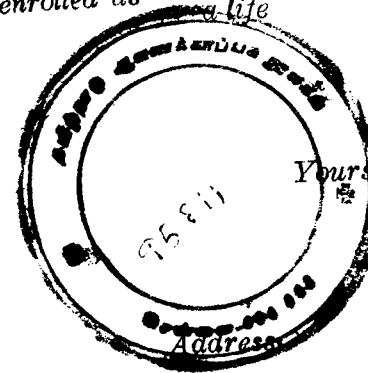
