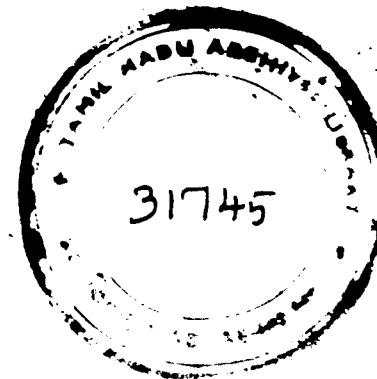

ANNUAL REPORT ON THE ADMINISTRATION OF TOWN-PLANNING IN THE MADRAS STATE FOR THE YEAR 1951-52.

CHAPTER I.

INTRODUCTION.

The year of the Report was a significant one for the department and records an all-round increase of activity. This increase was in the region of 75 per cent from the point of view of the total number of references received and 100 per cent from the point of view of the total number of plans and designs made or approved by the department, as compared with the figures of 1950-51. The year of Report was also administratively a difficult period as, with the retirement from service of Sri R. D. N. Simham, by the end of June 1951, the department was left with only one expert officer. The general outturn of the department was good and the department endeavoured to meet the increasing demands made on it by the municipalities, panchayats and other Government Departments and to render them as much assistance and guidance as was possible under the circumstances.

2. The municipal councils evinced keen interest in all matters relating to Town-Planning, the enforcement of Town-Planning and Building Regulations and the preparation and execution of Town-Planning and Improvement Schemes. Good progress was shown in all these activities. The interest shown by the local bodies in the improvement of civic amenities, in providing parks, play and recreation grounds, bus-stands, markets, schools, child welfare centres, offices, schools, etc., during the year was also remarkable and the department furnished a number of layouts and designs for them. They also made good progress in making new Town-Planning Schemes, reviving old and pending Town-Planning Schemes, execution of sanctioned schemes and also in the zoning of residential and industrial areas and regulating industrial installations. The department gave technical advice on layouts and designs of land development and building schemes of some Government departments and Co-operative Housing and House Construction Societies. A very large number of layouts was furnished to the Revenue and Harijan Welfare Departments for providing house-sites and amenities to houseless Harijans. The department also examined and issued certificates and advice to a large number of industrial concerns in regard to their factory buildings under the Madras Factories Rules.

3. *The scope of Town-Planning in the State.*—There were, in the Madras State, 99 municipalities including the Corporation of Madras. The total number of Town-Planning Schemes so far undertaken by these municipalities were 492, but they still cover only a part of the total area occupied by the municipalities. Similarly, in the matter of panchayats, there are 466 Class I panchayats and 8,035 Class II panchayats organised and functioning as such under the Madras Village Panchayats Act. Out of the above total of 8,501 panchayats, the Town-Planning Act has been extended only to 341 panchayats. But it is significant that only 46 Town-Planning Schemes have so far been undertaken by the panchayats and villages in the State. Town-Planning activity in panchayats continued to be poor for want of adequate resources in staff and finances.

4. The figures given above indicate the extent to which the Town-Planning function in the State is yet backward and also the vast scope of work which yet remains to be done. There are, in addition, about 8,501 villages in the whole State which also need a large measure of grouping, regrouping, planning and improvement and provision of a local or combined civic amenities, improved

sanitation, housing, communications, etc. There is also need for making a comprehensive study of the villages in the State. The village should necessarily form the basis of Town and Country Planning in this country and no scientific approach to Town-Planning can be made without understanding and taking into account the particular characteristics of the villages and villagers who make up the bulk of the population. Village planning and village improvement should be taken as part of regional planning schemes. A group of villages numbering from 10 to 30, as circumstances may demand, should be designed to form by themselves into one "Rural City" with full amenities, and a regional scheme should envisage the creation of as many such rural cities as may be required. The villages are the real assets of our country and the most beautiful and healthy places to live in. With proper planning, the rural populations can be prevented from drifting into the towns and cities. It is necessary, therefore, to expand the activities of the department to the planning of the villages of the State.

5. In the Administration Report of the department for the year 1950-51, the department ventured to point out how and to what extent district boards can and should introduce Town-Planning activities in the rural areas and panchayats in the districts and to show how the Chingleput district has already taken the lead in the matter. Government, in their review of the Administration Report of the department for 1950-51 (G.O. No. 185, Health, dated 18th January 1952), observed as follows:—

"It is gratifying to note that the Chingleput District Board is evincing special interest in Town-Planning and that it is preparing certain detailed Town-Planning Schemes. The Government hope that the example set up by the Chingleput District Board will be followed up by other district boards also.

"It is gratifying to note that the Chingleput District Board is evincing bringing within the reach of the villages and panchayats in their areas the benefits of planning, improvement and amenities and also good housing."

6. *Need for knowledge of the value and meaning of Town-Planning.*—While the scope for planning is vast and while little has been done so far, it is essential that the planning authorities and those for whom the planning is done, viz., the citizens, know what planning signifies and gain a correct appreciation of the value and the need for proper planning. It is also essential to have technicians in the local bodies who are well-versed in the subject and to give suitable training facilities for the personnel already employed by the local bodies. The dissemination and acquisition of the required knowledge can be obtained in three ways, (1) by establishing courses of study in some technical institutions of the State, (2) by a properly organized publicity and education branch in the Government department and teaching of elementary principles of Town-Planning in schools as an essential civic study, and (3) by the organization by local authorities such as municipal councils, major panchayats and district boards, of a town and country planning library in their offices and inclusion of some essential books and journals on town and country planning in the public libraries and reading rooms run by them. As regards items (1) and (2), specific proposals had been made to the Government and these were under consideration by them. In the matter of item (3) above, the local bodies may themselves initiate suitable action. The department has already circulated a list of books to be purchased by municipalities. The department has under consideration the issue of a circular of information on a scheme of books and periodicals which may, for this purpose, be purchased by municipalities. Government generally approved the proposal of the Provincial Town-Planning Enquiry Committee that the Town Planning Officers of municipalities and officers of the department may give lectures on Town-Planning principles to the public with a view to improve the general knowledge of the public on Town-Planning matters. The issue of detailed instructions in the matter was under consideration of the department.

7. *Housing.*—Housing is essentially a part of town and country planning and should become a major function of the department. Co-operative housing continued to be the main feature of housing in the State and several new Co-operative

Housing and House Building Societies were registered during the year and the department furnished a large number of schemes and approved a large number of designs of houses.

(a) *Selection of sites for Co-operative Housing Schemes.*—It has come to the notice of the department that in some cases the lands selected by the co-operative societies for their housing schemes were highly defective in the following respects:—

(1) Badly located areas were chosen, sometimes outside existing towns. Such housing is highly injurious to Town-Planning, which cannot permit of sporadic building or indiscriminate tendencies to expand the size of a town forcibly and uneconomically.

(2) Areas located on the fringes on or either side of main highways were selected producing highly injurious ribbon developments outside urban areas.

(3) Certain areas selected had inadequate facilities for lighting, water-supply and drainage, which ought not to be encouraged.

(4) Lands were sometimes acquired in irregular shapes and odd boundaries making it impossible to plan them properly.

(5) There are instances, where after enormous sums of money had been expended, the sites were found to be inconvenient for workers in adjoining cities or towns or where daily migrations became costly.

The department feels convinced that wherever a co-operative society is formed with lands outside or inside a town or city, the department should first be consulted regarding the suitability of the site in view and that no society should be registered, if the sites are found to be unsatisfactory from a town-planning point of view. Selection of sites for housing is the most important aspect affecting town-planning and no site should be chosen or used, if it is not likely to conform to the standards and requirements of scientific planning and zoning of housing. Avoidable waste of ill-conceived expenditure can thereby be prevented. It is necessary to amend the rules relating to Co-operative Housing and House Construction Societies in this regard.

8. *The future of housing.*—Housing as a Government function must assume great importance hereafter, in this welfare State. From the point of view of Governmental action, housing will necessarily be confined only to housing of the lower income groups who, in the majority, are at present very poorly housed in insanitary or overcrowded hutments and other dwellings. The co-operative method of housing has not so far succeeded in giving much relief in providing housing accommodation to these groups. The basis of housing would, therefore, be a matter of Governmental policy and the need for fixation of standards of housing and methods of financing housing schemes are matters for legislative and administrative action. It has, however, been felt by the department that there is need for organizing a certain amount of housing research, with a view to encourage indigenous talents and use of indigenous materials and also in the adoption of indigenous methods of construction of houses. In securing land for such housing, it has been considered that such housing should be confined to a large extent to "New Towns" and "New villages" that may be created to start with. The department feels that it has to be given an opportunity to establish a housing branch within its folds, charged with the responsibility for creating such "New townships" and "New villages" while at the same time conducting research on the indigenous methods of construction, labour and materials. The department prepared a large number of Harijan Colony Schemes and also schemes for rehabilitation of people evicted from project areas, but its activities remained confined to the supply of layout designs and plans. While the planning of such townships and villages is necessary a good measure of the value of such planning would be obtained only in the further pursuit of such planning by the erection of the particular types of buildings such plans conceive, and this should be handled by the department direct in organized Government housing schemes.

9. *Need for qualified town-planners.*—The need for a large number of qualified town-planners for the department and the municipalities of the State was keenly felt. At a modest estimate, it is estimated that the Madras State will absorb

almost 300 to 400 trained town-planners, and it is significant that no training facilities in this science exist in the whole of India as yet. From an administrative point of view, the department has always felt that it was necessary to equip it with a large number of expert officers on its services. It has also felt that, in respect of some of the major municipalities, including the Corporation of Madras, there should be qualified town-planners in charge of the town-planning functions.

One significant fact in respect of the scientific approach that should be made in respect of planning and which must necessarily be realized, is that by proper town and country planning a considerable amount of avoidable wastage in expenditure can be saved, as planning and regulation will eliminate the possibilities of bad developments, overcrowding, congestion and slums, which occur freely in the absence of planning and are costly to eliminate or rectify later on. The economics of town-planning is an acknowledged fact. Additional expenditure on improving town-planning administration, will be an asset to any State.

10. *Progress of town-planning in the State.*—Town-planning has now become a recognized function with every municipal council and a good many panchayats. The progress of the town-planning function has been steady and recently there has been rapid increase in the number of schemes prepared and the extent of town-planning action instituted by local bodies. There has also been a certain amount of general awakening on the part of local bodies regarding the need for proper planning and improvement. The pivot, however, of the town-planning movement and town-planning action in the State, still rests with the Directorate of Town-Planning at the Centre. Although the functions of the department are deemed to be advisory, it has in effect proved to be far more than merely advisory, notwithstanding the fact that even in an advisory capacity the department functions as a guiding force in all town-planning matters. Simultaneously, in respect of building regulations, private land development and various other functions of the department, there has been considerable improvement in recent years. There is also ample scope for still further improvement.

CHAPTER II.

ADMINISTRATION OF THE TOWN-PLANNING ACT.

11. *Applicability of the Town-Planning Act.*—(a) *Municipalities.*—The Madras Town-Planning Act was applicable to 99 municipalities of the State including the Corporation of Madras.

(b) *Panchayats and villages.*—The total number of panchayats and villages to which the provisions of the Madras Town-Planning Act had been extended and was in force during the year was 341 as against 295 at the end of the previous year. Government were pleased to extend the provisions of the Act to 36 villages in Chingleput district and 10 other existing panchayats in the State during the year. In respect of the panchayats of Repalle and Ariyalur, the original notifications were amended so as to empower the panchayat board and its Executive Authority to function as a municipal council and its Chairman under the Act. A list of panchayats to which the provisions of the Town-Planning Act and also of the provisions of Chapters IX and X of the Madras District Municipalities Act, have so far been extended is given in Appendix I.

The District Board of Chingleput exercised planning powers in all areas surrounding the Madras City covering 194 villages. The District Board had a Town-Planning Officer on its staff and had under consideration a scheme for assisting Panchayat Boards in its area in all their Town-Planning problems. Although the Town-Planning Act had been extended to 341 villages and Panchayats in accordance with their individual importance a good many of the Panchayats did not as yet possess the wherewithal to make and carry out the schemes of Town-Planning and housing they badly needed. The District Board of the concerned Districts should be in a position to supply to the smaller

panchayats in their areas such technical assistance as may be required for these works. Organizationally, therefore, there is need for technical staff at the District level, and this may be provided by the District Boards, which may arrange for farming out and collecting from the Panchayats concerned such contributions as they may be able to make towards the maintenance of the staff. The recommendations made in the Administration Report for 1951-52 in this regard should be considered seriously by all District Boards.

12. *General Town-Planning Schemes (Master Plans).*—Need for General Town-Planning Schemes.—The preparation of a General Town-Planning Scheme by all municipalities for all land within the municipal limits and their vicinity is an obligation under the Town-Planning Act. Such a scheme would lay down and specify on broad-based principles of Town-Planning, the general lines along which the Town or City may be allowed to grow, develop and improve and be the basis for all individual Town-Planning action. The urgency of the need for the preparation of these schemes is obvious and more than ever, to be realized in these days of rapid development and reconstruction.

13. *Progress made in the preparation of General Town-Planning Scheme.*—(a) *The Madras City and environs.*—The Corporation had an aerial photograph made of the entire area of the scheme including the city and 54 villages around it. The Special Assistant Engineer continued to attend to the work of the master plan under the guidance of the Joint Director of Town-Planning. A preliminary master plan has now to be prepared and is expected to be completed in the course of a year.

(b) *The Municipalities.*—The Mangalore and Coimbatore Municipalities completed almost all the preliminary work. The preparation of the schemes has now to be taken up by the department directly. The preliminary work in Tiruchirappalli Municipality progressed satisfactorily and is nearing completion. The Madurai Municipality suspended during the year its preliminary work which was progressing satisfactorily and disbanded the temporary staff engaged for the purpose. The Municipal Council has been advised to resume the work soon. Preliminary work was commenced by the Vijayavada Municipality and some attempts were made to commence it by the Salur, Tuticorin, Tirunelveli, Mangalore and Bodinayakanur Municipalities. These latter municipalities had not employed sufficient staff and were advised to do so. Several other municipalities sought the advice of the department regarding the preparation of their General Town-Planning Schemes and were given such advice as was necessary. In cases of towns which were yet unsurveyed, the municipal councils were requested to get such surveys made by the Survey Department of the Government.

14. *The Pallikarani Regional Scheme.*—Mr. Robert Alexander, an American Town-Planner and an expert of the United Nations Organization who came to advise Messrs. Amalgamations, Limited, Madras, regarding housing colonies for the factory workers in the Pallikarani Project, which involved the creation of a series of villages in Saidapet taluk, recommended that a statutory scheme should be made on the basis of a Regional Town-Planning Scheme for the entire area of the reclamation and surrounding villages. The scheme aimed at rural reconstruction on modern lines, in which new village units will be created for the company workers to stay in and also to develop agriculture in the reclamation area. The Joint Director of Town-Planning, Sri C. Govindan Nair, collaborated with Mr. Alexander in the making of the Pallikarani Scheme.

A detailed statement of progress made in the preparation of General Town-Planning Schemes with the time granted by Government for each municipality is given in Appendix II.

15. *Preparation of detailed town-planning schemes.*—(a) *Municipalities.*—Town-planning activity prevailed and town-planning schemes were undertaken by 7 municipal councils including the Corporation of Madras out of a total strength of 99 municipalities in the State. The fact that 11 of these municipalities were constituted newly during the last year or two and that most of them had yet to

start taking action in respect of Town-Planning should be taken account of. It has, however, to be admitted that the older municipalities of Bhimavaram, Bhimunipatnam, Chidambaram, Cuddapah, Mannargudi, Tellicherry, Tiruvallur and Walajapet are still to begin to prepare detailed town-planning schemes, although the Municipal Councils of Bhimunipatnam and Mannargudi did some work towards the preparation of the General Town-Planning Scheme. Among the newly created municipalities, Amalapuram, Arni, Ambur, Bapatla, Gudur, Guntakkal, Melapalayam, Pudukkottai, Salur and Tindivanam have yet to begin Town-Planning action.

A few municipalities declared and notified certain town-planning schemes but had inadvertently neglected some of these schemes and in some cases even dropped them. The department would like to impress upon these authorities the need to regulate land developments in vulnerable areas and to plan such developments in a suitable manner and it is necessary that they should co-operate with the department in the interest of their towns.

(b) *Panchayats*.—Most of the panchayats were handicapped for want of technical staff and a good many of them could not financially afford to employ staff. If existing towns are not to overgrow at the expense of the villages, planning should start at the village level providing proper amenities, better opportunities and living conditions. As already suggested, the district boards may lend a helping hand to the panchayats or some panchayats which are close to one another may join together and employ commonly the required staff.

16. *Town-Planning Schemes notified by municipal councils under sections 9 and 10 of Act*.—The following detailed Town-Planning Schemes have been newly undertaken and notified under sections 9 and 10 of the Town-Planning Act during the year.

The Kakinada Municipal Council re-notified four detailed schemes under section 10 of the Act and the Palayamkottai Municipal Council re-notified the Nandakulam Scheme under section 10 of the Act.

17. *Town-Planning Schemes notified under section 12 of the Act*.—The following schemes were newly notified by the Government under section 12 of the Act during the year:—

The proposal of the Palayamkottai Municipal Council to drop the new municipal extension Town-Planning Scheme undertaken by it was agreed to by the department.

18. *Total number of schemes in operation*.—By the end of the year, there were in all 374 detailed town-planning schemes under various stages of preparation, publication and submission to Government and also 118 sanctioned Town Planning Schemes in various stages of execution in the municipalities and panchayats of the State. Appendices III and IV give details of the progress and the stages in the preparation, publication and submission of the detailed town-planning schemes and the execution of the sanctioned town-planning schemes respectively.

It has been observed that certain municipal councils have not yet registered the notified town-planning schemes under the Indian Registration Act as required by the rules. They should note that copies of notifications issued under section 12 of the Act by the Government and also under section 10 of the Town-Planning Act by the municipal council which were published prior to the issue of rule 50-A as per G.O. No. 2444, P.H., dated 16th July 1948, may also be registered under the Indian Registration Act and that the Government have considered it necessary and desirable to register all such notifications accordingly. The Executive Authorities concerned should take prompt action under rule 50-A (2) in respect of all notifications of schemes issued under section 10 or section 12 prior to 16th July 1948.

19. *Delay in the preparation of Town-Planning Schemes*.—As pointed out in the Report for 1950-51, delays in the making of Town-Planning Schemes cause much inconvenience to landowners and builders and are generally injurious to interest of town-planning. It has also been observed that some municipal councils which had already published the Town-Planning Schemes did not take further action to approve them and submit them to the Government for sanction. Such delays have to be avoided.

20. *Time-barred Town-Planning Schemes*.—A list of Town-Planning Schemes which were taken up by Municipalities and Panchayats under section 10 of the Town-Planning Act, but which became time-barred for the reason that the schemes were not published and submitted to Government in time and also of schemes undertaken but dropped subsequently by the Municipalities and Panchayats is given below:—

It is observed that most of the above schemes are very essential and valuable schemes and that as such, it was undesirable to discontinue them. The concerned municipal councils and panchayats were accordingly advised to either re-notify these schemes themselves or to request the Government to notify them under section 12 of the Act. Layouts and draft schemes had been furnished by the department for most of the schemes and the concerned authorities should see that they are perused and carried out in the fuller interests of Town development.

21. *Draft Detailed Town-Planning Schemes and layouts furnished by the department during the year.*—Although during the year the Municipal Councils took better interest in Town-Planning Schemes than in previous years, the department found it impossible to furnish draft Town-Planning Schemes and layout plans in respect of all the schemes referred to it. The department prepared and furnished layout plans and draft schemes in respect of the following schemes during the year:—

As the work of the department increased considerably, it was not possible to bestow timely attention on the Town-Planning Schemes for want of staff.

22. *Interim control under section 17 of the Town-Planning Act.*—Interim control of land development and of erection of buildings in Town-Planning Scheme areas for which the schemes had not been sanctioned and control of developments in sanctioned Town-Planning Schemes showed remarkable improvement during the year. The advice of the department or its approval as the case may be, was taken in respect of layout applications received by local authorities in Town-Planning Scheme areas. Eighty-five layout applications were examined and dealt with by the department during the year. A list of such layouts is given in Appendix V to the report.

Certain municipal councils supported the resolution of the Eluru Municipal Council. The Government in their order in G.O. No. 896, Health, dated 18th March 1952, declined to accept proposals. Government considered that a general relaxation will give rise to slums on an unrestricted scale. Government observed that exemption of Harijan Colonies from the operation of Town-Planning Rules will only give unscrupulous landholders a free hand to exploit the situation for their own private benefit at the expense of the Harijans whom the exemption is supposed to benefit. Government considered that the acceptance of the resolution by Government will only result in unhygienic housing, particularly overcrowding, without adequate provision for circulation of fresh air inside dwellings, leading to a low level of health and vitality of the residents and this will cause very much greater hardship by way of loss of man-hours of earning capacity on the part of the principal earning members. It is observed that most of the above schemes are very essential and valuable schemes and that as such, it was undesirable to discontinue them. The concerned municipal councils and panchayats were accordingly advised to either re-notify these schemes themselves or to request the Government to notify them under section 12 of the Act. Layouts and draft schemes had been furnished by the department for most of the schemes and the concerned authorities should see that they are perused and carried out in the fuller interests of Town development.

21. *Draft Detailed Town-Planning Schemes and layouts furnished by the department during the year.*—Although during the year the Municipal Councils took better interest in Town-Planning Schemes than in previous years, the department found it impossible to furnish draft Town-Planning Schemes and layout plans in respect of all the schemes referred to it. The advice of the department or its approval as the case may be, was taken in respect of layout applications received by local authorities in Town-Planning Scheme areas. The Government, however, had no objection to

individual cases of hardship being examined on merits liberally and sympathetically and in the case of Harijan Colonies even without excessive regard to straight lines and rectangles and squares, subject to the condition that, whenever possible and where it can be done without undue hardship, the rules are meticulously and rigorously enforced and that local bodies may bring such cases of hardship to the notice of the Director of Town-Planning for consideration.

30. *Progress in the execution of sanctioned town-planning schemes.*—rally very good progress was made as regards arbitration, acquisition of lands, provision of amenities, etc. The progress made by some of the municipalities indicated in detail in Appendix IV to the report.

31. *Levy of betterment.*—In G.O. No. 2556, P.H., dated 2nd October 1945, the Government pointed out that the levy of betterment contribution in Town-Planning areas at a fixed percentage spread over a number of years may result in collection of unduly large amounts and may cause hardship to owners and invited the attention of the municipal councils and the Corporation to provision of section 36 of the Town-Planning Act, under which they would make suitable provision in schemes for collection of lump sum in lieu of betterment contribution from the owners of properties in case this is found desirable and that the schemes should provide for the following under the betterment clause.

“Notwithstanding anything contained in clause, the council may, with the previous approval of Government, agree with any owner to receive a fixed payment either in lump sum or in instalments in lieu of the betterment contribution”. In respect of sanctioned schemes where such provision is not made, the Commissioner should see that a clause in the above sense is introduced by making necessary variations under section 15 (2) of the Act.

32. *Variations to sanctioned schemes.*—During the year, the Government sanctioned draft variations and confirmed the variations in respect of 10 Town-Planning schemes. Variations published in respect of four schemes were not confirmed during the year.

33. *Town-Planning Committee of Municipal Councils.*—Most of the municipalities had special Town-Planning Committees functioning under section 37 of the Town-Planning Act, and had powers delegated to it by the Municipal Council under rule 22 of the Town-Planning Rules. The Standing Committee (Town-Planning and Improvements) functioned as Special Town-Planning Committee for the Corporation of Madras.

34. *Town-Planning Fund under section 30 of the Town-Planning Act.*—Some municipal councils have yet to constitute the Town-Planning Fund as required by section 30 of the Town-Planning Act and rules 67 to 69 and Form No. 23 of the Town-Planning Rules. Their attention is drawn to the administration report of 1950-51 in this regard. They should establish such a fund and find ways and means to develop the fund.

35. *Annual Budget Estimates for Town-Planning by municipal councils.*—As required by G.O. No. 1010, L. & M., dated 15th March 1952, municipal councils consulted the department regarding the provision to be made for Town-Planning in their budget estimates. The department examined the Budget Estimates of 72 municipal councils and approved the estimates and made suitable recommendations in regard to extra allotment to be made wherever necessary and pointed out the instructions issued in G.O. No. 2529, P.H., dated 26th August 1946.

36. *Amendments to Town-Planning Act.*—The amendments to the Town-Planning Act, 1920, based on the recommendations of the Madras Provincial Town-Planning Enquiry Committee accepted by Government in G.O. No. 1097, Health, dated 25th March 1950, were submitted by the department and were

under examination by the Government. It is considered that the expanded provisions of the Act will improve Town-Planning administration in the State. The passing of the amended Act is of great importance and has to be speeded up.

37. *Amendments to the Town-Planning Rules, 1933.*—It was found that a number of local bodies were using the Property Tax Special Notice forms and miscellaneous receipt forms and that all municipalities were not using the same kind of forms for the same purpose. Government were, therefore, requested to prescribe standard forms which may be printed in the Government Press and supplied to local bodies on payment of cost. The Government accordingly amended rules 59 (1), 59, etc., of the Town-Planning Rules in G.O. No. 790, Health, dated 11th March 1952, which were finally confirmed in G.O. No. 2517, Health, dated 6th August 1952. Additional forms Nos. 22-A and 22-B were prescribed.

(1) Special notice of assessment of betterment contribution under sections 23 and 24 (b) of the Town-Planning Act and rule 58 of the Town-Planning Rules.

(2) Notice of demand for betterment contribution and receipt for betterment contribution.

38. *Improvement Trusts.*—The Director of Town-Planning continued as an ex-officio trustee of the Madras City Improvement Trust and attended the meetings of the Trust. The Visakhapatnam Municipal Council submitted proposals for the creation of an Improvement Trust with a view to making a master plan for the town and its vicinity and to co-ordinate the improvement activities of the Port Authority, the Railways and of the town and to carry out works of improvement. The question whether the Union Government activities would also have to be brought in for the purpose of creating a Town-Planning Trust within the framework of the Town-Planning Act was under consideration with the Government.

39. *General remarks on Chapter II.*—As may be observed from the figures given above, good progress was generally made in the matter of Town-Planning Schemes and the work of the department was also much greater than in the previous years.

CHAPTER III.

ADMINISTRATION OF THE PROVISIONS OF THE MADRAS DISTRICT MUNICIPALITIES ACT, 1920, RELATING TO STREETS AND BUILDING REGULATIONS.

40. *Extension of provisions of Chapters IX and X of Madras District Municipalities Act to panchayats and non-municipal areas.*—The demand from local authorities for powers to enforce building regulations and street making control was very much on the increase during the year. The provisions of Chapters IX and X of the Madras District Municipalities Act together with certain other relevant sections are extended by the Government or Inspector of Municipal Councils and Local Boards to the following Panchayats and villages during the year.

The provisions of Chapters IX and X of the Act were in force in 306 panchayats and villages during the year as against 267 in the previous year. The Building Rules of 1942 were also made applicable to the Mettur Township in G.O. No. 3536, dated 28th August 1951.

The following panchayats, to which the provisions of the Town-Planning Act had already been extended, have yet to get the provisions of the Madras District Municipalities Act also extended to their areas.

(1) The Vriddhachalam Panchayat (South Arcot district), (2) the Kollegal Panchayat (Coimbatore district), (3) the Razole Panchayat (East Godavari district), (4) the Pamarru Panchayat (Kishna district), (5) the Nannilam, (6) the Papanasam and (7) the Pattukkottai Panchayats (Tanjore district), (8) the Jayakondam and (9) the Lalgudi Panchayats (Tiruchirappalli district), (10) the Ambasamudram and (11) the Puliangudi Panchayats (Tirunelveli district).

The need for extending these provisions was explained in the last year's report. The panchayat boards concerned should address the Inspector of Municipal Councils and Local Boards for the extension of the provisions of the Madras District Municipalities Act and rules thereunder, under section 125 (1) of the Panchayat Act and see that these provisions are strictly enforced.

41. *Control of private streets.*—The Corporation of Madras and most of the Municipal Councils in the State enforced these provisions very strictly and effectively during the year. The panchayats of the State could not, however, be as effective in the enforcement, as might be desired.

Cases of unauthorized subdivision and sale of land as sites for buildings were still noticed in some places, but these were very few. It is necessary that purchasers of sites should know the obligations of the owners. The municipal and other local authorities may periodically issue bulletins and hand-bills to the citizens to keep them constantly informed of the matter, so that innocent parties may not be inveigled into purchasing such sites which may involve them in difficulties later on.

Land development was somewhat poor as compared to the previous year as a result of market fluctuations. Land speculation was observed to be poor though housing shortage still prevailed in an acute measure. Only 26 layout schemes (from 18 municipalities) covering an extent of 96 acres and providing for 984 building sites were approved by the department during the year. Appendix VII gives details of layout schemes approved by the department during the year.

42. *By-laws for street control.*—*Layout.*—The model by-laws commended in G.O. No. 1616, Health, dated 2nd September 1931, for layout of private streets were adopted by the Narasaraopet and Tiruchirappalli Municipalities with the approval of the Inspector of Municipal Councils and Local Boards. Such of the Municipal Councils as have not so far adopted the bye-laws and the Panchayats to which Chapter IX of the Madras District Municipalities Act had been extended, should adopt the bye-laws without delay.

43. *Relaxation of street, making provisions.*—The Mettupalayam Municipal Council requested that Government may permit the Municipal Council to waive the requirements of sections 175 and 179 of the Madras District Municipalities Act in respect of the private layout schemes in the town. It was pointed out by the department that it is incumbent on a party who intends to subdivide and lay out his land as sites for building purposes to see that suitable roads are provided so as to give access to every building site proposed to be disposed of by him and that such a street should be duly levelled, paved, channelled, drained, conserved and lighted by the owner concerned and that this obligation cannot on any account be waived, since every person who purchases a building site would be entitled to the full amenity of a formed road giving access to it and that in the operation of the provisions, the Municipal Council is at liberty to frame bye-laws to regulate the making of streets. They were also told that the instructions issued in G.O. No. 1920, P.H., dated 26th May 1939, should be complied with irrespective of whether a land belongs to a poor or rich person and that a private street, when made by owner, should conform to certain specifications, and would not merely allow of earthen roads or of an owner leaving only lands for streets. It was also explained that if private persons are allowed any laxity in their obligations, such obligations will devolve on the Municipal Council in due course and will have to be carried out at public expense and that there was no reason why the public should be called on to spend any money where an individual stood to secure the full benefit of a private development. The Government agreed with the above observations of the department and informed the Municipal Council of Mettupalayam accordingly, but the Municipal Council has again asked for a reconsideration of the orders of the Government and the matter was under consideration of the Government.

44. *Enforcement of Building Rules.*—With the appointment of Town-Planning and Building Inspection staffs by municipal councils, municipalities have been able to enforce the building rules more and more effectively. The engagement of licensed surveyors was also very useful in this matter. It was considered that, with the co-operation also of the builder, who is in actual charge of a construction (contractor, maitri, mason or builder) the erection of buildings unauthorisedly and in violation of rules could be largely checked. The Palayamkottai Municipality made a suggestion to have bye-laws enacted for licensing of builders also, to meet the above aim. The department considered the suggestion premature, in the absence of institutions training persons for the building trade in a specialised manner, as is being done in western countries and also in view of the fact that the building profession has not yet become organized and is still very much in the indigenous stage. The Government in Memorandum No. 25, Health, dated 24th August 1951, agreed with the department that the question of framing of bye-laws under section 306 (10) (c) of the Madras District Municipalities Act for licensing builders (masons) may be deferred for a period of two years.

45. *Construction of buildings by parties without permission.*—*Checking of—Responsibility of Town-Planning and Building Inspection staff and other outdoor staff.*—In their Order No. 72, Health, dated 8th January 1952, the Government informed Executive Authorities of municipal councils as follows:—

“Instances have come to the notice of the Government where private parties have either constructed or reconstructed buildings without obtaining the required permission from the local bodies concerned or constructed or reconstructed them in contravention of building rules. Such unauthorized constructions or reconstructions have led to protracted correspondence between the Government and the local bodies concerned as a result of parties petitioning to Government or the Director of Town-Planning giving rise to difficult and delicate situations. The Government consider that such protracted correspondence or situations would not have arisen if the Town-Planning and Building staff of local authorities had detected such construction or reconstruction in their initial stages and taken steps to stop them. And even after such unauthorized construction or reconstruction had been detected and reported, the Executive Authorities of local bodies have been slow in taking action for the demolition of such unauthorized construction or

reconstruction. The result has been that many an unauthorized construction reconstruction has come to stay.

The Government, therefore, wish to impress on the Executive Authorities of municipalities and other local bodies to which areas the Town-Planning Act and the building provision of the Madras District Municipalities Act have been extended, the supreme importance and the utter necessity of the local Town-Planning and Building staff to detect such construction or reconstruction when they are commenced and take prompt steps for stopping them instead of allowing them to be proceeded with until they are completed when demolition rather becomes difficult. Even if such unauthorized constructions are for some reason or other completed, the Executive Authority concerned should take prompt action to get the construction or reconstruction demolished.

To this end, the Government direct all Executive Authorities of the concerned local bodies to issue instructions to the Town-Planning and Building staff in the matter. The letter should be definitely told that prompt detection of unauthorized construction or reconstruction is their sole responsibility and that evidence of any slackness on their part would be severely dealt with. The Executive Authorities are informed that they can make use of the services of the other outdoor staff also for the purpose and may issue suitable instructions to them to report cases of unauthorized construction or reconstruction noticed by them in the course of their rounds. They are also informed that whenever a case of unauthorized construction or reconstruction is reported to them by these staffs they should take prompt action to stop further construction and to demolish the construction already made."

The Inspector of Municipal Councils and Local Boards was requested to bring the above orders to the notice of the panchayats to which areas the Town-Planning Act and the building provisions of the Madras District Municipalities Act have been extended or are proposed to be extended in future.

46. *Building regulation and exemption appeals under rule 15 of the Building Rules.*—This branch of administration of the department received a large increase of work during the year. As many as 3,400 currents were received in this branch during the year including a large number of appeals for exemption from the operation of one or other of the building rules. Nine hundred and sixty-eight appeals were disposed of during the year. Exemption was granted in 422 cases with or without conditions and was refused in 546 cases. Appendix VIII gives the number of exemption appeals received from municipal councils and panchayats and the number of cases exempted or refused for the different municipalities of the State. Madurai and Coimbatore topped the list with 247 and 72 cases respectively. There was considerable correspondence of a general nature and in regard to applicability of the rules and these were disposed of promptly.

47. *Closure of pending files relating to building cases in certain towns.*—The Coimbatore Municipal Council reported to Government that there were as many as 360 building application files which had accumulated in the Town-Planning section from 1945 onwards and that in most cases action could not be taken in time and as difficulties were experienced in closing the pending cases for various reasons and requested Government to exempt all these cases and to permit the council to close the files. The Government permitted the Municipal Council to close the cases by issuing formal orders of permission in cases where permission had not been granted, after collecting fees if necessary and plans of the unauthorized constructions be kept in files for further reference. The Commissioner was also informed that prompt and effective action on all unauthorized construction either in Town-Planning Scheme area or non-Town-Planning area of the municipality should be taken hereafter.

The Commissioner, Bhimavaram Municipality, sought the permission of the Director of Town-Planning to close 29 building cases, as no action could be taken by the municipality, as most of them had come up in panchayat days. The Commissioner was permitted to close the files after issuing licences and getting plans of the constructions from the parties concerned.

48. *Agitation of certain councils for relaxation of rules.*—There was some agitation by certain municipal councils against the enforcement of rule 9 (2) (a) of the Building Rules. The Mayuram Municipal Council requested Government to amend the Building Rules so as to allow the construction of buildings in small sites abutting on streets without leaving four feet space on the side of buildings, since great hardship is experienced in complying with rules in force. Certain other municipal councils supported this view. The Government after detailed examination of the question considered that complying with the request of the councils will amount to according a general exemption from rule 9 (2) (a) in respect of small sites abutting on streets and that such exemption was not desirable or even necessary, and declined to do so. The Government invited their attention to G.O. No. 1443, Health, dated 25th April 1950, and requested them to enforce the Building Rules strictly in the interests of the future progress of town-planning on well-organized lines and to refer cases of real hardship to the Director of Town-Planning for orders.

The Kurnool Municipal Council requested Government to grant general permission to relax rule 9 (2) (a) of the Building Rules in respect of latrines other than flushout latrines in the front open space. The proposal was not approved by the Government.

49. *Powers of a municipal council and Executive Authority in the matter of enforcement of Building Rules and demolition.*—In the issue of the *Madurai Municipal Gazette*, dated 15th September 1951, a leading article appeared on the subject 'Demolition' of unauthorized constructions explaining the powers of an Executive Authority vis-a-vis the powers of a municipal council in the matter of regulating and controlling unauthorized constructions and their demolition. The department observed that the leading article would be useful to all members of the town-planning staff of all municipalities and to all Executive Authorities thereof and with the permission of the Editor of the *Municipal Gazette* (Commissioner) the detailed note of the Commissioner, Madurai Municipality, was circulated to all Executive Authorities of Municipal Councils and Panchayats and to all members of the town-planning staff for information and guidance.

50. *Unauthorized constructions—Acquittal by Court.*—The Commissioner, Fort Cochin Municipality, reported that when a party was prosecuted for an unauthorized reconstruction, the Magistrate acquitted the accused finding him not guilty under section 245 (1), Criminal Procedure Code, and he requested instructions of Government. The Government held that notwithstanding the acquittal in the case, it is open to the Commissioner to take action for demolition in accordance with section 339 of the Madras District Municipalities Act.

51. *Extension of rule 5 (3) of Building Rules (re: religious buildings) to Panchayats in Malabar District.*—Government have ordered that it will be sufficient to enforce rule 5 (3) of the Building Rules amended in G.O. No. 890, P.H., dated 19th March 1951, in the non-municipal areas of the district of Malabar to which the building regulations of the Madras District Municipalities Act or the Building Rules have not been extended and they requested the Inspector of Municipal Councils and Local Boards to take necessary steps to extend rule 5 (3) of the Building Rules to all Panchayats in the Malabar district in which the Building Rules are not in force.

52. *Building Code—Corporation of Madras.*—The draft Building Code prepared by the special committee appointed by Government which was forwarded to the Corporation by the Government was received back from the Corporation Council. The draft code was examined in detail by the department and comprehensive suggestions made for co-ordinating the provisions of the code with existing provisions of the City Municipal Act. Wherever necessary amendments to the City Municipal Act were recommended to Government. The Building Code is believed to constitute a very positive measure towards control and regulation of all building activities and building development in cities in a manner compatible with safety, health and environmental conditions. It has been recommended to Government that the draft code prepared by the Corporation

scheme so far made for rehabilitation in the project. If benefits of planning are to be derived in full, it is necessary that the authorities responsible for the execution of the scheme adhere to the plan strictly. It is hoped that this model village would constitute an important landmark in the history of the rural development in the State.

61. *Araku Colony Township.*—The plan for a township previously prepared for this colony was intended for a settlement of the hill tribes in the area. It has now been proposed to convert the area into a hill station and holiday resort for the civilian population. The township was being replanned for this purpose.

62. *Housing of Harijans and other employees of local bodies.*—Government G.O. No. 1316, L.A., dated 21st June 1952, pointed out to Municipal Councils that the housing of Harijans and labourers in their employ is purely the responsibility of local boards and Municipal Councils, including the Corporation of Madras and that the local bodies should take early steps to provide houses for the labourers to the extent to which their finances permit and that Government will be prepared, subject to availability of funds, to consider on merits application from local bodies for loans or subsidies for undertaking schemes for the construction of houses for their workers. The following proposals were examined and layout and designs furnished during the year:—

In Rajahmundry Municipality in the Brodipeta Town-Planning Area wherein there were 247 resident families and about 294 encroachments in Government and municipal lands the Municipal Council, Rajahmundry, acquired about 24 acres of land at a cost of Rs. 1,37,262. A detailed design to house 219 families in the existing Peta itself which was damaged by fire and to house 387 families in the acquired area including reconstitution of sites was prepared and furnished to the municipality.

63. *Housing for industrial workers and type designs of houses.*—A revised layout plan furnished by the department for the Mettur Industries Housing Scheme for operatives was adopted by the company.

A scheme for industrial (quarry) labour for provision of 2,000 houses by the India Cements, Limited, at Talayuttu involving the acquisition of 300 acres of land was examined by the department. The department considered that a township should eventually develop in the area and suggested that the acquisition should be restricted to within a suggested limit. This was accepted and the preparation of a comprehensive housing scheme for the area was under consideration with the Department.

64. *Municipal building schemes.*—This activity increased considerably during the year, as more and more amenities were being thought of by the municipalities and local bodies.

The department supplied in all 68 designs and layouts for 68 items during the year. A list of the designs and the municipalities to which they were furnished is given in Appendix XI.

65. *Playgrounds and parks.*—Layouts for parks and recreation grounds were furnished to Bellary, Chidambaram and Anakapalle Municipal Councils.

66. *Orderly development of canal bank lands in Vijayavada, Tenali, etc.*—The plans and layouts drawn by the Joint Director of Town-Planning and approved by the Special Committee for Vijayavada were under consideration by the Public Works Department.

In regard to the canal margins at Tenali detailed plans of the Nizampeta canal right bank, received in the department from the Executive Engineer were under examination by the department.

CHAPTER V.

INDUSTRIAL CONTROL.

67. *Approval of industrial areas in Municipalities and Panchayats.*—There was great improvement in the regulation of industries by Municipalities and Panchayats during the year. Major industries can and should be allowed only in industrial areas declared by local bodies under the provisions of the Madras District Municipalities Act and the Village Panchayat Act.

Proposals for setting apart industrial areas and additional industrial areas were received and approved by the Department in respect of the following towns:—

68. *Permission for installation of electric motors exceeding 15-H.P. and up to 20-H.P. outside industrial areas.*—Under instructions 1 (2) (c) of appendix to G.O. No. 4054, P.H., dated 3rd September 1940, a large number of applications for installations of electric motors exceeding 15-H.P., but not exceeding 20-H.P. were received in the department and 30 such cases were approved during the year.

69. *Licences and permissions—Construction of factories and installation of machinery—Grant by local bodies—Prior consultation with Health Officer and Factory Inspector—Further instructions.*—With reference to certain points raised by the Commissioner, Sivakasi Municipality, in respect of the statutory obligation under section 250 to consult Health Officers and Factory Inspector, the Government issued orders that the approval of the Inspector of Factories is also a condition precedent to the grant of permission under section 250 of the Madras District Municipalities Act. The Government also held that the Commissioner should obtain the approval of the Inspector of Factories before an application for permission is placed before the Municipal Council. The Government saw no objection to the Commissioner placing for formal rejection all applications for establishing factory, workshops, etc., in a notified residential area under the Public Health Act or in a place demarcated for residential purposes in a Town-Planning Scheme published under the Town-Planning Act before the Municipal Council, so that the Municipal Council may be seized of the matter. Government also pointed out that section 144 of the Public Health Act will override the provisions of any other enactment touching on matters of public health and that when there is a repugnancy between those two provisions and when once a residential area had been once notified under section 89 of the Public Health Act, the construction, or establishment of a new factory, workshop, etc., will be absolutely protected under section 92 of the Act. If an application is received for the construction of or establishment of a factory in such an area, the obligation on the part of the Municipal Council to get the approval of the Inspector of Factories and to consult the Health Officer under section 250 of the Madras District Municipalities Act will not arise.

The Government also directed that the above orders will apply *mutatis mutandis* to applications for permissions under section 194 of Madras District Boards Act and under section 92 of the Madras Village Panchayat Act and requested the Inspector of Municipal Councils and Local Boards to bring the order to the notice of Panchayat Boards.

70. *Certificate of approval by Director of Town-Planning under rule 3 (c) of Factories Rules, 1950.*—During the year, the department dealt with 902 applications made to it under rule 3 (c) of the Madras Factories Rules. In many cases the department gave advice to promoters of industry for laying out their factory premises in a convenient and economic manner and the advice given was appreciated by them and accepted. The plans approved related to the different factories, workshops, studios, etc., as noted below:—

CHAPTER VI.

MADRAS PUBLIC HEALTH ACT, 1939.

71. *Notification of residential areas by urban local authorities.*—The setting apart of specified areas in all urban local areas for residential purposes is an obligation placed under section 89 of the Public Health Act. The residential amenity of the citizens needs to be protected and any carelessness or indiscretion in this matter might result in the residential portion of our towns getting spoiled by industrial or trade processes of harmful nature being carried on indiscriminately in their midst. The total number of urban local authorities coming under the provisions of the Public Health Act was 315 at the end of the year.

The Government granted further time for notification of residential areas to the following municipalities:—

Karaikudi—31st December 1951.

Mettupalayam—31st March 1952.

Nandyal—30th June 1952.

Madras—31st March 1952.

72. *Residential areas approved and returned.*—The department approved the proposals for residential areas submitted to it in respect of (1) the Adoni Municipality, (2) the Coimbatore Municipality, (3) the Palayamkottai Municipality (4) the Tanjore Municipality, (5) the Rajahmundry Municipality, (6) the Srirangam Municipality and also the panchayats of (1) Kalyandrug (Anantapur district), (2) Kollegal (Coimbatore district), (3) Kasaragod (South Kanara district), (4) Karkal (South Kanara district), (5) Paramakudi (Ramanathapuram district), (6) Attur (Salem district), (7) Kulittalai (Tiruchirappalli district), (8) Turayur (Tiruchirappalli district) and (9) Vuyyur (Krishna district).

73. *Application for exclusion of area from notified residential areas.*—Several proposals were made by local bodies for exclusion of certain sites from approved residential areas and were examined by the department during the year. Certain exclusions were approved in respect of the following towns:—

(a) *Municipalities.*—(1) Palayamkottai, (2) Madurai, (3) Cuddalore, (4) Periyakulam, (5) Palni, (6) Nellore, (7) Tindivanam, (8) Cannanore and (9) Mangalore.

(b) *Panchayats.*—(1) Sattenapalle, (2) Tiruppattur, (8) Kuniamuthur, (4) Kulittalai, (5) Ponnuru and (6) Ariyalur.

74. After protracted correspondence and consideration by the Director of Public Health and Director of Town-Planning, the Government in G.O. Ms. No. 81, Health, dated 3rd January 1952, approved the proposals of the Sivakasi Municipal Council to cancel the notification made by it for reservation of residential areas in the municipality in 8th June 1942 and to notify the area near the railway station as a residential area and to declare S. Nos. 129 and 130, etc., as industrial areas of the municipality. Government also informed the Commissioner that the cancellation of the 1942 notification regarding residential areas will render the areas neutral, i.e., non-industrial and non-residential, where electric installations up to 20-H.P. can be permitted in accordance with G.O. No. 4054, P.H., dated 3rd September 1940. The Government also informed this department that section 15 of the Madras General Clauses Act, 1891, would permit revision, amendment or variation of any notification issued under section 89 of the Public Health Act.

On a point raised by the Commissioner, Sivakasi Municipality, whether permission should not be granted for the installation in notified residential areas of the machineries exempted by rule in G.O. No. 1938, P.H., dated 29th May 1950, as amended by G.O. No. 811, Health, dated 12th March 1951, and whether instructions 1 to 5 in the appendix to G.O. No. 4054, P.H., dated 3rd September 1940, are not applicable to the said machineries, the Government in their orders in G.O. No. 4488, Health, dated 31st December 1951, pointed out that the appliances and machineries exempted from the operation of Section 250 of Madras District Municipalities Act, 1920, do not offend the provisions contained in section 92 of the Madras District Municipalities Act and therefore permission need not be obtained for the installation of the above appliances and machinery even in notified residential areas and that G.O. No. 4054, P.H., dated 3rd September 1940, is not applicable to the appliances and machinery.

75. *Consultation with District Collectors.*—In G.O. No. 458, Health, dated 18th February 1952, Government informed Executive authorities of Municipal Councils that they should submit their proposals for the declaration of exclusion from or inclusion in, residential or industrial areas and other similar proposals relating to lands and buildings to the Director of Public Health and Director of Town-Planning through the Collector of the district concerned, who will after his remarks on the proposals from all points of view with which he is concerned as Collector and directed that the Director of Public Health and Director of Town-Planning should invariably consult the concerned Collector if a proposal had inadvertently reached them without being sent to the Collector. The Inspector of Municipal Councils and Local Boards was requested to bring the above orders to the notice of all panchayat boards.

CHAPTER VII.

MISCELLANEOUS—TRAINING IN TOWN-PLANNING—PUBLICITY, PROPAGANDA MUNICIPAL ESTABLISHMENT, ETC.

76. *Institution of degree, Licentiate and refresher course in Town and Country Planning.*—To meet the demand for qualified Town-Planners in the country, who can assist the Government and local bodies in the planning and development of urban, residential and industrial areas the All-India Board of Technical Studies in Town-Planning and Architecture recommended a scheme of training in town and reformal planning, by a two-year full-time course open to persons who had passed the three-year All-India Intermediate in Architecture and/or a three-year

part-time course for qualified Architects and Engineers. The above scheme referred by Government of India to the State Government was under examination by the Department.

In the meantime, a proposal to start degree and licentiate courses in Town-Planning in one of the Engineering Colleges of the State as recommended by the Provincial Town-Planning Enquiry Committee was under consideration with the Government.

77. *Study of Architecture*.—A scheme for organizing a course of study in architecture drawn up by the All-India Board of Technical Studies was examined by the department and a report was submitted to the Government. There is at present no School of Architecture in the State and as such the need for one was stressed by the department.

78. *Deputation of candidates for overseas training in Town and Country Planning*.—The Government in G.O. No. 165, Health, dated 17th January 1952, generally approved a scheme for deputing two candidates every year for a period of five years, for higher study in Town and Country Planning in the United Kingdom of two years' duration in each case and ordered that—

(1) a few persons may be deputed abroad to undergo specialized training in Town and Country Planning;

(2) two Engineering Graduates selected from those employed under Government or local bodies may be deputed to undergo training; and

(3) persons so deputed for training may be offered the same terms and conditions as allowed to Government servants deputed by Government in Education Department under the Overseas Scholarship Scheme including taking of an agreement from the candidates to serve the Government or local body on completion of training for a specified minimum number of years.

The department recommended Sri G. Venkataramana Reddy (Junior Town-Planning Expert) and Sri R. Somasundara Rao, Town-Planning Assistant (Senior), for deputation in the year 1952.

In G.O. No. 1045, Health, dated 28th March 1952, Government sanctioned the deputation of Sri R. Somasundara Rao, Town-Planning Assistant (Senior), to the United Kingdom to undergo specialized training in Town-Planning and the matter of deputing Sri Reddy was under consideration with the Government.

In their letter No. 2834, Education, dated 31st October 1951, to the Government of India, the State Government specified the requirements of the State for the years 1952, 1953 and 1954 as follows for the fellowship or scholarship schemes of the United Nations:—

79. *Propaganda and Publicity*.—The Town-Planning Enquiry Committee had recommended to Government that proper publicity or education of Town and Country Planning principles and policies should be undertaken for the public benefit and enlightened public opinion must be created to ensure a successful enforcement of planning regulations and restrictions and planning results.

The Government were furnished by the department with a list of propaganda films which are likely to be of use in propaganda and education in Town-Planning. The Department considered that the creation of a publicity branch in the Department was necessary. The matter was being examined by the Department.

80. *Reorganization—Engineering and Town-Planning Establishment of Municipal Councils*.—In order to overcome certain administrative difficulties and to have parity in treatment and contentment in the Engineering and Town-Planning establishment under Municipal Councils, the Government had announced in

G.O. No. 555, L.A., dated 13th March 1950, their decision to reduce the multiplicity of posts in the Engineering and Town-Planning branches and adopting similar scales of pay for these posts and to place the Town-Planning branch under the Municipal Engineers for administrative control.

The department represented against the proposals and pointed out how the arrangement will prejudicially affect Town-Planning Administration in the State and requested cancellation of the said orders by the Government. The Government re-examined the matter and ordered in G.O. No. 98, L.A., dated 22nd January 1952, the cancellation of G.O. No. 555, L.A., dated 13th March 1950, in this regard and requested the Department to submit proposals for reducing the multiplicity of posts in the Town-Planning branches. The matter was under consideration of the department.

81. *Municipal Town-Planning Establishment—Rules regarding qualification*.—Government were addressed to frame rules prescribing qualifications for District Board Town-Planning staffs under the relevant sections of the Madras District Boards Act and Village Panchayat Act, 1950.

In G.O. No. 2937, Health, dated 26th August 1951, Government confirmed the draft amendment to the rules issued in G.O. No. 2937, Health, dated 24th August 1951, substituting the following paragraph to the second paragraph of the rules:—

“Notwithstanding anything contained in the rule, the Director of Town-Planning may approve the appointment of any person with qualifications other than those specified in this rule to any of the posts if he is satisfied that the qualifications possessed by such person are sufficient or suitable for discharging the duties of the post and provided the period of such appointment does not exceed one year at a time.”

82. *Town-Planning staffs in municipalities*.—Most of the Municipal Councils had engaged Town-Planning staffs. Only 17 Panchayats had so far engaged Town-Planning staff. All the newly constituted municipalities were advised to appoint the necessary Town-Planning staff.

83. *Town-Planning Officers*.—The following municipalities had Town-Planning Officers as heads of Town-Planning Branches:—

The Chingleput District Board employed a Town-Planning Officer of the Senior Grade throughout the year.

Post of Town-Planning Officers were sanctioned by the Inspector of Municipal Councils and Local Boards during the year for the Municipalities of Tiruppur, Anantapur and Kurnool.

Town-Planning Officers were newly appointed in the Municipalities of Anantapur, Tenali, Tanjore and Ootacamund during the year.

The department considers that the engagement of a responsible person as a Town-Planning Officer in Municipalities is necessary for improvement of Town-Planning work. It is also considered necessary that there should be a Town-Planning Officer in every district.

84. *Personal files of Town-Planning Officers.*—The Government in G.O. No. 2924, Health, dated 23rd August 1951, ordered that the personal files of Town-Planning Officers of Municipalities and District Boards should be maintained by the Director of Town-Planning. Government have issued instructions on the manner in which the reports may be maintained.

The Government also ordered in G.O. No. 888, Health, dated 23rd August 1951, that the Town-Planning Officer or Commissioner should maintain and scrutinize personal files of the ministerial and technical staff in the Town-Planning section and issued instructions to the Inspector of Municipal Councils and Local Boards to arrange for the issue of necessary amendment slips to the District Board Office Manual.

85. *Deputation of Municipal Town-Planning staff for Town-Planning Training.*—The training of Municipal Officers in the department was continued till 15th December 1951, and had to be stopped for want of accommodation and facilities in the department. The following officers of municipalities, however, came and underwent the training during the year:—

86. *Transfers of Town-Planning staffs.*—The Town-Planning Officer of Mangalore Municipality was transferred as Town-Planning Officer, Vijayavada and the Town-Planning Officer, Vijayavada, was transferred to Mangalore Municipality by the Inspector of Municipal Councils and Local Boards. Sri M. Satyanarayana, Town-Planning and Building Overseer, Vijayavada Municipality, was transferred and promoted as Town-Planning and Building Supervisor, Masulipatnam Municipality. Sri R. Ramamurthi, Town-Planning and Building Overseer, Tiruchirappalli Municipality, was transferred and promoted as Town-Planning and Building Supervisor at Gobichettipalayam Municipality.

The Corporation of Madras employed one Assistant Engineer for Town-Planning with necessary staff of Supervisors, Surveyors, Draftsmen, etc., and one Assistant Engineer with subordinate technical staff for preparation of Master Plan. The question of appointing an Architect Town-Planner for the City was recommended by the Government.

CHAPTER VIII.

TOWN-PLANNING DEPARTMENT PERSONNEL EXPENDITURE AND ORGANIZATION.

87. *Officers—Provincial—Gazetted.*—(1) Ex-Officio Director of Town-Planning, Sri T. Prabhakararao Naidu, I.A.S., Inspector of Municipal Councils and Local Boards was ex-officio Director of Town-Planning during the year.

(i) *Temporary post of Joint Director of Town-Planning.*—Sri R. D. N. Simham, B.E., M.E. (Hons.), M.T.P.I. (Lon.), who was re-appointed as Joint Director of Town-Planning, for a period of one year from 6th July 1950 retired from service with effect from 5th July 1951 as Joint Director of Town-Planning. The department places on record its deep appreciation of the valuable services rendered by Sri Simham for 27½ years in the department and to the cause of town-planning in the State. Sri C. Govindan Nair, D.P.T.P. JEdin.I., A.M.T.P.I.

(Lon.), Permanent Junior Town-Planning Expert was appointed to act as Joint Director of Town-Planning from 5th July 1951. In G.O. No. 2256, Health, dated 25th June 1951, Government sanctioned the continuance of the post of the Joint Director of Town-Planning up to 30th September 1952.

(ii) *Junior Town-Planning Expert.*—Consequent on the appointment of Sri C. Govindan Nair as Joint Director of Town-Planning, the permanent post of Junior Town-Planning Expert fell vacant from 5th July 1951, and remained vacant till 1st February 1952. The Government appointed Sri G. Venkataramana Reddy, A.R.I.B.A. (Lon.), A.I.I.A., to act as Junior Town-Planning Expert in G.O. Ms. No. 280, Health, dated 28th January 1952. Sri Reddy assumed charge of his duties from 1st February 1952.

(iii) *Permanent post of Town-Planning Expert and Personal Assistant to Director of Town-Planning.*—This post was kept in abeyance and remained as such during the year.

(iv) *Temporary post of Gazetted Town-Planning Assistant.*—Sri S. Subba Ayyar continued as Gazetted Town-Planning Assistant during the year.

88. *Committees.*—Sri T. Prabhakararao Naidu, I.A.S., attended the meetings of the Madras City Improvement Trust as an ex-officio member of the trust.

Sri C. Govindan Nair, Joint Director of Town-Planning gave lectures on Town-Planning to students undergoing the B.S.Sc. course in the Madras Medical College.

89. *Mr. Max Lock, F.R.I.B.A., M.T.P.I.,* an eminent Architect and Town-Planner from the United Kingdom visited Madras in February 1952. Mr. Max Lock delivered a lecture on *Latest developments in Town and Country Planning in England* on the 9th February 1952 at the Rajaji Hall when the Hon'ble Sri Kala Venkata Rao (ex-Minister of Health and Housing) presided. All Municipal Commissioners, Town-Planning Officers and Chief Members of Town-Planning sections of municipalities were permitted to attend the lecture. The lecture was attended also by the Secretary to Government, Health Department, many Heads of Departments and also by most of the Commissioners of municipalities in the State and Town-Planning Officers of the Corporation and municipalities in the State. Simultaneously, a meeting of the Commissioners and Town-Planning staff was held on 10th February 1952 at the Rajaji Hall when the Director of Town-Planning and the Joint Director of Town-Planning addressed them on town-planning matters and discussed with them problems relating to building rules and provisions of the Town-Planning and Madras District Municipalities Acts.

90. *Leave of Officers.*—Sri C. Govindan Nair, Joint Director of Town-Planning proceeded on leave on average pay for ten days from the 10th March 1952. During the said period Sri G. Venkataramana Reddy, Junior Town-Planning Expert was appointed to hold full additional charge of the post of Joint Director of Town-Planning in addition to his own duties. Sri S. Subba Ayyar, Gazetted Town-Planning Assistant was granted leave for 41 days from 21st May 1951 to 30th June 1951. Sri C. Govindan Nair (Junior Town-Planning Expert) was appointed to hold full additional charge of the post of Town-Planning Assistant (Gazetted) in addition to his own post in G.O. Rt. No. 250, Health, dated 21st May 1952. The request of Sri S. Subba Ayyar for grant of leave for four months preparatory to retirement with effect from 15th January 1952 was declined by Government in the interests and requirements of the Public Services (vide G.O. Ms. No. 318, Health, dated 30th January 1952).

91. *Tour of Officers.*—Sri R. D. N. Simham, Joint Director of Town-Planning was on tour on three occasions for about 22 days and inspected seven towns. Sri C. Govindan Nair, Junior Town-Planning Expert was on two tours for eight days, and inspected six towns. Sri C. Govindan Nair, Joint Director of Town-Planning was on eight tours for 36 days and inspected 19 towns. Sri S. Subba Ayyar (Gazetted) Town-Planning Assistant, was on tour for 76 days, on 16 occasions and inspected 41 towns. He also attended the meetings of the Mettur township site allotment special committee as a representative of the Department.

ANNUAL REPORT ON THE ADMINISTRATION OF TOWN-PLANNING IN MADRAS STATE

92. *Subordinate technical and ministerial staff.*—In G.O. No. 2826, Health, dated 13th August 1951, the following temporary staff was sanctioned by the Government till 30th December 1952.

- One Town-Planning Assistant (Junior).
- Two Draftsmen, Grade II.
- One Tracer.
- One Upper Division Clerk.
- Two Lower Division Clerks.
- One Typist.
- Four Peons.

A post of one Junior Superintendent and one upper division clerk were sanctioned in G.O. Ms. No. 4088, Health, dated 29th November 1951 till 30th November 1952 and 3rd March 1952, respectively.

Sri R. Somasundara Rao, Senior Town-Planning Assistant was on tour on ten occasions for 54 days and inspected 27 towns. Sri C. Chakrapani Naidu, Junior Town-Planning Assistant, was on tour on four occasions for 18 days and inspected 11 towns. The matter of filling up of the post of Additional Junior Town-Planning Assistant was under correspondence with Government.

93. *Office location.*—The office continued to be located in the southern wing of the first floor of the Old High Court Buildings, First Line Beach Road. Accommodation was poor and the atmosphere was incongenial for office use, owing to grain storages in the ground floor of this wing of the building. It is necessary to have separate accommodation provided for the department.

94. *Blue Printing Work.*—About 2,710 blue-print copies of scheme maps, layouts, designs for buildings, etc., were taken during the year. An amount of Rs. 205-12-0 was realized by the sale of copies of certain maps. The amount realized was credited by the concerned bodies in the local treasuries to the credit of cash under the head XXVIII. Public Health—Miscellaneous—Other items—Cost of plans.

95. *Expenditure of the department in 1951-52.*—The total expenditure of the department during the year 1951-52 was Rs. 65,664-11-8 as against Rs. 56,636 during the previous year.

Town-Planning—Administration Report for 1951-52—Reviewed.

2. By the end of 1951-52 the provisions of the Madras Town-Planning Act, 1920, were in force in 99 municipalities including the Corporation of Madras and 341 panchayats.

3. *General town-planning schemes.*—The Government desire that the municipalities and panchayats which have not so far taken up the preparation of general Town-Planning Schemes should take up the work at an early date.

4. *Detailed town-planning schemes.*—Up to the end of the year under review, 77 out of 99 municipal councils including the Corporation of Madras had taken up formulation of detailed town-planning schemes. At the end of the year there were in all 374 detailed town-planning schemes under various stages of preparation, publication and submission to the Government. Of these, 118 sanctioned schemes were in various stages of execution by the local authorities.

During the year under review, 4 new schemes were notified under section 12 of the Madras Town-Planning Act.

The progress made in regard to execution of town-planning schemes was generally good.

5. *Town-planning funds.*—Some municipal councils had not constituted Town-Planning Funds as required by section 30 of the Madras Town-Planning Act. It is necessary that all such municipal councils establish the fund soon.

6. *Housing.*—Co-operative housing continued to be the main feature of housing in the State during the year. Several new co-operative housing and house building societies were registered. The Town-Planning Department furnished layout designs in respect of 41 urban co-operative housing or house building societies and 8 rural co-operative house building societies during the year. Two hundred and thirty-eight type designs for houses were furnished to these societies.

The Department also furnished 377 designs and layouts for colonization schemes of the Harijan Welfare and Revenue Departments.

For the rehabilitation of families displaced from the submerged villages of the Tungabhadra Reservoir, 8 new colonies and townships were designed by the

The Department also furnished designs for the housing of other special like industrial workers, municipal employees, etc.

7. *Industrial and residential areas.*—There was an improvement in the regulation of industrial areas by municipalities and panchayats. Satisfactory progress was also made in setting apart and declaration of residential areas.

8. *Building*.—With the appointment of town-planning and building inspection staff by the municipal councils, enforcement of building rules was effective during the period.

Nine hundred and sixty-eight appeals for exemption from the operation of building rules were disposed of. Exemption was granted in 422 cases.

The provisions of Chapters IX and X of the Madras District Municipalities Act, 1920, together with certain other relevant sections were extended to 13 panchayats and 26 villages, thus bringing the total number of panchayats and villages to which the provisions had been applied to 306, as against 267 in the previous year.

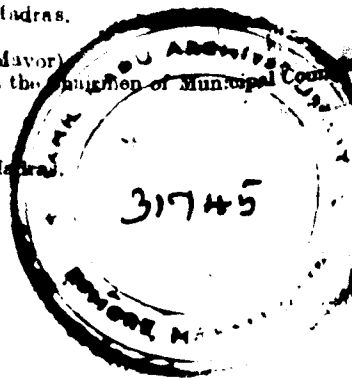
9. *Technical assistance to Government departments.*—The Town-Planning Commission continued to give technical advice to the other departments of the Government and local bodies also.

10. *General.*—During the year under review there was an all-round increase in activity in the Town-Planning Department. The working of the Department was good. The local authorities evinced keen interest in all matters relating to planning and building control.
