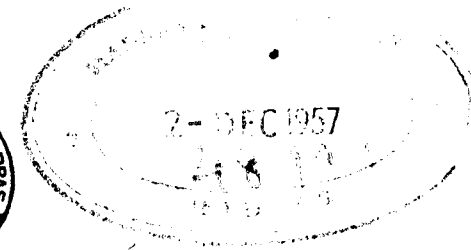

Part I.

REPORT ON THE WORKING OF THE INDUSTRIAL DISPUTES ACT, 1947
(CENTRAL ACT XIV OF 1947), FOR THE PERIOD 1st JANUARY TO 31st
OCTOBER 1956.

I. *Personnel*.—Sri V. Balasundram, I.A.S., continued to be the Commissioner of Labour, Commissioner for Workmen's Compensation, Registrar of Trade Unions and Certifying Officer, under the Industrial Employment (Standing Orders) Act of 1946 during the period 1st January to 31st October 1956.

The Commissioner of Labour as the Chief Conciliation Officer under the Industrial Disputes Act, 1947, for the entire State of Madras was assisted in his work by the Assistant Commissioner of Labour, the Personal Assistant to the Commissioner of Labour and 11 Labour Officers, all of whom have been appointed as Conciliation Officers under the Industrial Disputes Act of 1947.

Sri K. Srinivasan, B.A., and Sri K. V. Parthasarathy, M.A., B.L., continued to be the Assistant Commissioner of Labour and the Personal Assistant to the Commissioner of Labour respectively during the period.

Sri M. Akilandam Pillai and Sri K. N. Radhakrishna Mudaliar continued to be the Industrial Tribunals, Madras and Coimbatore up to 27th February 1956 and 30th May 1956 respectively. Sri V. Pattabhiramayah and Sri M. V. Harihara Ayyar who succeeded them continued to be the Industrial Tribunals, Madras and Coimbatore, from 28th February 1956 and 30th May 1956 respectively.

Sri P. Kanda Narasimha Chettiar continued to be the Special Industrial Tribunal for Plantations up to 20th October 1956, when Sri M. V. Harihara Ayyar succeeded him.

Sri K. N. Radhakrishna Mudaliar who was appointed as the Special Industrial Tribunal, Madurai, in G.O. Ms. No. 2204, Industries, Labour and Co-operation, dated 30th May 1956, for the adjudication of disputes relating to wages and revision of workload in the Madura Mills Company, Limited, Madurai, Tuticorin and Ambasamudram, assumed charge on 12th June 1956 forenoon.

II. *Labour policy and changes in Labour Legislation during the year 1956*.—Labour occupies an important position in the life of a nation and no scheme for raising the general standard of living can be successful without the active co-operation and help of labour. To enable labour to put forth its best, special laws have been enacted to ensure adequate working and living conditions for them. With the advent of independence, labour welfare has become the most important and essential part of social services and it has been given its due place in the directive principles of the constitution. The need for a harmonious relationship between Capital and Labour is now being fully realized by the State, the workers and the employers.

In the labour policy adopted for the period of the First Five-Year Plan, greater emphasis was placed on the effective administration of existing labour laws. For the settlement of disputes joint consultation at different levels was proposed. Improvement in the real wages of the working class, implementation of social security schemes and improvement in working conditions in factories, plantations and mines were envisaged. The Labour Policy and the approach to industrial relations outlined in the First Five-Year Plan will also hold good for the period of the Second Five-Year plan. The objectives of the Second Plan are the strengthening of the trade union movement, granting them representative character, promotion of leadership from within and the training of workers in trade union philosophy and methods, settlement of disputes through mutual negotiations, conciliation and voluntary arbitration, effective implementation and enforcement of awards, increased association of labour with management, prevention of tendencies to violence and indiscipline, a progressive wage policy with a view to accelerating progress towards fair wages, extension of the Provident Fund and Employees' State Insurance Schemes, enhancement of the rate of contribution to Provident Fund and regulation of that schemes of rationalisation should be preceded by agreements between the parties and that the responsibilities of providing additional employment to agricultural workers and the problems peculiar to women workers should receive adequate attention. Greater emphasis has also been laid on the problem of providing housing facilities to the industrial workers.

Industrial housing.—Both the Central and the State Governments are specially interested in Industrial Housing. The scheme for the construction of 936 tenements in

Sembiam and Erukkancherry which the State Government have undertaken with assistance from the Centre has made substantial progress. A provision of Rs. 55.10 lakhs has been made in the Second Five-Year Plan for construction of houses for private industrial workers in this State under the Subsidised Industrial Housing Scheme and it has been decided that the provision should be utilized for schemes to be undertaken by the Government. Many of the employers have come forward to donate lands for the construction of houses for their workers and a priority list of such lands on which construction can be undertaken has been drawn up and approved by the Government. The officers of the Public Works and Town-Planning Departments have already inspected some of the lands and proposals for construction of houses at Madras, Sivakasi (Ramanathapuram district) and Vellalur (Tiruchirappalli district) have been submitted to the Government.

The Government of India have also provided a sum of Rs. 3.34 lakhs for housing plantation labour during the period of the Second Five-Year Plan. It is obligatory on the part of every employer in plantations to provide and maintain for every worker necessary housing accommodation and the Madras Plantation Labour Rules require the employers to build houses for accommodating at least 8 per cent of their resident workers every year. The provision made in the Second Five-Year Plan is to assist such of the employers as are not in a position to construct houses with their own resources in complying with the above statutory requirement. The Inspectors of Plantations and the Association of Planters have been advised to give wide publicity to the scheme. The Government have also constituted an Advisory Board for consultation in regard to matters relating to housing as required in the Plantation Labour Rules.

Changes in the Labour Legislation during the period 1st January to 31st October 1956.—The Industrial Disputes (Amendment and Miscellaneous Provisions) Act of 1956, amending the Industrial Disputes Act of 1947 which was one of the major changes in the labour legislation during the year 1956 received the assent of the President of India on 28th August 1956. It provides for the abolition of Labour Appellate Tribunals, the constitution of labour courts, Industrial Tribunals and National Tribunals and for the appointment of Assessors, to help the Industrial Tribunals and National Tribunals. Voluntary reference of disputes to arbitration has also been specifically provided for in the Act. The definition of the term "Workman" has been widened to include supervisory staff also. The definition of the term "Award" has been widened to include an arbitration award by an arbitrator under section 10-A and the definition of the term "Settlement" enlarged to include a settlement arrived at even outside the course of conciliation proceedings. The conciliation officers have been empowered to compel the production of documents connected with the dispute, whenever they consider it necessary. Any breach of settlement or an award has been made punishable under the new Act with imprisonment or fine or both, no distinction being made between first or subsequent convictions. Under the new Act the employers are prohibited from changing the conditions of service of workmen in respect of certain specified matters without giving previous notice or within 21 days of giving such notice.

The legal position regarding the payment of compensation in case of retrenchment of workmen has been clarified by the addition of a new provision 25-FF. According to this provision, no workman shall be entitled to compensation merely on account of change of ownership or transfer in ownership or management of an undertaking if (a) the service of the workman has not been interrupted by reason, (b) the terms and conditions of service applicable to the workman after such transfer are not in any way less favourable to the workman than those applicable to him immediately before the transfer; and (c) the employer to whom the ownership or management of the undertaking is so transferred is, under the terms of the transfer or otherwise, legally liable to pay to the workman, in the event of his retrenchment, compensation on the basis that his service has been continuous and has not been interrupted by the transfer.

Payment of compensation for period of lay off in excess of 45 days in the absence of a contract to the contrary between the employer and the employees has also been provided by another amendment.

Among the amendments to the Madras Industrial Disputes Rules, 1948, introduced during 1956, may be mentioned the addition of the new rules 31, 32 and 33 prescribing therein the procedure to be followed in the matter of retrenchment and re-employment of such retrenched workman.

The provisions of the Industrial Disputes Act were made applicable to the working journalists by the Working Journalists (Conditions of Service) and Miscellaneous Provisions Act, 1955. The Officers of the Labour Department have been appointed as Conciliation Officers under the Act for the areas within their respective jurisdiction.

The Labour Officers, Tiruchirappalli, Coimbatore and Tirunelveli, have also been appointed as Conciliation Officers in respect of disputes arising in the quarrying industry within their jurisdiction for a period of one year from 3rd January 1956.

The question as to how the full benefits of the Industrial Disputes Act can be extended to the workers in the beedi industry is also being examined in the light of the recommendations of the Special Officer appointed to enquire into the conditions of workers in the beedi industry.

III. *Industrial disputes*.—The Conciliation machinery set up under the Industrial Disputes Act has been striving hard to bring about settlements of industrial disputes and to promote industrial peace. From 1st January to 31st October 1956, 7,703 complaints under the Industrial Disputes Act were investigated by the officers of the Labour Department in the State of Madras. Of these, 1,869 related to demands for re-instatement of discharged workers, 1,120 to increase in the rates of wages, 660 to bonus and 64 to dearness allowance. There were also 231 complaints relating to leave facilities, 448 complaints relating to service conditions, 20 complaints regarding food supplies and 3,291 miscellaneous complaints. The statement showing the details is appended (Annexure I).

IV. *Strikes and lockouts*.—There were 288 strikes and lockouts during the period under report in the various industries, including those falling under the Central sphere, as detailed below :—

The 288 stoppages of work resulted in a loss of 421,313 mandays and Rs. 9,65,456 in wages. Among the main causes for these strikes were the demand for reinstatement of discharged workers, increase in wages, bonus, enhanced dearness allowance and better service conditions. Ninety-five out of the 288 strikes were resolved by the intervention of the officers of the Labour Department. In 165 cases (97 cases relating to the Central sphere), the workers voluntarily resumed work and agreements were reached between the parties by direct negotiation in 24 cases. In one case the Government referred the dispute for adjudication and prohibited the continuance of the strike. There were two strikes in progress at the end of the period in Gnanambikai Mills, Limited, and Kothari Textiles, Limited. The lockout in the Nanco Rubber and Plastics, Limited, Coimbatore, also continued. Details about the various industries in which there were strikes number of workers involved and mandays lost, etc., are given in the statements appended (Annexures II and III).

V. *Industrial disputes referred for adjudication*.—During the period under report, 148 disputes were referred to the Industrial Tribunals for adjudication. (See Annexure IV.)

Awards relating to 274 cases were published during the same period out of which 124 were decisions of the Industrial Tribunals on the applications filed by the workers under section 33-A of the Industrial Disputes Act (see Annexure V).

One hundred and forty decisions and orders of the Labour Appellate Tribunal of India on appeals against the awards of the Industrial Tribunals and applications filed by the employers and employees were published in the Supplement to Part I of the *Fort St. George Gazette*, during the period under report (see Annexure VI).

Seventy-seven decisions and awards of the Central Government Industrial Tribunal, Madras, on the applications filed by the employees under section 23 of the Industrial Disputes (Appellate Tribunal) Act, 1950, were also published in the Supplement to Part I of the *Fort St. George Gazette*, during the period under report (see Annexure VII.)

VI. *Important disputes during the period 1st January to 31st October 1956*.—*Buckingham and Carnatic Mills, Madras*.—Justice Sri K. Ramaswami Gounder, Judge of the Madras High Court, who was appointed as the Arbitrator to enquire into the dispute between the workers and the management of the Buckingham and Carnatic Mills, relating to increased basic wages, dearness allowances, etc., had not concluded, his enquiry by 31st October 1956.

Three thousand two hundred and two workers of the Buckingham and Carnatic Mills, Madras, struck work on 1st September 1956 as a protest against the proposed introduction of three shifts in some sections of the Mills without the prior written permission of the Chief Inspector of Factories. The strike was called off on the mediation of the Commissioner of Labour, Madras.

Messrs. Burmah-Shell Oil Storage and Distributing Company of India, Limited, Madras.—The workers of the Burmah-Shell Oil Storage and Distributing Company of India, Limited, Madras, numbering about one thousand and fifty went on strike on 20th March 1956 as a protest against the refusal of the management to concede their demand for payment of six months' wages as bonus for the year 1955. The dispute was referred to the Special Industrial Tribunal, Madras, Sri V. Pattabiramaiah, for adjudication, on 20th March 1956 and the workers resumed work the next day. The Industrial Tribunal in its award published in G.O. No. 3984, Industries, Labour and Co-operation, dated 7th September 1956, has rejected the claims of the workers for payment of additional bonus over the four months bonus offered and paid by the management.

T.I. Cycles of India, Limited, Ambattur, Madras.—The workers of the T.I. Cycles of India, Limited, Ambattur, went on strike from the 12th January 1956. As the strike continued despite the advice of the management asking the workers to resume work, they dismissed all the workers and recruited a new labour in February 1956. At a later stage, on the motion of the Union and on the advice of the Commissioner of Labour, the management agreed to recruit 350 to 400 old workmen. The other demands relating to the payment of dearness allowance, annual bonus, etc., were also discussed and a settlement was signed by the parties before the Commissioner of Labour on 28th July 1956, which was to be in force for a period of three years.

Textile mills in Coimbatore district.—The Textile Unions in the State were agitating from the year 1955 for the implementation of the recommendations of the T.T.E.C. As the recommendations could not be legally enforced, the Unions were advised to seek relief under the Industrial Disputes Act. The Coimbatore District Textile Workers' Union, and the Mill Workers' Union, Coimbatore, representing about 22,000 textile mill workers in the Coimbatore district, accordingly presented a charter of demands. The demands related to classification of workers, fixation of workload, wages, dearness allowance, leave facilities, festival holidays, bonus, etc. On several occasions, the parties to the dispute had discussions with the Minister for Agriculture and also the Commissioner of Labour with a view to arriving at an amicable settlement of the dispute. The Commissioner of Labour finally met the parties to the dispute at Coimbatore on the 23rd, 24th and 25th September 1956 and after prolonged discussions with them, brought about a settlement of the dispute, which was to be in force for a period of five years from 1st October 1956. The agreement among other things provided for a minimum basic wage of Rs. 30-1-0 per mensem, fixed the workloads and duties of workers in several departments and also provided for a machinery for the settlement of disputes arising between the parties. It also gave the option to either of the parties to seek a revision of the agreement after three years by giving three months' notice.

Dispute relating to the payment of bonus for 1955-56 to the workers of Textile mills in Coimbatore district.—Following the settlement of bonus dispute for 1954-55 by arbitration the dispute regarding bonus for 1955-56 was referred to an Arbitration Board consisting of the representatives of the Mill Owners' Association and the three textile workers' unions with Sri S. Ganapathia Pillai, District Judge, Coimbatore, as the Chairman of the Board. The dispute regarding bonus for the year 1955-56 in the Vijayakumar Mills, Limited, Palni, Rajendra Mills, Limited, Salem and Jawahar Mills, Salem, was also referred to the same Arbitration Board. The Arbitrator gave his decision in the matter on 20th October 1956 and it was implemented by the mills.

Messrs. Nanco Rubber and Plastics, Limited, Coimbatore.—Thirty-four workers of the V.B. Hose Section of the Nanco Rubber and Plastics, Limited, Coimbatore, suddenly struck work on 10th July 1956 as a result of which, the management notified closure of that section. The workers of the other sections struck work on 3rd August 1956, as a protest against the above action of the management. As the strike continued and as the management found no prospect of the workers returning to work, they declared a lock-out of the factory on 4th October 1956 which continued till the end of the month.

Messrs. Madurai Mills Company, Limited, Madurai, Tuticorin and Ambasamudram.—The Papanasam Labour Union, Vikramasingapuram, the Vikramasingapuram Textile Workers' Union, Vikramasingapuram, the Madurai Mill Labour Union, the Madurai Textile Workers' Union, Madurai, and the Tuticorin Mill Labourers' Union, Tuticorin, issued notices of strike in May 1956, on behalf of the workers of the Mills at Madurai, Tuticorin and Ambasamudram demanding six months' basic wages as bonus for the year 1955, increased basic wages, increased dearness allowances, at four annas per point over 100 on the cost of living index number, annual increments, workload, eleven festival holidays with wages and permanency of workers who have put in more than one year of service. The demands relating to workload and basic wages were referred for adjudication to Sri K. N. Radhakrishna Mudaliar, B.A., B.L., who was appointed as the Special Industrial Tribunal, Madurai.

One hundred and seventy-two workers (Doffers, Yarn Carriers and other workers of the Bundling Department) of the Madura Mills Company, Limited, Madurai, struck work from 1 p.m. to 4 p.m. on 4th June 1956 protesting against the allocation of work. Again on 5th June 1956 one hundred and ninety-six workers struck work from 12-15 p.m. to 4 p.m. for the same reason. As there was no improvement in the situation the management closed mills on 7th June 1956 stating that they were prepared to consider the re-opening of the mills, if satisfactory assurances for a normal resumption of work were forthcoming from the workers. The lock-out was lifted on 11th June 1956 on the intervention of the Commissioner of Labour, Madras.

Two thousand seventy-eight workers of the Madura Mills Company, Limited, Tuticorin, struck work on 11th February 1956, as a protest against the suspension of a shafting oiler for his refusal to wear shorts while on duty. The management declared a lock-out, as the workers refused to resume work unless the suspension order was cancelled. The lock-out was lifted on the advice of the Commissioner of Labour, Madras, and the workers resumed work on 21st February 1956.

VII. *Strikes and lock-outs declared illegal during the period 1st January to 31st October 1956.*—No strike or lock-out was declared illegal during the period under report.

VIII. *Prosecutions under section 29 of the Industrial Disputes Act, 1947.*—Of the four prosecutions for breach of awards under section 29 of the Industrial Disputes Act, 1947, which were pending at the end of 1955, the managements were convicted and fined in three cases, and one case was pending. During the period under report, prosecutions were sanctioned against the managements of six industrial concerns for non-implementation of awards of the Industrial Tribunals and settlements before the Conciliation officers. Convictions were obtained in 2 cases and 1 case ended in acquittal. The other three cases were pending disposal on 31st October 1956. Details are given in Annexure VIII.

IX. *Important meetings and conferences.*—The Commissioner of Labour, Madras, attended the following conferences and meetings during the period 1st January to 31st October 1956 :—

(1) The meeting of the Heads of Departments held at the Secretariat on 9th January 1956 to discuss the draft memorandum on the Second Five-Year Plan sent by the Planning Commission.

(2) The first meeting of the Madras Regional Board of the Employees' State Insurance Corporation held at the Secretariat on 21st January 1956.

(3) The first meeting of the Madras Regional Committee of the Employees' Provident Fund scheme held at Madras on 30th January 1956.

(4) The meeting of the State Metric Committee held at the Secretariat on 30th January 1956.

(5) The Seventh Session of the Central Board of Trustees of the Employees' Provident Fund held at New Delhi, on 27th February 1956.

(6) The meeting of the Fifteenth Session of the Standing Labour Committee held at New Delhi on the 4th and 5th April 1956.

(7) The meeting of the Employees' State Insurance Corporation held on 14th July 1956 at New Delhi.

(8) The second meeting of the Regional Board of the Employees' State Insurance Corporation, held at Madurai, on 27th October 1956.

(9) *Conference of the Labour Officers and Inspectors of Factories.*—With a view to improving the standards of administration of the various labour enactments, the Government have been sanctioning periodical departmental conferences so that the officers can benefit by exchange of views. A conference of the Labour Officers and the Inspectors of Factories, which was inaugurated by Sri M. Bhaktavatsalam, Minister for Agriculture, was held at Madras from 17th to 19th May 1956. Among the important subjects discussed at the conferences were the need for compilation of statistical particulars regarding the scope of employment, wages and allowances, leave and other privileges in each establishment by the Labour Officers, the procedure to be followed in the matter of complaints, individual and Industrial disputes, disposal of claim petitions for recoveries of moneys, the need for amendment of the Industrial Disputes Act providing for recovery of moneys due under a settlement before a Conciliation Officer and for extension of the period of operation of settlement.

X. *State Labour Advisory Board.*—The State Labour Advisory Board met twice during the year, i.e., 17th February 1956 and 10th October 1956. Both the meetings were presided over by the State Labour Minister, Sri M. Bhaktavatsalam, B.A., B.L., Among the important subjects discussed at the meetings were the draft Madras Recog-

nition of Trade Unions Bill and the provision of adequate housing facilities for industrial workers. The standardization of the number of festivals holidays to be granted to the workers in the industrial establishments, the need for amending the provisions relating to working hours under the Factories Act, exemption from payment of court-fees on applications presented to the Labour Department, extension of the provident fund facilities to the workers in plantations and motor transport services and payment of gratuity to the Industrial workers were some of the other subjects which were discussed at the meetings.

XI. *Public utility services.*—The following industries have been declared as public utility services under the Industrial Disputes Act, 1947 :—

- (1) Sugar Industry.
- (2) Salt Industry.
- (3) Motor Transport Services and Cotton Textile Industries.
- (4) Anamallais Ropeway Company, Limited, Attakatti post.
- (5) All labour in Minor Ports.
- (6) Air Transport Services in the State of Madras.

XII. *Works committee.*—Five hundred and forty-three works committees were functioning in the State of Madras at the beginning of the year and works committees were constituted in 14 industrial establishments during the period ending 31st October 1956. The total number of works committees functioning in this State on 31st October 1956 was 557. (Details of newly formed works committees are given in Annexure IX.)

Part II.

REPORT ON THE WORKING OF THE INDUSTRIAL DISPUTES ACT, 1947
(CENTRAL ACT XIV), FOR THE PERIOD 1st NOVEMBER TO 31st
DECEMBER 1956.

I. *Personnel*.—Sri V. Balasundram, I.A.S., continued to be the Commissioner of Labour, Commissioner for Workmen's Compensation, Registrar of Trade Unions and Certifying Officer under the Industrial Employment (Standing Orders) Act of 1946 during the period 1st November to 31st December 1956.

Sri K. Srinivasan, B.A., continued to be the Assistant Commissioner of Labour during the period under review.

Sri K. V. Parthasarathy, M.A., B.L., continued to be the Personal Assistant to the Commissioner of Labour up to 8th December 1956. Sri K. Srinivasan, B.A., Assistant Commissioner of Labour was placed in full additional charge of this post from 9th December 1956 till the end of the year.

Two of the Labour Officers were allotted to the Kerala and Mysore States with effect from 1st November 1956, consequent on the reorganization of States. In G.O. Ms. No. 4875, Industries, Labour and Co-operation, dated 16th November 1956, the Government sanctioned an additional post of Labour Officer, Grade III, for the Kanyakumari district.

The Commissioner of Labour was also appointed as the Conciliation Officer under the Industrial Disputes Act, the Commissioner for Workmen's Compensation under the Workmen's Compensation Act, Registrar of Trade Unions, under the Indian Trade Unions Act, the Certifying Officer, under the Industrial Employment (Standing Orders) Act, 1946, and the authority to decide questions and relating to the applicability of the Travancore-Cochin Shops and Establishments Act to particular classes of establishments or persons in respect of the transferred area from 1st November 1956.

The Assistant Commissioner of Labour and the Personal Assistant to the Commissioner of Labour were appointed as Conciliation Officers under the Industrial Disputes Act and additional Commissioners for Workmen's Compensation under the Workmen's Compensation Act in respect of the transferred area from 1st November 1956. The Assistant Commissioner of Labour was also appointed as the authority under the Payment of Wages Act in respect of that area.

II. *Industrial disputes*.—During the period 1st November to 31st December 1956, 1,472 complaints under the Industrial Disputes Act were investigated by the Officers of the Labour Department in the reorganized State of Madras. Of these, 551 related to the demand for reinstatement of discharged workers, 287 to increase in the rates of wages, 127 to bonus and 8 to dearness allowance. There were also 22 complaints relating to leave facilities, 80 complaints relating to service conditions and 397 miscellaneous complaints. The statement showing the details is appended (Annexure I).

III. *Strikes and lock-outs*.—There were 44 strikes and lock-outs during the period 1st November to 31st December 1956 in the various industries including those falling under the Central sphere as detailed below :—

The 44 stoppages of work resulted in a loss of 86,072 man-days and Rs. 51,201 in wages. Among the main causes of these strikes were the demand for reinstatement of discharged workers, increase in wages and bonus. Eighteen out of 44 strikes were resolved by the intervention of the Officers of the Labour Department. In 19 cases (2 cases relating to the Central sphere) the workers voluntarily resumed work and agreements were reached between the parties by direct negotiation in 3 cases. There were 3 strikes in the progress at the end of December 1956 in the Kothari Textiles, Limited, the Cambodia Mills, Limited, and the Janardhana Mills, Limited, Coimbatore. The

lock-out in Sri Krishna Foundry, Madurai, also continued. Details about the various industries in which there were strikes or lock-outs, number of workers involved and man-days lost, etc., are given in the Statements appended (Annexures II and III).

IV. *Industrial disputes referred for adjudication*.—During the period under report 22 disputes were referred to the Industrial Tribunals for adjudication (see Annexure IV).

Awards relating to 38 cases were published out of which 17 were decisions of the Industrial Tribunals on the applications filed by the workers under section 33-A of the Industrial Disputes Act (see Annexure V).

Six decisions and orders of the Labour Appellate Tribunal of India on appeals against the awards of the Industrial Tribunals and applications filed by the employers or employees were published in the Supplement to Part I of the *Fort St. George Gazette* during the period under report (see Annexure VI).

V. *Important disputes during the period 1st November to 31st December 1956*.—*Messrs. Nanco Rubber and Plastics, Limited, Coimbatore*.—The lock-out declared on 4th October 1956 consequent on a sudden strike by the workers from 10th July 1956 was lifted on the intervention of the Commissioner of Labour, Madras, on 7th November 1956 when the workers resumed work.

Sree Meenakshi Mills, Limited, Madurai.—The workers and the management of Sree Meenakshi Mills, Limited, Madurai, signed an agreement before the Commissioner of Labour on 22nd December 1956 on the question of workload and revision of wages on the basis of the settlement in Coimbatore textile mills.

VI. *Strikes and lock-outs declared illegal during the period 1st November to 31st December 1956*.—No strike or lock-out was declared illegal during the period under report.

VII. *Prosecutions under section 29 of the Industrial Disputes Act, 1947*.—Of the 3 prosecutions reported to be pending on 31st October 1956, one related to Neelagundi Plantation, Kalpettah, which was transferred to the Kerala State consequent on the reorganization of States on 1st November 1956. The other two cases were still pending at the end of the year, besides the prosecution of the management of the Rasipuram Union Motor Service, Salem, sanctioned in G.O. Ms. No. 4706, Industries, Labour and Co-operation, dated 6th November 1956.

VIII. *Important meetings and conferences*.—1. The Commissioner of Labour, Madras, attended the following meetings and conferences during the period ending 31st December 1956.

The meeting of the officers dealing with Housing and Slum Clearance Schemes held at the Secretariat on 28th November 1956.

2. The *Ad hoc* Committee meeting of the 13th session of the Labour Ministers' Conference was held at New Delhi on 26th December 1956. The Minister for Labour attended the regular Session of the Conference held on the 27th and 28th December 1956 with the Secretary to Government, Department of Industries, Labour and Co-operation and the Commissioner of Labour.

IX. *Works committees*.—Of the 557 works committees functioning in the State of Madras, on 31st October 1956, 136 were in the areas transferred to the Kerala and Mysore States on 1st November 1956. One works committee was constituted in the Loyal Textile Mills, Limited, Kovilpatti, during the period under report. The total number of works committees functioning in this State on 31st December 1956 was 422.
