

REPORT ON THE ADMINISTRATION OF THE POLICE OF THE MADRAS STATE, 1962.

Part I.

1. *General conditions of the year.*—The seasonal conditions during 1962 were normal and the year was on the whole a peaceful one. The two important events of the year were the holding of the Third General Elections early in the year and the National Emergency caused by the Chinese aggression towards the close of the year.

2. *Elections.*—The Third General Elections were held on the 17th, 19th, 21st and 24th February. The task of ensuring peace prior to, during and after the elections was by no means an easy one and on account of the well-planned and elaborate police arrangements, the elections went off smoothly despite the keen competition and the high percentage of polling. All the political parties commended the Police for their efficiency and impartial behaviour.

3. *Conference.*—The Sixth Madras State Police Officers' Conference was held at Ootacamund on the 14th and 15th May 1962. Many subjects of departmental and general interest were discussed and decided.

4. *Centenary Scholarship Fund.*—The Government approved during the year the Madras Police Centenary Scholarship Scheme. It came into effect from 1st August 1962.

5. *All India Police Welfare Exhibition and Cultural Meet.*—Nineteen Police Units participated in the Fifth All India Police Welfare Exhibition and Cultural Meet held at Srinagar in June 1962. Madras took the second rank with 49 points to its credit and also annexed the Rolling Trophy for the best drama depicting most accurately and realistically any aspect of a Policeman's life. In the Exhibition, Madras won one first prize and two second prizes for spinning, crochet work and miscellaneous respectively.

6. *Madras Police Benevolent Fund.*—During the year a sum of Rs. 48,695.55 nP. was received as grant from the Government. A sum of Rs. 67,251.57 nP. was spent towards relief, welfare, educational aid and provision of amenities for the members of the Force.

7. *Police Village Development Scheme.*—The Police Village Development Scheme also continued to work satisfactorily. The Police assisted the villagers in laying mud roads and in the construction of small wooden bridges, etc., in various districts. They also continued to train school boys in simple drill and discipline.

8. *Police Sports.*—The twelfth All India Police Games Meet was held at Trivandrum from 31st January to 7th February 1962. The Madras State Police Team secured 121 points and stood second among the All India Teams. They secured five gold medals, three silver and five bronze medals. Madras also took part in the Third All India Police Aquatic Meet held in Delhi on 30th and 31st August 1962. In view of the National Emergency, the Tenth All India Police Duty Meet, the South Zonal Tournaments and the Annual State Police Sports were not held during the year.

9. *Conclusion.*—The General Elections in the beginning of the year, the declaration of National Emergency at the end of the year and the visits of various high dignitaries all through the year added to the normal strain of their duties. Nevertheless, the Police continued to discharge their duties in regard to the maintenance of Law and Order and the control and prevention of crime with commendable zeal and efficiency.

The State-wide General Elections afforded a unique opportunity to the Police and the public to come close together and enlist each other's assistance in further building up the fund of mutual goodwill and co-operation fostered through the years.

Part II—Crime.

TRUE COGNIZABLE CRIME—ANALYSIS OF OFFENCES UNDER VARIOUS CLASSES (I TO VI).

10. *General character of the year.*—Despite the none-too-favourable economic conditions, the total cognizable crime and grave crime registered a fall of 0.78 per cent and 9.0 per cent respectively. This decrease, especially under grave crime, is largely attributable to the hard and sustained work put in by the force in general, to the active assistance of Village Vigilance Committees, to the effective control over the movements and activities of known bad characters and potential offenders, and to the great progress in the maintenance and collation of criminal records and to the publication and inter-communication of information relating to crime and criminals.

11. *Total cognizable crime.*—Excluding offences under the the 'Special and Local Laws' and the 'Nuisance' Sections of the Indian Penal Code,

the total number of true cases of cognizable crime reported during the year was 48,089 as against 48,468 in 1961—a decrease of 379 cases or 0.78 per cent.

The total number of cases under the special and local laws increased from 204,490 in 1961 to 270,040 in 1962—an increase of 65,550 cases or 32.05 per cent. Increase was noticeable in all districts except Thanjavur and Madras City.

There was a decrease in the total number of nuisance cases from 158,577 in 1961 to 126,711 in 1962—a fall of 31,866 cases or 20.1 per cent. The decrease was noticeable in all districts except Ramanathapuram, Kanyakumari, Salem, The Nilgiris and in Madras City.

14. *Murder*.—The number of true cases of murder was 659 as against 727 in 1961 showing a decrease of 68 cases or 9.4 per cent.

12. *Serious offences against person and property*.—The number of serious offences against person and property was 17,720 as against 17,946 in 1961. The ratios of these offences to population in this State during the years 1960, 1961 and 1962 were one case for every 1,620, 1,875 and 1,899 persons respectively.

13. *Grave crimes*.—The following statement shows the number of true cases of grave crime reported during the last two years.

In 63 cases, the murderers committed suicide as against 43 in 1961.

15. *Infanticide*.—Cases of infanticide were reported from 11 districts (including Madras City) during the year. The motives were attributed to poverty, domestic trouble or fear of social disgrace.

16. *Riots and disturbances*.—Two thousand five hundred and sixty-three cases of rioting and unlawful assembly were disposed of in 1962 as against 1,476 in 1961. The increase was due to the State-wide agitation launched by the Dravida Munnetra Kazhagam in connection with the demand for control of prices of essential commodities. There were no major or widespread riots of any consequence in the State; the few that broke out were sporadic and were dealt with suitably. Law and Order and public peace were, on the whole, very well maintained.

The only occasion in which the Police had to open fire during the year was on 10th May 1962 when Head constable 883 Mahaboob Khan shot one K. D. Mooka Murugan, son of Arunachala Thevar of Sivalaperi when the K. D. attempted to cause hurt to Police constable 1641 who followed a person carrying a basket suspected to contain I.D. arrack. The Revenue Divisional Officer, Tirunelveli, who held an enquiry, justified the shooting.

17. *Communal situation*.—There were no organised or large scale communal clashes during the year.

18. *Agrarian situation*.—Except a few isolated cases arising out of the familiar issues of demand for increase in wages and protest against employment of outside labour, there was not much organised activity on the Kisan front during the year.

Security proceedings were initiated against 40 Kisans of Anakudi, Thanjavur district, for trespass into lands in order to take forcible possession of them.

19. *Labour situation*.—Except for a few strikes that were localised ones and resorted to by the workers of individual concerns for redress of local grievances, there were no organised and protracted strikes or lockouts during the year under review.

20. *Students activities*.—The few students' agitations or unrest were of no consequence.

21. *Dacoity*.—Statistics of dacoity for 1961 and 1962 are given in the statement under paragraph 14 of this report. There were 36 cases of dacoity during the year 1962 as against 32 in 1961—an increase of 12.5 per cent.

Of these, nine were reported direct to the Magistrates. There were 16 highway dacoities, even field dacoities and 13 house dacoities.

22. *Robbery*.—There were 169 cases of robbery in 1962, the lowest on record for the past 10 years. Of

these, 16 were reported direct to the Magistrates. There were 43 highway robberies, 48 field robberies and 78 house robberies.

23. *Mail robbery*.—There was no case of Mail Robbery during the year.

24. *House-breaking*.—There were 6,221 cases of house-breaking as against 6,703 in 1961, a decrease of 482 cases or 7.2 per cent. Of these, 47 cases were reported to the Magistrates direct.

The average value of property lost per case of house-breaking was Rs. 240 as against Rs. 317 in 1961 and Rs. 208 in 1960.

25. *Thefts*.—There were 17,019 cases of ordinary thefts as against 18,944 in 1961—a decrease of 1,925 cases or 10.2 per cent. Of these, 353 cases were reported to the Magistrates direct.

26. *Cattle thefts*.—There were 1,909 cases of cattle thefts, the lowest on record in the past ten years.

27. *Cattle poisoning*.—There were 103 cases of cattle poisoning as against 88 cases in 1961.

28. *Counterfeiting coins and currency notes*.—Two cases of counterfeiting coins were disposed of in 1962 and both of them ended in conviction. Of the 15 cases of note forgery disposed of in 1962, one ended in conviction.

29. *Other cases of interest (Bombs and explosives)*.—During the year 151 explosions of a non-political nature occurred resulting in the death of 19 persons and injuries to 238 persons as against 121 cases resulting in the death of 24 persons and injuries to 198 persons during 1961. The increase is due to accidents while blasting rocks for deepening wells and construction of dams in dry areas in the State and also due to careless handling of explosive substances.

30. *Fire arms*.—Forty-five cases were examined in 1962 as against 37 cases in 1961. Of those, seven cases were from Mysore State and five cases from Kerala State. The fire arms expert was summoned to give evidence in 16 cases on 17 occasions as against 23 cases on 25 occasions in 1961.

31. *Justifiable homicide*.—There was only one case that was treated as justifiable homicide as against three in 1961. The Police opened fire in this case in self-defence.

32. *Accidental deaths*.—Six hundred and thirty cases of deaths disclosing culpable negligence were reported in 1962 as against 505 in 1961. Prosecutions were launched in 450 cases, of which 187 ended in conviction, 181 in discharge and 81 were pending trial at the end of the year. One case was treated as undetected. The districts of Coimbatore, Chingleput, Tiruchirappalli, Madurai Urban, South Arcot, North Arcot and Salem contributed to the increase.

33. *Detection and prevention.*—The percentage of detection on the number of total true cases disposed of during the year excluding those in which investigation was refused in the last three years are shown below :—

Detection of total cognizable crime and of grave crime recorded an improvement of 3.9 and 2.0 per cent respectively over that of last year.

34. *Cases in which investigation was refused.*—Section 157 (1) (b), *Criminal Procedure Code.*—Of the 52,414 cases reported to the Police during the year, investigation was refused in 194 cases or 0.4 per cent as against 0.5 per cent in 1961 and 0.5 per cent in 1960. The need for the discreet use of this provision of law is being constantly brought to the notice of subordinates by me and by the senior officers.

35. *Cases referred by Magistrates under section 202, Criminal Procedure Code.*—Three hundred and fifty-six cases were referred to the Police by Magistrates in 1962 under section 202, *Criminal Procedure Code* as against 464 in 1961. No unnecessary references have come to notice.

36. *Property lost and recovered.*—There has been a good improvement in the value of property recovered, the percentage being 41.7 as against 32.8 in 1961 and 36.95 in 1960.

37. *Prosecutions.*—The number of cases decided by the Courts was 34,571 as against 32,495 in 1961. Of these, 70.0 per cent ended in conviction as against 68.4 per cent in 1961.

38. *Other offences.*—Forty-six thousands five hundred and fifty-nine persons were tried in 1962 as against 45,585 in 1961. 58.6 per cent were convicted in 1962 as against 56.9 per cent in 1961.

39. *Inadequate sentences and retrials.*—Serious cases of inadequate sentences or prima facie miscarriage of justice were duly brought to the notice of the Collectors.

40. *Escapes.*—There were 64 cases of escapes of prisoners during the year as against 53 in 1961 and 48 in 1960. Of these 18 escaped from sub-jails, two from Police lock-ups and 44 from other police custody, as against nine, eight and 36 respectively in the previous year.

Of these, 46 prisoners were re-captured. Fifty-nine police officers were dealt with departmentally for neglect of duty in guarding prisoners. The need for tightening up discipline in this regard has been emphasised by me.

41. *The Madras Restriction of Habitual Offenders Act.*—The Act continued to work satisfactorily. The suggestion to include in the schedule under the Act certain sections of the Indian Penal Code is under the consideration of the Government.

42. *Security for good behaviour.*—Out of 13,514 persons put up, 11,118 were bound over. Six hundred and forty-five cases were pending at the end of the year. The number sentenced to imprisonment in default was 3,154 as against 2,835 in 1961. The average amount of security demanded was Rs. 114 the same as in 1961.

43. *Cinematograph Act.*—This Act and the Rules thereunder were enforced satisfactorily.

44. *The Suppression of Immoral Traffic Act.*—Effective steps to stamp out this evil continued.

45. *Prohibition.*—Prohibition is being enforced by the Police as part of their regular duties throughout the State.

46. *Inspection of shops licensed under the Indian Arms Act and the Indian Explosives Act.*—All the shops licensed under the Indian Arms Act and the Indian Explosives Act were inspected during the year by Inspectors and Gazetted Officers.

47. *Tear Smoke Squad.*—The Tear Smoke Squad was put into action on one occasion each during the year at Madras City and at Vellore to disperse the unruly mob that collected on account of the picketing by the members of the Dravida Munnetra Kazhagam Party in connection with the demand for reduction in the high prices of foodstuffs. After due warning 14 shells were fired. None was injured during the operation.

48. *Inspections.*—I toured all the districts during the year for general check up of police work and the band bust arrangements made in connection with the Third General Elections. I met the district officials and the Deputy Inspectors-General of Police and instructed them on current and special branch matters. I also inspected the Pallavaram police station (Chingleput district), Kottur Police Station (Kanyakumari district), Malabar Special

Police Companies I and II and the District Police Offices, Thiruchirappalli, Thanjavur, Coimbatore, The Nilgiris and North Arcot. I also visited Nagaland and Barrackpore where the two Armed Police Battalions from Madras are working.

49. *The Detective Dog Squad.*—The strength of the City Police Detective Dog Squad was nine dogs at the beginning of the year. Two pups were received on presentation. There were four casualties during the year. The strength of the squad at the close of the year was five dogs and two pups. The dogs gave useful clues for investigation in 34 cases.

The Dog Squad at Madurai had a strength of 3 dogs at the beginning of the year, one died during the year. This squad also proved useful in 12 out of 32 calls, it was required to attend during the year.

50. *Beggar Homes.*—The Government Care Camp and Care Home at Melpakkam and the Special Home (Care Home) at Kancheepuram are functioning under Police Management.

The establishment of the Special Home-cum-work house for the old, inform, discarded and disabled beggars and also for able-bodied beggars at Sirkali, Thanjavur district, has been sanctioned by the Government this year. This will be under the management of the Sirkali Town Panchayat.

The Government also sanctioned during the year the establishment of a work house for able-bodied baggars at Chidambaram, South Arcot district. This will be under the management of Chidambaram Municipality.

Part IV.

Police Force.

51. *Gazetted Officers.*—Two officers of the Indian Police, 14 of the Indian Police Service, 27 officers of the Madras Police Service and three officers of the Madras Armed Police Services were on deputation with the Government of India at the end of the year.

An officer of the Indian Police Service was on deputation as Aid-de-camp to the Governor of Madras during the year.

An officer of the Indian Police continued to be on deputation with the Jail Department throughout the year; one Madras Police Service Officer was on deputation with the Jail Department up to 16th December 1962.

One Indian Police Officer, one Indian Police Service Officer, 15 of the Madras Police Service and Two Ministerial Personal Assistants retired during the year.

An officer of the Indian Police Service died during the year.

52. *Strength.*—The sanctioned strength of the Force excluding the Malabar Special Police and Special Armed Police on the last day of the year was 28,043 (Permanent) and 3,271 (temporary) as against 25,604 and 3,933 respectively at the end of 1961.

53. *Recruitment.*—There were 759 vacancies in the force on the last day of the year as against 302 in 1961.

Six Ex. Army men and 313 Harijans were enlisted during the year as against 6 and 165 respectively in 1961. Among the recruits 343 were holders of Secondary School-Leaving Certificates as against 216 in 1961.

54. *Casualties.*—The total number of casualties in the force was 1,115 as shown below as against 988 in 1961.

Ninety police officers were injured during the year in the course of their duty as against 69 in the previous year. The increase in the number of Police Officers injured is due to the rioting on 19th July 1962 inside the Vellore Fort by D.M.K. sympathisers in which 28 Police officers received injuries.

55. *Health.*—The health of the force continued to be satisfactory. The percentage of the total actual strength of daily average number of men absent from duty on account of sickness was 2.8 the same as in 1961.

One hundred and twenty Police officers died in 1962 as against 101 in 1961.

The usual periodical medical examinations of the subordinate police were conducted during the year. Besides, Health and Medical Officers visit the lines periodically and report on measures to improve the health of the force.

56. *Education.*—There were 3,378 Head constables and 24,052 Police constables in the force on the last day of the year. Of these, only one was illiterate.

57. *Training College and Schools (Police Training College, Vellore).*—One Indian Police Service Probationer, two Probationary Deputy Superintendents of Police, Forty-nine Probationary Sub-Inspector (including three from Pondicherry State), and 6 Head constables selected for promotion as Sub-Inspectors passed out of the College after training during the year.

Three Indian Police Service Probationers, three Probationary Deputy Superintendents of Police, seventy-one Probationary Sub-Inspectors, eighty-nine Head Constables selected for promotion as Sub-Inspectors and six Sub-Inspectors of Pondicherry State were under training at the end of the year. Nine Assistant Sub-Inspectors of whom two were later selected as Sub-Inspectors were also trained during the year.

The standard of the trainees continued to be good and they did well both in examinations and in sports.

58. *Police Recruits' Schools.*—The following statement shows the number of recruits trained in each recruits' school in 1962.

59. *State Police Band.*—The State Police Band put in another year of good work. The band attended all important Government functions and had 67 private engagements during the year as against 56 in 1961. A number of foreign dignitaries who visited Madras expressed appreciation of the performance of the band.

66. *Extraordinary family pension, compassionate allowances and gratuities.*—The dependants of 10 deceased police officers were sanctioned compassionate gratuities ranging from Rs. 750 to Rs. 2,400 in view of the approved service of the deceased officers and the poor circumstances in which the dependants were left.

67. *Cost.*—The total cost of the department for the financial year 1962-63 was Rs. 7,07,00,000 as against Rs. 16,10,91,500 for 1961-62.

68. *Housing the force.*—The Police Housing Scheme was formulated at an approximate cost of Rs. 4.5 crores for inclusion in the Second Five-Year Plan, the object being to provide accommodation to 80 per cent of the Police subordinate staff. Though this scheme was not included in the Second Five-Year Plan proper, for all purposes, it is being treated as an important non-plan scheme. As the target of 80 per cent could not be reached by the end of the Second Five-Year Plan period, it is being continued in the Third Five-Year Plan period also.

69. *Criminal Investigation Department (Crime Branch).*—The Crime branch handled during the year many complicated and important cases of diverse nature such as counterfeiting, forgery, cheating, postal thefts, impersonation, fraud, suspected sabotage, unlawful possession of railway properties

and criminal conspiracy. The number of cases investigated rose from 91 in 1961 to 97 in 1962. There was also an increase in the number of cases, that ended in conviction from 42 in 1961 to 61 in 1962, an increase of 19 per cent. The Crime Branch, C.I.D., continued to function satisfactorily.

70. *State Forensic Science Laboratory.*—One hundred and forty-five cases of Questioned documents were received for examination during the year as against 160 in 1961.

Two Inspectors of the Criminal Investigation Department continued to be attached to the Document Wing of the Laboratory, one as Foot Print, Fire Arms and Coin and Currency Expert and other as Document Expert.

71. *Police Research Centre.*—During the year, the Police Research Centre embarked on a thorough study (i) of the various aspects of Prohibition Act, (ii) of Modus Operandi Characteristics of Kepmaris in the different parts of the country (iii) about the criminals addicted to Crimes which used to be committed by Thottia Naiks and (iv) of suicides. The Central Research Centre, Mount Abu, and other States have been consulting and taking advice from this Centre, whose research papers continued to be in demand.

72. *'X' Branch.*—The number of officers dismissed, removed and discharged from service in 1962 on the basis of X Branch reports was 17 as against 21 in 1961. The X Branch continued to work efficiently.

73. *Special Branch.*—The Special Branch continued to function satisfactorily.

74. *Prohibition Intelligence Bureau.*—The Prohibition Intelligence Bureau continued to do useful work. The cost of foreign liquor seized in 1962 was Rs. 37,942 as against Rs. 11,300 in 1961. The seizure this year included 5 cars involved in the transport of liquor worth Rs. 27,020.

75. *Finger Print Bureau.*—There were 3,94,538 finger print slips on record at the beginning of the year and 24,518 slips were received for record during the year. Of these, 14,082 were removed from the Bureau leaving 4,04,880 on record at the end of the year.

Of the 65,024 search references received in the Bureau (as against 59,397 in 1961) 61,132 were from Madras State and 3,892 from other States.

The Single Digit Sections in Madras City and Madurai continued to function satisfactorily.

76. *Shorthand Bureau, Vellore.*—The sanctioned strength of the Shorthand Bureau is three Inspectors and thirty-one Sub-Inspectors/Junior Reporters of whom one Inspector and two Junior Reporters are permanently stationed in Madras City. In G.O. No. 549, Home, dated 6th February 1962, two posts of Junior Reporters were made permanent. The

staff of the Bureau covered 2,855 political and labour meetings and 78 conferences, seminars, etc., as against 2,987, and 74 respectively in 1961.

77. *Railway Police*.—There was no change in the jurisdiction of the Tiruchirappalli Railway Police District during the year.

There were 648 cases of thefts of all kinds during the year as against 953 in 1960 and 807 in 1961.

There were 2,468 complaints of shortages of goods during the year as against 3,433 in 1961 and the amount of property lost was Rs. 69,253 as against Rs. 78,419 in 1961.

There were eight cases of attempted derailment of trains as against 4 in 1961. Of these, seven cases were treated as mistake of fact or mistake of law and one case as undetected.

No sabotage was suspected in any of these cases.

Six cases of stone throwing on trains were reported during the year as against 15 in 1961. Of these two ended in conviction, two were treated as mistake of fact and two remain undetected.

78. *Port Police*.—The Tuticorin Port Police consisting of a staff of one Sub-Inspector, one Head constable and 10 Police constables, continued to work satisfactorily.

79. *Armed reserve*.—The armed reserves were kept up to strength and mobilized during the year for annual training and for certain special occasions such as the visits of V.I.Ps., General Elections, Dravida Munnetra Kazhagam agitation, etc.

The discipline and morale of Armed Reserve continued to be such as to offer good hope for the future.

80. *Tear Smoke Squads*.—Tear Smoke Squads continued to function in the city and in the Armed Reserves of all districts. The Squad was put into action in one occasion each during the year in Madras City and at Vellore to disperse the unruly mob that collected on account of the picketing by the members of the Dravida Munnetra Kazhagam in connection with the demand for reduction in the high prices of food stuffs.

81. *Malabar Special Police*.—The Malabar Special Police I Battalion consisting of six active companies and one Headquarter company continued to be under the charge of the Malabar Special Police Commandant, along with the four active companies of Malabar Special Police II Battalions.

Four companies of Malabar Special Police II Battalion with the Commandant, Malabar Special Police, were deputed for duty in Assam from 20th September 1962 and four companies with the headquarters company of the Malabar Special Police I Battalion under the charge of the Commandant, Special Armed Police, were deputed for duty in

West Bengal on 30th November 1962 along with two companies of the Special Armed Police. One active company of Malabar Special Police, I Battalion continued to be on deputation with the Pondicherry State throughout the year. The annual inspection of the Malabar Special Police I companies by a Military Officer was carried out by Lt. Col. B. S. Grewal in January 1962.

The Radio and Motor Transport Branches are functioning satisfactorily.

Discipline was well maintained. The health of the force continued to be satisfactory.

It is pleasing to note that even within a short period of their duty under the operational command of the Army, these companies won the approbation of the Army Officers in regard to their turn out as well as discipline.

82. *Special Armed Police*.—The health of the force was satisfactory, and discipline was well maintained.

The force which was utilised for bandobust in connection with the Third General Elections discharged its duties efficiently.

The unit put in another year of useful work to the State.

83. *Police Radio Branch*.—There were three control, 12 static and 18 transportable stations at the end of the year with an operating staff of 20 Head Constables, 36 Naiks, 48 Lance Naiks and 22 Police Constables including a vacancy reserve of nine police constables.

Traffic continued to be very heavy due to the Third General Elections, visits of V.I.Ps. agitation by Political parties, National Emergency, etc.

Eight transportable sets with the full strength of operating staff were placed at the disposal of the Government of India for border duties in Nagaland and 12 more sets with the necessary operating staff sent for duty in West Bengal.

84. *Village Police*.—Village officers continued to co-operate with the Police in the reporting of crime as well as in their prevention and detection. The Police Officers for their part enlisted their assistance whenever necessary.

85. *Village Vigilance Committees*.—Village Vigilance Committees function in all the districts.

PART V.

Reforms and Needs.

86. *Forensic Science Laboratory*.—The Government approved the proposal for appointment of two Sub-Inspectors (one for Thanjavur and the other for Tirunelveli) as Scientific Assistants after their training in the State Forensic Science Laboratory for a period of nine months.

87. *Training of recruits*.—Due to National Emergency the period of training of Police constables in the Police Recruits' School has been reduced to four months and they are given further training in the districts while on duty.

88. *Police Hospital*.—A well-equipped hospital with 30 beds for the benefit of the City Police has been constructed.

89. *Scholarship fund*.—The Government sanctioned the Madras Police Centenary Scholarship Scheme which has come into effect from 1st September 1962.

90. *Good Service Stripes*.—The Government have approved the proposal to grant good service stripes and silver stripes to Head Constables and Police Constables of Armed Reserve, Taluk Police, Railway Police, City and Criminal Investigation Department, etc., and Lance Naiks and Naiks of the

Malabar Special Police and Special Armed Police and to sanction the payment of a special pay to each holder of a stripe.

91. *Traffic*.—The new traffic signals have been introduced in all the districts (except Salem) and Madras City with effect from 1st November 1962 and in Salem from 15th December 1962.

The rapid growth of highway traffic in Madras State has created several traffic problems. In order to consider matters relating to traffic planning and regulations at State level, the Government have constituted a State Road Development and Traffic Planning Committee with the Transport Commissioner as Chairman, Secretary to Government, Home Department and Inspector-General of Police and some other officials and non-officials as members. The Government have also ordered the formation of District Road Development and Traffic Planning Committees in districts with the Collector as Chairman, Superintendents of Police as Secretary, Regional Transport Officer and some officials and non-officials as members.

The Government have also ordered the creation of a Traffic Planning (Engineering) Cell to work under the Chief Engineer (Highways). In order to co-ordinate the work of the Traffic Planning (Engineering) Cell, the Government have also approved the creation of Traffic Planning (Police) Cell. The Traffic Planning (Engineering) Cell has already started functioning.

Police—Administration Report, 1962—Reviewed.

Recorded.

2. The year was marked by a decrease in cognisable crime and grave crime. The total number of cases of cognisable crime, excluding offences under "Special and Local Laws" and "Nuisance" sections of the Indian Penal Code was 48,089 as against 48,467 in 1961, a decrease of 0.78 per cent. Grave crimes decreased from 28,599 in 1961 to 26,013 in 1962, a decrease of 9 per cent. The decrease was noticeable under all heads of grave crime, except dacoity. Cases of murder decreased from 727 to 659 (9.4 per cent), robbery from 191 to 169 (11.5 per cent), house-breaking from 6,703 to 6,221 (7.2 per cent), theft (cattle) from 2,002 to 1,909 (4.6 per cent) and theft (ordinary) from 18,944 to 17,019 (10.2 per cent). The number of dacoity increased from 32 in 1961 to 36 in 1962, an increase of 12.5 per cent. The decrease, especially in grave crime was largely attributable to the hard and sustained work put in by the force in general, to the active assistance of Village Vigilance Committees, to the effective control over the movements and activities of known bad characters and potential offenders, and to the great progress in the maintenance and collation of criminal records and to the publication and inter-communication of information relating to crime and criminals. The number of cases under "Special and Local Laws" increased from 204,490 in 1961 to 270,040 in 1962, an increase of 32.05 per cent. This increase was noticeable in all districts except Thanjavur and Madras City. Nuisance cases, however, decreased from 158,577 in 1961 to 126,711 in 1962, a fall of 30.1 per cent. The decrease was noticeable in all districts except Ramanathapuram, Kanyakumari, Salem, the Nilgiris and in Madras City. Serious offences against person and property fell from 17,846 in 1961 to 17,720 in 1962. The ratio of these offences to population in the State for the years 1960, 1961 and 1962 was one case for every 1,620, 1,875 and 1,899 persons respectively.

3. The percentage of detection of cognizable crime in 1962 was 54.3 as against 50.4 in 1961 and 48.3 in 1960. There was improvement in detection in Madras City and nine districts, viz.,

Chingleput, South Arcot, Thanjavur, Madurai North, Madurai Urban, Ramanathapuram, Salem, Coimbatore and the Nilgiris. Satisfactory improvement in the standard of detection was maintained.

4. Two thousand five hundred and sixty-three cases of rioting or unlawful assembly were disposed of in 1962 as against 1,476 in 1961. The increase was due to the State-wide agitation launched by the D.M.K. in connection with the demand for control of prices of essential commodities. There were no major or widespread riots of any consequence in the State and Law and Order and Public peace were very well maintained. The Police opened fire in self defence on one occasion and the Revenue Divisional Officer who held an enquiry justified the shooting.

5. There were no organised or large scale communal clashes during the year. Except for a few isolated cases, there was not much organized activity on the kisan front during the year. But for a few strikes that were localised ones and resorted to by the workers of individual concerns for redress of local grievances, there were no organised and protracted strikes or lock outs during the year. The few students' agitation or unrest were of no consequence.

6. The Crime Branch of the C.I.D. continued to function efficiently. It handled many complicated and important cases of diverse nature such as counterfeiting, forgery, cheating, postal thefts, impersonation, fraud, suspected sabotage, unlawful possession of railway properties and criminal conspiracy. The number of cases investigated was 97 and out of this 61 cases ended in conviction.

7. The Special Branch and 'X' Branch continued to function satisfactorily.

8. The Prohibition Intelligence Bureau continued to do useful work. The value of foreign liquor seized by the Bureau during 1962 was Rs. 37,942 as against Rs. 11,300 in 1961. The seizure included 5 cars involved in the transport of liquor worth

Rs. 27,020. In Madras City 26,463 cases under the Madras Prohibition Act were charged during the year as against 25,986 during 1961. The increase in the number of prohibition offences is due to the greater and unstinted vigilance enforced by the Police. Continuous raids were conducted by the City Police on the borders of the Chingleput district and the flow of liquor from Pondicherry and Andhra State was kept low.

9. Traffic accidents decreased from 3,535 in 1961 to 3,488 in 1962. Seventy-seven cases were fatal in 1962 as against 62 in 1961.

10. The Armed Reserves were kept up to strength and mobilised during the year for annual training and for certain special occasions, such as visits of V.I.Ps., General Elections, D.M.K. agitation, etc.

The discipline and morale of the Armed Reserve continued to be such as to offer good hope for the future.

11. Four Companies of Malabar Special Police II Battalion with the Commandant, Malabar Special Police were deputed for duty in Nagaland from 29th September 1962. Four Companies with the Headquarter Company of the Malabar Special Police I Battalion and 2 Companies of the Special Armed Police under the charge of the Commandant, Special Armed Police were deputed for duty in West Bengal on 30th November 1962. One active Company of the Malabar Special Police I continued to be on deputation with the Pondicherry State throughout the year. Even within the short period of their duty under the operational command of the Army, the Companies won the approbation of the Army Officers in regard to their turn out as well as discipline.

12. At the end of the year, the State Police Radio Network had 3 control, 12 static and 18 transportable stations. Traffic continued to be very heavy due to the Third General Elections, visits of V. I. Ps., agitation by Political parties, National Emergency, etc. In spite of the heavy pressure, a high standard of efficiency was maintained.

13. The Police Housing Scheme aims at providing quarters for 80 per cent of the Police subordinate staff at a total estimated cost of Rs. 450 lakhs. In 1962-63, the Government have sanctioned the construction of quarters for 3 Inspectors, 8 Sub-Inspectors, 18 Head Constables and 119 Police Constables at an estimated cost of Rs. 10,94,850. The construction of quarters for one Subedar Major, one Subedar, 5 Jaminidars and 189 other

ranks sanctioned in March 1961 was completed and these were declared open by the Chief Minister on 31st January 1963. As the target of 80 per cent could not be reached by the end of the Second Five-Year Plan, the Scheme is being treated as an important non-Plan Scheme and continued during the Third Plan.

14. The two important events of the year under review, were holding of the Third General Elections early in the year and the National Emergency caused by the Chinese aggression towards the close of the year. The task of ensuring peace prior to, during and after the elections was by no means an easy one and on account of the well planned and elaborate Police arrangements the elections went off smoothly despite the keen competition and the high percentage of polling. All the political parties commended the Police for their efficiency and impartial behaviour.

15. The various welfare schemes sponsored in the previous years to augment the family income of the Policemen continued to function satisfactorily. The Police Village Development Scheme also continued to work satisfactorily. The Police assisted the villagers in laying mud roads and in the construction of small wooden bridges, etc., in various districts. They also continued to train school boys in simple drill and discipline.

16. In the Twelfth All-India Police Games Meet held at Trivandrum from 31st January to 7th February 1962, the Madras State Police Team secured 121 points and stood second among the All-India Teams. Five gold, three silver and five bronze medals were annexed by them. The Madras State Police also took part in the Third All-India Police Aquatic Meet held in Delhi on 30th and 31st August 1962.

17. The General Elections, the declaration of National Emergency and the visits of various high dignitaries all through the year added to the normal strain of the Police. In spite of it, the Police continued to discharge their duties in regard to the maintenance of law and order and the control and prevention of crime with commendable zeal and efficiency. The State wide General Elections afforded a unique opportunity to the Police and the public to come close together and enlist each other's assistance in further building up the fund of mutual goodwill and co-operation fostered through the years. The Government are pleased to record their appreciation of the good work done by the Police during the year under review.
