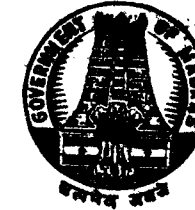

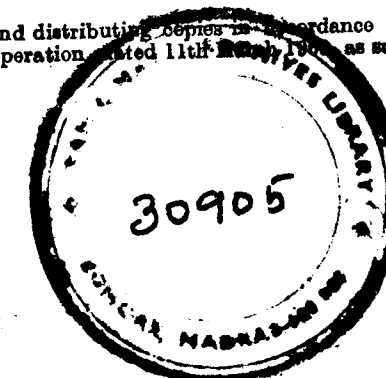

Report on the working of the Industrial Disputes Act, 1947 (Central Act XIV of 1947) for the calendar year 1964.

PERSONNEL.

Sri R. Balasubramanian, I.A.S., continued to be the Commissioner of Labour, and Registrar of Trade Unions from 1st January to 15th March 1964 and Sri M.G. Balasubramanian, I.A.S., who took over on 16th March 1964, continued to be the Commissioner of Labour during the remaining period of the year.

During the year, the Department was reorganised into three regions and each region was put in charge of a Deputy Commissioner of Labour with effect from 10th September 1964.

Sri K. V. Parthasarathy, M.A., B.L., continued to be the Deputy Commissioner of Labour, Chief Inspector of Plantations and Certifying Officer under the Industrial Employment (Standing Orders) Act, 1946. With effect from 10th September 1964, he assumed charge as Deputy Commissioner of Labour, Madras Region.

Sri T. S. Ramakrishnama Raja, B.Sc., Assistant Commissioner of Labour, was transferred on deputation on 24th April 1964 as Managing Director, North Arcot District Co-operative Spinning Mills.

Sri G. Kamalaratnam, M.A., B.L., Assistant Commissioner of Labour, was promoted and posted as Deputy Commissioner of Labour, Coimbatore, from 10th September 1964.

Sri D. K. Purushotham, B.A., Assistant Commissioner of Labour, was promoted as Deputy Commissioner of Labour, and he assumed charge as Deputy Commissioner of Labour, Madurai, on 15th December 1964 afternoon.

Sri C. R. Visvanathan, B.A., LL.B., D.S.W., who was reverted from the Central Board for Workers Education assumed charge as Assistant Commissioner of Labour from 24th July 1964.

Sri S. R. Muthuswamy Pillai assumed charge as Assistant Commissioner of Labour (Administration) on 8th January 1964 and continued in that post throughout the year. The post of Assistant Commissioner of Labour (Administration) was redesignated as Assistant Commissioner of Labour (Establishment and General) with effect from 10th September 1964.

Sri W. S. Sivasankar, B.A., (Hons.), LL.B., Gazetted Assistant to the Commissioner of Labour, continued to be in charge of the preparation and publication of the *Madras Labour Gazette*, a monthly publication of the Department from 1st January 1964 to 23rd April 1964 and thereafter he was reverted to Secretariat. Sri E. S. Ramaswamy, B.Sc., assumed charge as Gazetted Assistant on 1st August 1964 and continued in that post during the remaining period of the year.

The Commissioner of Labour was the Chief Conciliation Officer under the Industrial Disputes Act, 1947, for the entire State of Madras. He was assisted in his work by one Deputy Commissioner of Labour, 2 Assistant Commissioners of Labour and 14 Labour Officers up to 9th September 1964 and with effect from 10th September 1964, 3 Deputy Commissioners of Labour, 2 Assistant Commissioners and 14 Labour Officers in the Districts. Deputy Commissioners of Labour have been appointed as Conciliation Officers under the Industrial Disputes Act, 1947, for the entire State and the Labour Officers as Conciliation Officers in their respective jurisdictions.

LABOUR POLICY.

The Labour policy of the State was governed by the guiding principles of the Third Five-Year Plan. Tripartite divisions like Industrial Truce Resolutions, Code of Discipline, etc., were continued to be implemented.

FAIR WAGES.

The implementation of the recommendations of the Wage Board constituted by the Government of India for the Cotton Textile Industry has been completed in this State. The number of workers who have been benefitted by the implementation of the Wage Board recommendations for this industry including four mills which subsequently implemented, is about Rs. 1,02,175.

The Central Wage Board for Tea Plantations has given the second interim recommendation and it has been implemented in the tea plantations in this State.

The Government of India have constituted second wage boards for the Cotton Textile and Cement Industries. They have also constituted Wage Boards for the Engineering Industry (including foundries) and the Iron and Steel Industries.

INFORMAL ARBITRATION.

After the National Emergency in October 1962, and following the Industrial Truce Resolution of 3rd November 1962, which was ratified at a Tripartite Conference held on 14th November 1962 in Madras, it was decided that all the disputes such as dismissal, discharge, retrenchment, etc., affecting individual workmen should be referred to the Commissioner of Labour for informal arbitration so as to avoid prolonged litigation and industrial unrest. There has been a good response to this from both the managements and trade unions. Even major issues like wages, dearness allowance, bonus, etc., involving large financial commitments, have been referred for informal arbitration to the Commissioner of Labour or his nominee.

The above position has helped to create a good climate in industrial relations; the last session of the Indian Labour Conference acknowledged that Madras has given a good lead in this regard.

IMPLEMENTATION OF LABOUR ENACTMENTS.

The number of awards of the Industrial Tribunal, Madras and the Labour Courts including awards in respect of disputes referred to them by the workers under Section 33A of the Industrial Disputes Act, 1947 and published in the *Fort St. George Gazette*, was 242. Out of these 136 required implementation and of these 89 were implemented on the date of enforcement. The other cases are under investigation.

EVALUATION AND IMPLEMENTATION COMMITTEES.

The State Evaluation and Implementation Committee of which the Commissioner of Labour is the Chairman and the Assistant Commissioner of Labour is the Secretary, met on 24th October 1964 and discussed subjects relating to the breaches of the Code of Discipline by unions, recognition of the National Carbon Employees' Union and the Tamilnad Thozhilalar Munnetra Sangam. So far 255 managements, 820 Unions and 24 Local Bodies have ratified the Code of Discipline.

INDUSTRIAL DISPUTES.

The State of industrial relations in the State was very satisfactory during the year.

The officers of this Department received 7,273 disputes during the year as against 7,362 disputes during the previous year. They settled 1,186 disputes by conciliation, 5,787 through mediation as against 6,086 by conciliation and 6,086 by informal mediation, during the last year. (A statement showing the details is given in Annexure I.)

IMPORTANT SETTLEMENTS OF DISPUTES.

Among the important industrial disputes settled during the year under review, mention may be made of the following :—

1. In the industrial disputes between the workers and the management of Madura Mills Co., Ltd., Madurai, Tuticorin and Ambasamudram, over the payment of bonus for 1963, a settlement was arrived at before the Assistant Commissioner of Labour II, Madras on 29th March 1964. The workmen were paid a bonus of 9.2 per cent of their total earnings or 20.5 per cent of their basic earnings for 1963 whichever was higher.

2. Through the good offices of the Chief Minister of Madras the industrial dispute over the payment of bonus for 1963 between the plantation workers and the management of Plantation estates, who are members of the Association of Planters of the State of Madras was settled and a memorandum of settlement under section 12 (3) of the Industrial Disputes Act, 1947, was signed before the Commissioner of

Labour, on 4th August 1964. This settlement is, however, subject to the condition that in the event of the Government of India accepting the recommendations of the Bonus Commission in regard to minimum bonus for the plantations in the South, and enacting a legislation on this, there will be a tripartite meeting for going into the question of minimum bonus in the light of the final decision of the Government of India in the matter. The employers' representatives agreed to the above condition without prejudice to their contentions on the question of minimum bonus and other recommendations of the Bonus Commission.

3. A settlement under section 18 (1) of the Industrial Disputes Act, 1947, was reached on 24th September 1964, between the workers represented by four unions in Coimbatore region and the managements or member-mills of Southern India Mill Owners' Association in the dispute over bonus for the year 1963, whereby an interim payment equivalent to 1/12th of the total annual earnings during 1963 (subject to a minimum of Rs. 50) was to be made as advance to the workers towards bonus for 1963, pending final settlement.

4. A dispute arose over the non-payment of second interim wage increase as recommended by the Tea Wage Board to the workers of Kelley and Lauriston Estates of O'Valley Estate (1938), Limited, arising out of the reorganisation of the Estate of the Company. A settlement under Section 12 (3) of the Industrial Disputes Act, 1947 between the management and the Nilgiris District Estate Workers' Union, Coonoor, was arrived at on 20th November 1964 before the Labour Officer, Coonoor, with the good offices of the Commissioner of Labour. From the date of the settlement Cleavans and New Hope Estates shall continue to be treated as tea estates whereas Kelly and Lauriston Estate shall be treated as coffee estates and the workers working already in the coffee estates will be transferred to the tea estates of the company as and when vacancies arise before going in for new recruits.

ADJUDICATION AND ARBITRATION.

During the year 194 industrial disputes were referred for adjudication to the Industrial Tribunal and the Labour Courts at Madras, Madurai and Coimbatore. Besides, one case was referred for arbitration under section 10-A of the Industrial Disputes Act. (A statement showing the details is given in Annexure II.) An additional Labour Court was constituted at Madras for a period of 6 months to expedite adjudication of the cases and it started functioning from 14th September 1964.

Two hundred and forty-two Awards were published during the year. (A statement showing the details of the awards published in the year is given in Annexure III.)

STRIKES AND LOCKOUTS.

There were 243 strikes and lockouts during the year in the various industries including those falling under the Central sphere, out of which 3 strikes continued from the previous year—

The 243 stoppages of work involving 77,810 workers resulted in a loss of 475,705 mandays. So far as the State sphere is concerned, 219 stoppages of work affected 64,514 workers (51,175 workers directly and 13,339 workers indirectly). This resulted in a loss

of 460,805 man-days. 1,875 working days were lost on account of these stoppages. An industry-wise classification of the work stoppages together with the number of working days lost, number of workers involved directly and indirectly and the number of man-days lost is given in Annexure VI.

Out of 219 stoppages in the State sphere, one related to lockout by the management which affected 2,500 workers and resulted in a loss of 5,000 man-days. In 16 cases the management declared lockouts consequent on the strike by the workers. On account of these 16 stoppages, 76,715 man-days were lost.

Out of 219 stoppages in the State sphere, 126 were settled by mediation by the officers of the Government. In 36 cases the parties came to a settlement by direct negotiation and in 48 cases the workers voluntarily resumed work. Two strikes were continuing at the end of the year. (Details are given in Annexure IV.)

Details of the major strikes are given below :—

1. About 839 workers of Southern Structurals, Limited, Pattabiram, struck work on 29th January 1964, as a protest against the action of the management in not conceding their demands. The workers resumed work on 9th March 1964, on the advice of the Labour Officer, Madras. As a result of the strike, 38,393 man-days were lost.

2. About 1,744 workers of Western India Match Company Limited, Madras, struck work on 14th April 1964 as a protest against the action of the management in not conceding their demands. The workers voluntarily resumed work on 12th May 1964. As a result of the strike, 60,112 man-days were lost.

3. All the 696 workers of the Indian Steel Rolling Mills, Limited, Nagapattinam, struck work on 19th July 1964, as a protest against the suspension of certain workers. The strike was called off and the workers resumed work on 25th July 1964, on the mediation by the Assistant Commissioner of Labour II, Madras. 4,176 man-days were lost on account of the strike.

4. The Unions affiliated to Hind Mazdoor Sabha and the All-India Trade Union Congress organized a hartal in the textile mills in Coimbatore district on 14th August 1964, as a protest against the failure of the Government to arrest the rise in prices. Workers in 15 textile mills numbering about 10,000 only observed the hartal.

5. All the 485 workers of Dharangadhara Chemical Works, Limited, Arumughaneri, struck work on 10th August 1964, demanding increase in dearness allowance. The workers resumed work on 18th August 1964, on the mediation by the Commissioner of Labour, Madras. 2,910 man-days were lost on account of the strike.

6. All the 3,543 workers in Textool Company, Limited, Ganapathy (Coimbatore), went on a strike on 26th October 1964 demanding bonus for 1963-64. The workers resumed work on 29th October 1964, on the intervention of the Commissioner of Labour, Madras. 10,629 man-days were lost on account of the strike.

Similarly 308 workers out of 347 workers in Textool Company, Limited, Branch II, 208 workers out of 342 workers in Textool Company, Limited, Branch I and 851 workers out of 1,234 workers in Textool Company, Limited, Branch III, went on a strike on 26th October 1964, demanding bonus for 1963-64. The workers resumed work on 29th October 1964, on the advice of the Commissioner of Labour, Madras. 4,440 man-days were lost on account of the strike.

7. About 4,000 workers in all the tanneries in the North Arcot district struck work on 19th December 1964, demanding interim relief. The workers except in Ranipet area resumed work on 23rd December 1964 and those in Ranipet area on 24th December 1964, on the mediation by the Commissioner of Labour. 20,000 man-days were lost on account of the strike.

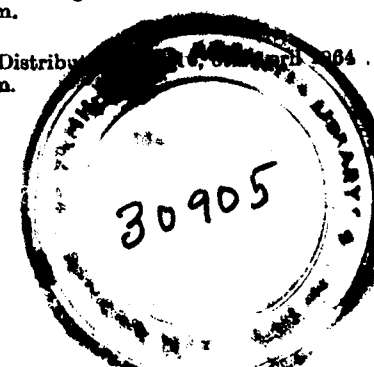

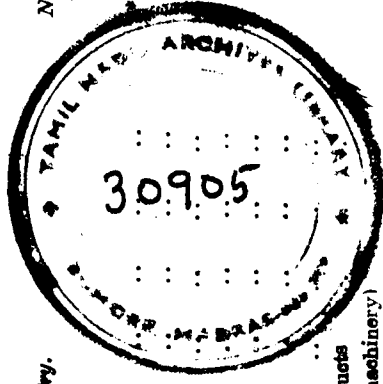
