

REPORT ON THE WORKING OF THE INDUSTRIAL DISPUTES ACT, 1947
(CENTRAL ACT XIV OF 1947), FOR CALENDAR YEAR 1966.

Personnel—The Commissioner of Labour was the Chief Conciliation Officer under the Industrial Disputes Act, 1947, for the entire State of Madras. He was assisted in his work by three Deputy Commissioners of Labour, Special Deputy Commissioner of Labour, Assistant Commissioner of Labour I, Assistant Commissioner of Labour (Establishment and General) all of whom have been appointed as Conciliation Officers under the Industrial Disputes Act, 1947, for the entire state and 14 Labour Officers in the districts who have been appointed as Conciliation Officers in their respective jurisdictions.

Sri M. G. Balasubramanian, I.A.S., continued to be the Commissioner of Labour and Registrar of Trade Unions during the period under report.

An important development in the administrative side is the decision to merge the department of Weights and Measures with the Labour department with effect from 16th June 1966. With a view to improve the collection of labour statistics, six posts of Statistical Inspectors (two for each of offices of the Deputy Commissioners of Labour) were newly sanctioned.

An additional post of Deputy Commissioner of Labour has been created and designated as Controller of Weights and Measures (Deputy Commissioner of Labour-Inspection). Sri K. V. Parthasarathy, M.A., B.L., Deputy Commissioner of Labour, Madras, transferred and posted to this post assumed charge on 15th June 1966 a.n. He also held full additional charge of the post of Deputy Commissioner of Labour, Madras, during the period from 15th June 1966 afternoon to 24th August 1966 fore noon. He continued as Chief Inspector of Plantations under the Plantation Labour Act and Chief Inspector under the Motor Transport Workers Act.

Sri G. Kamalaratnam, M.A., B.L., continued to be Special Deputy Commissioner of Labour, Madras, during the period under report.

Sri D. K. Purushotham, B.A., continued as Deputy Commissioner of Labour, Madurai, up to 18th August 1966 and he was succeeded by Sri M. R. Subramaniam from 18th August 1966 forenoon.

Sri C. R. Viswanathan, B.A., LL.B., D.S.W., continued as Deputy Commissioner of Labour, Coimbatore, during the period under report.

Sri M. R. Subramaniam B.A., continued as Assistant Commissioner of Labour (Establishment and General) till 16th August 1966. He was promoted as Deputy Commissioner of Labour, and assumed charge as Deputy Commissioner of Labour, Madurai, on 18th August 1966 forenoon *vide* Sri D. K. Purushotham.

Sri S.R. Muthuswamy Pillai, continued to be the Assistant Commissioner of Labour-I, during the period under report. He held full additional charge of the post of Assistant Commissioner of Labour (Establishment and General) from 16th August 1966 afternoon to 12th October 1966.

Sri K. Sengodan, B.A., D.S.W., Labour Officer-I, Coimbatore, on his appointment as Assistant Commissioner of Labour (Establishment and General) assumed charge of that post on 13th October 1966 forenoon relieving Sri S. R. Muthuswami Pillai of his additional charge and continued in that post.

Sri E. S. Ramaswami, B.Sc., Gazetted Assistant to the Commissioner of Labour continued to be in-charge of the preparation and publication of the Madras Labour Gazette a monthly publication of the department.

During the period Sri K. Hallen, Labour Officer-II, Coimbatore and Sri N. Arumugam, Labour Officer, Salem, were deputed for training in a short term social work course of the Indian Institute of the Social Welfare and Business Management, Calcutta, for a period of 6 months.

The Labour Policy.—The Labour Policy of the State was governed by the guiding principles of the Third Five Year-Plan. Tripartite decisions like Industrial Truce Resolution, Code of Discipline, etc., were continued to be implemented.

Fair wages.—The Government of India have constituted Central Wage Boards for (1) Engineering Industry, (2) Heavy Chemicals and Fertiliser Industries, (3) Leather and Leather Goods Industry, (4) Road Transport Industry and (5) Electricity undertakings.

Second Wage Boards have also been constituted for the Cotton Textiles, Cement and Sugar Industries.

The Central Wage Board for Engineering Industries and the Leather and Leather Goods Industry have recommended an interim relief.

The Central Wage Board for Coffee Plantations Industry, Tea Plantations Industry and the Rubber Plantations Industry, have given their final recommendations and orders of the Government of India on them have also been received.

Effective steps have been taken to implement the recommendations in this state through the labour department.

Informal Arbitration.—After the National Emergency in October, 1962, and following the Industrial Truce Resolution of 3rd November 1962 which was ratified at a Tripartite Conference held on 14th November, 1962 in Madras, it was agreed that all the disputes, affecting individual workman such as dismissal, discharge, retrenchment, etc., should be referred for informal arbitration so as to avoid prolonged litigation and industrial unrest. The services of the departmental officers have been utilised in this regard in a fairly large measure.

Sixty-four cases were referred to the Commissioner of Labour, the Deputy Commissioner of Labour or Assistant Commissioner of Labour for informal arbitration during the year.

Cases showing details of instances in which arbitration has been accepted during 1966. On general issues involving heavy financial commitments are given below :—

Implementation of labour enactments.—The number of awards of the Industrial Tribunal, Madras and the labour courts including awards in respect of disputes referred to them by the workers under Section 33-A of the Industrial Disputes Act, 1947 and published in the *Fort St. George Gazette* was 351. Out of these, 307 (including 82 awards pending at the beginning of the year) required implementation and of these 162 were implemented on the date of enforcement. The other cases are under investigation. Besides the 351 awards mentioned above four arbitration awards were also published in the *Fort St. George Gazette*.

Evaluation and Implementation Committee.—The State Evaluation and Implementation Committee with the representatives of Employers and Trade Unions Associations on it, the Commissioner of Labour being the Chairman, has been endeavouring to incubate the spirit underlying Code of Discipline in managements and trade unions. The committee met twice during the year on 18th June and 17th December 1966. Labour Officers have also been contacting employers' and workers' organisations not affiliated to any of the Central Organisations and advising them to ratify the code of discipline. By their efforts 1,185 trade unions, 260 managements and 25 local bodies have ratified the code of discipline, up to 31st December 1966.

The payment of Bonus Act, 1965.—The payment of Bonus Act, 1965 (3 of 1965), applies to all factories and establishments employing 20 or more persons. It provides for the payment of a minimum bonus of four per cent and maximum of 20 per cent of the total annual earnings of the employers.

In G. O. Ms. No. 4163 (Labour), Department of Industries, Labour and Co-operation, dated 24th August 1965, the Government have specified the Commissioner of Labour, Madras, as the authority to extend the period of eight months referred to under section 19 of the Act. The conciliation machinery provided under the Industrial Disputes Act, 1947, viz., Commissioner of Labour, Assistant Commissioner of Labour Deputy Commissioners of Labour and Labour Officers have been appointed as Inspectors under Sections 27 of the Payment of Bonus Act, 1965 in G. O. Ms. No. 4833 (Lab.) Department of Industries, Labour and Co-operation, dated 13th October 1965.

The bonus disputes in 15 textile mills in Coimbatore and other districts have been referred to the Special Industrial Tribunal, Coimbatore, in addition to the 90 disputes already referred for adjudication in 1965. The awards are awaited.

The Government constituted a similar Special Industrial Tribunal at Madras and the dispute in Buckingham and Carnatic Mills Ltd., Madras regarding fixation of bonus for 1963, 1964 and 1965 was referred to it for adjudication. The Tribunal has given its award (vide item 78 of Annexure-III).

Industrial Disputes.—Industrial relations in the State was satisfactory during the year.

The Officers of this department received 8,558 complaints during the year as against 6,396 complaints during the previous year. During the year they settled 1,208 disputes by conciliation and 6,672 complaints through mediation as against 6,459 by conciliation and informal mediation during the last year. (A statement showing the details is given in Annexure-J.)

Important settlement of disputes.—Among the important industrial disputes settled during the year special mention may be made of the following:—

I. Regarding the payment of bonus for the workmen in Coffee Estate representatives of the managements and Trade Unions having held discussions before the Commissioner of Labour and agreed to have an industry wide long settlement. Accordingly a settlement under Section 34 (3) of the Payment of Bonus Act and Section 12 (3) of the Industrial Disputes Act was reached before the Special Deputy Commissioner of Labour, Madras on 30th September 1966. It was agreed between the parties that for years covered by the settlement i.e., from the Calendar year 1964 to the Calendar year 1967 both years inclusive the rate of bonus according to the agreed formula for each of the said Calendar years shall be as follows :—

II. Regarding the payment of bonus for the workmen in tea estates representatives of the management and Trade Unions having held discussion before the Commissioner of Labour and agreed to have an industry wide long term settlement. Accordingly a settlement under section 34 (3) of payment of Bonus Act and under Section 12 (3) of the Industrial Disputes Act was reached before the Commissioner of Labour on 21st September 1966. It was agreed

between the parties that the years covered by the settlement i. e., from the calendar year 1964 to the calendar year 1967 both years inclusive, the rate of bonus, according to the agreed formula for each of the said calendar years shall be as follows.—

III. A dispute regarding increase in wages to Factory workers in plantations was raised by the representatives of the Trade Unions. As a result of the conclusion reached before the representatives of Association of Planters of the State of Madras and Trade Unions on 30th September 1966, the issues have been referred to the Commissioner of Labour for his decision. After hearing the parties, the Commissioner of Labour had given a decision on 6th October 1966.

IV. A dispute was raised for payment of bonus for the workmen employed in certain plantations on the Shevaroy. After having had a discussion before the Labour Officer, Salem, a settlement under Section 34(3) of the Payment of Bonus Act and under Section 12(3) of the Industrial Disputes Act was reached before the Labour Officer, Salem on 14th December 1966 between the representatives of the Trade Unions and the management of certain plantations on the Shevaroy Planters Association, Yercaud. The parties agreed to have a long term settlement according to a formula providing for payment of bonus at a uniform rate by all member estates of the Shevaroy Planters Association. The rate of bonus for each of the seasonal years shall be :—

V. A dispute was raised by the workmen of Rallis India Limited, Madras, represented by Rallis and Associated concern Employees Union, Madras for the payment of bonus for the year 1962-63, 1963-64 and 1964-65. After having had a discussion a settlement under section 34(3) of Payment of Bonus Act and under Section 12(3) of the Industrial Disputes Act was reached before the Special Deputy Commissioner of Labour, Madras on 26th March 1966.

Adjudication and Arbitration.—During the year 310 industrial disputes were referred for adjudication to the Industrial Tribunal and the Labour Courts at Madras, Madurai and Coimbatore and Additional Labour Court, Madras. (A statement showing the details is given in Annexure-II.)

Three hundred and fifty-one awards were published during the year. (A statement showing the details of the awards published in the year is given in Annexure-III.)

Strikes and Lockouts.—There were 193 strikes and lockouts during the year in the various industries including those falling under the Central sphere out of which two strikes continued from the previous year.

The 193 stoppages of work involving 86,397 workers resulted in a loss of 8,24,640 mandays. So far as State Sphere is concerned 176 stoppages of work affected 69,310 workers, (55,721 workers directly and 13,589 workers indirectly). This resulted in a loss of 7,54,612 mandays. 1,438½ working days were lost on account of these stoppages. An industry-wise classification of the work-stoppages together with the number of working days lost, number of workers involved directly and indirectly and the number of mandays lost is given in Annexure VI.

Out of 176 stoppages in State Sphere, four were lockouts (Two Beedi and two textile industries) which affected 2,948 workers and resulted in a loss of 71,656 mandays. In 15 cases (Eight textile mills, three engineering establishments, one beedi, one chemical, one paper and paper products and one tobacco industries) the management declared lockout consequent on the strikes by the workers. In these 15 stoppages 12,334 workers were involved and 1,79,621 mandays were lost.

Out of 176 stoppages in the State Sphere 78 were settled by mediation by the officers of the Government in 16 cases the parties came to a settlement by direct negotiation, in 75 cases the workers voluntarily resumed work and in three cases the dispute was referred for adjudication and the strike or lockout was prohibited. Four strikes were continuing at the end of the year. (Details are given in Annexure IV.)

Some of the major strikes and lockouts during the year 1966 are referred to below :—

Out of 1,200 workers employed in the Somasundaram Mills (Private) Limited, Coimbatore, 1,000 workers directly and 200 workers indirectly staged a stay-in-strike with effect from 7 a.m. on 2nd March 1966 as a protest against the action of the management in retrenching 299 workers. As the workers did not resume work even after the advice of the management the mills declared lockout with effect from the forenoon of 4th March 1966. On the intervention of the Deputy Commissioner of Labour, Coimbatore, workers agreed to resume work and the management agreed to lift the lockout. The lockout was lifted at 1 a.m. on 16th March 1966 and all the workers resumed work. The number of mandays lost was estimated at 16,616. Out of 1,285 workers employed in Cambodia Mills Limited, Singanallur. Nine hundred and seventy-two workers went on a strike from 1 a.m. on 14th March 1966 demanding redressal of their grievances set out in strike notices issued by the unions. The strike continued upto 27th May 1966. As a result of intervention by the Commissioner of Labour and the Special Deputy Commissioner of Labour, Madras a settlement under Section 12 (3) of the Industrial Disputes Act, 1947 was effected on 26th May 1966 and as a result the management lifted the lockout and the workers resumed work with effect from 6th June 1966. The number of mandays lost was 94,157.

Out of 1,140 workers employed in Madras Rubber Factory, Madras, one thousand and ninety-seven workers went on strike from 4th June 1966 demanding bonus. The strike was called off on 16th June 1966 due to a settlement under Section 12 (3) of the Industrial Disputes Act, 1947 before the Commissioner of Labour, Madras. The number of mandays lost was 10,970.

About 400 workers of Pullicar Mills Limited, Tiruchengode, resorted to a stay-in-strike with effect from 30th May 1966 on the plea of alleged increase in work-load in the Spinning Department of the Mills. The management declared a lockout with effect from 1st June 1966. The strike and lockout ended on 29th July 1966 as a result of mediation by the Labour Department. The number of mandays lost was 19,680.

About 1,500 workers of first second and general shift of the Mettur Industries Limited, Mettur Dam went on a stay-in-strike with effect from 13th June 1966 protesting against the selection of an outsider by the management for a job in the Technical Department. The management declared a lockout with effect from 13th June 1966 (i.e., on the same day.) The strike and lockout ended on 11th July 1966 as a result of mediation by the Labour Department. The number of mandays lost was 47,100.

About 1,500 workers at various branches of Maharaja Beedi Factory, Ranipet, Timiri, Visharam and Kaviripak indulged in strike protesting against the action of the management of Maharaja Beedi Factory in having refused employment to 145 workers at their Ranipet Factory. The management declared a lockout with effect from 4th June 1966. The strike and lockout were resolved by a settlement under Section 12 (3) of the Industrial Disputes Act before the Labour Officer, Vellore and normal work was resumed in these factories with effect from 22nd July 1966. The number of mandays lost was 40,500.

The workers numbering about 1,188 of E. I. D. Parry Limited, Ranipet organised a stay-in-strike with effect from 10th June 1966 demanding early settlements of their demands. The management declared a lockout on 14th June 1966. The continuance of strike and lockout were prohibited by Government. The management lifted the lockout on 17th June 1966 and normalcy was restored. The number of mandays lost was 8,216.

Three thousand and hundred workers out of 6,400 workers of Madura Mills Company Limited, Madurai struck work for half-an hour on 27th April 1966 demanding early settlement of bonus for the year 1965. The workers resumed work of their own accord on the same day.

About 4,830 workers of Madura Mills and Pandian Mills, Madurai staged one hour token strike on 19th May 1966, protesting against the action of the management in terminating the services of two workers. The workers resumed work of their own accord.

The workers in Madura Mills and Pandian Mills, Madurai numbering about 6,880 staged a stay-in-strike with effect from 27th June 1966 as a protest against the action of the management in not conceding the demands raised by them in their strike notice dated 9th June 1966. Consequent on the stay-in-strike the management declared a lockout in both the Mills with effect from 28th June 1966. The workers resumed work on 10th July 1966, consequent on the settlement arrived at before the Special Deputy Commissioner of Labour, Madras. The number of mandays lost was 75,680.

About 8,611 workers out of 16,429 employed in 27 Textile Mills in Coimbatore belonging to Coimbatore District Mill Workers' Union (All-India Trade Union Congress), Coimbatore and the Coimbatore District Textile Workers' Union (Hind Mazdoor Sabha) Coimbatore, indulged in a token strike (Hartal) for one day on 5th May 1966, as a protest against the action of the managements of textile Mills in effecting retrenchment, closure and for certain other demands. The workers resumed work on the next day.

All the 1,456 workers employed in Somasundaram Mills Limited, Coimbatore staged a stay-in-strike with effect from 10.00 p.m. on 10th August 1966 protesting against the retrenchment of 73 workers. On the advice of the Labour Officer, Coimbatore, the workers resumed work with effect from 8.00 p.m. on 19th August 1966 and a settlement over the dispute was effected under section 12 (3) of the Industrial Disputes Act, 1947. The number of mandays lost was 10,408.

The management of the Parkaja Mills Limited, Coimbatore declared a lockout from 4.00 p.m. on 4th November 1966 as the workers of the mills obstructed the movement of yarn bales as a protest against the management's action in not granting bonus to the workers. Nine hundred and ninety-eight workers were affected by the lockout. The lockout was lifted and the workers resumed work from 7.00 p.m. on 22nd November 1966 as a result of direct negotiations between the parties. The number of mandays lost was 12,969.

Out of 1,566 workers employed in Kothari Textiles Limited, Singanailur 125 workers directly and 1,441 workers indirectly staged a stay-in-strike with effect from 4.10 p.m. on 18th December 1966 and the workers resumed work voluntarily on 25th December 1966 at 7.30 p.m. The number of mandays lost was 10,962.

Prosecutions.—During the year under report, Government sanctioned prosecutions against the following managements for non-implementation of awards.

(1) Pioneer Motors, Nagercoil for non-implementation of the terms of award of the Industrial Tribunal, Madras in I.D. No. 3/64 punishable under section 29 of the Industrial Disputes Act, 1947.

(2) M. K. N. Bus Service, Krishnagiri for non-implementation of the terms of the award of the Labour Court, Coimbatore in I.D. No. 29/65 punishable under section 29 of Industrial Disputes Act, 1947.

(3) M. K. N. Bus Service, Krishnagiri for non-implementation of the terms of award of the Labour Court, Coimbatore in I.D. No. 19/65 punishable under section 29 of the Industrial Disputes Act, 1947.

Recoveries.—During the year orders for recovery of the amounts due to workers under section 33 (C) (i) of the Industrial Disputes Act, were issued in 200 cases for an aggregate amount of Rs. 1,57,413-98.

Public utility services.—The period of declaration of the following industries as Public Utility Service was extended during the year 1966.

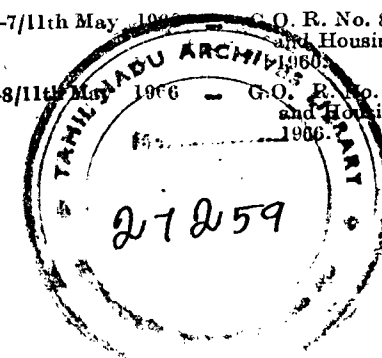

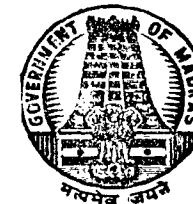
