Sir,

I have the honour to request that sanction of Government may be obtained for the publication by M.R.Ry. R. Krishnamachariar, M.A., (in Sanskrit) Sub-Assistant Inspector of Sanskrit Schools, of a dissertation in Sanskrit prose entitled "Raghuvamsavimarsam" or "Kalidasa unveiled". The book is supposed to contain critical observations on Raghuvamsa, which is one of the standard works of Kalidasa. The Sub-Assistant Inspector reports that there are no works in Sanskrit, which come up to modern taste and requirements, containing original critical observations on standard authors in Sanskrit and that he purposes writing a series of dissertations similar to the one which it is now proposed to publish. The whole series when completed will, it is stated, be known as "Kavyagunadarsa".

2. The Sub-Assistant Inspector reports that the work was undertaken outside office hours and without prejudice to his own legitimate duties and that the book is to be printed at his own cost at the Sri Vanivilas Press, Srirangam.

3. It is not intended that the proposed series should receive any sort of financial help from Government. The Sub-Assistant will be instructed not to have anything to do with the sale of the publications.
