Sir,

I am directed to refer to the correspondence ending with your letter no. 801, dated the 6th December 1905, regarding a scheme for promoting the growth of a knowledge among the school children of the Empire of the conditions of countries other than their own by means of a series of lessons or lectures illustrated by lantern slides.

2. I am to state for the information of the Governor in Council that the India Office has intimated that 7 sets of slides have been duly supplied to the Government of Madras, and that the cost thereof amounts to £. 243-17-10, which sum, it will be observed, is appreciably less than the estimated cost. I am to add that the freight and packing charges amount to ^{Rs.} 5-5 and £. 1-7-6, respectively.
