In G.O. No. 709 Educational, dated 19th October 1907, the proposal of the Director of Public Inst. was approved to incur out of the lump sum of .83 lakh made in the Civil Budget estimate for the current year for primary education an expenditure of Rs 2000, towards the cost of the special furniture, magic lantern & slides for the Training College Rajahmundry.

2. In his current letter, No. 7886, dated 31st January 1908, the D.P.D. requests sanction for the purchase of furniture for the Science laboratory of the Govt. Training College, Rajahmundry, at a cost of Rs 2432. The D.P.D. states that the exp. charge can be met from the special allotment of Rs 2000, sanctioned in G.O.
