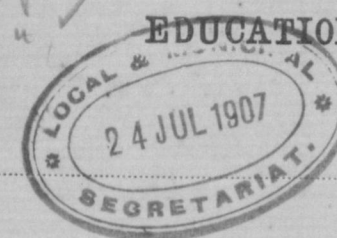

Col. 6 of stat. - page 3 of current.

The total cost of the library books proposed to be purchased for the St. Joseph's College, Trichinopoly, is Rs.1,679-1-0. The management of the school requests sanction for a grant-in-aid of Rs.839 which may be paid under Article 57 of the Grant-in-Aid Code (1906 Edition). The D.P.I. recommends that the ^{grant} ~~grant~~ may be sanctioned. The ^{amount} ~~amount~~ will be met from the balance of Rs.11,541 remaining out of the allotment of Rs.12,000 made in the current year's budget.

There is a provision of Rs.15,000 under "special grant for furniture, apparatus & maps" - page 145 C.B.E, 1907-08 (Preliminary issue).
