Though not possessed of the general educational qualifications required for being entertained in superior service, he is reported to be a thoroughly well-behaved and intelligent young man and well conversant with the office~~al~~ routine work and to have been discharging the duties entrusted to him satisfactorily. He is the only Muhammadan clerk in the Gudur division and comes of an ancient family claiming his descent from Shaikh'Abd-ullah, who, as the diploma granted to him and preserved in the family discloses, won great military distinction during the reign of Emperor Aurangazeb. I therefore strongly recommend that he be permanently exempted from examination rules for entertainment in superior service.
