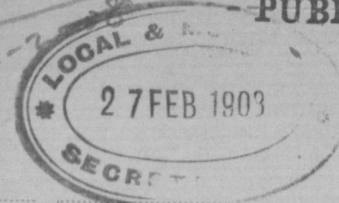

The individual has put in a service of 9 years of which he has acted as Gumasta for nearly 8 years. His work is reported to have been satisfactory. There is real difficulty in the Hosur Taluk in getting passed candidates for the post of gumasta and I request that

the exemption applied for may be sanctioned as a special case. I enclose an application in the prescribed form.
