The Curator reports that out of about 7400 slips of the Descriptive catalogue of Sanskrit manuscripts that remained to be printed at the close of the last official year 1906-07, about a thousand slips have been revised and printed but more than 6400 slips still remain to be so treated.

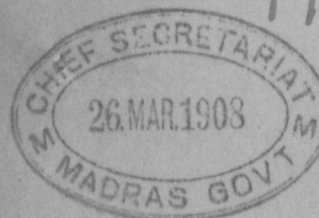
