I have the honour to request that Government will be
pleased to sanction the retention, till the 31st December 1908,
of the appointment of temporary assistant master sanctioned for
the Government Madrasa-i-Azam in G.O. No. 293 Mis. dated 15th
May 1907. The Headmaster reports that the second form continues
to be more than 40 strong and that since January last, it has
been working as two sections, one under a permanent teacher and
the other under the temporary assistant referred to above.

2. Necessary provision for the purpose has been made in
the Budget Estimate of the school for 1908-1909.

3. As the sanction accorded in the G.O. quoted above
expires on the 31st instant, I request the favour of early orders

SUBJECT

Appointment of a temporary Asstt. Master
for the Govt. Madrasa-i-Azam.

As the first form of the Madrasa-i-Azam had 53 pupils and had therefore to be split up into two sections under rule 29 of the Educational Rules, the Govt sanctioned the employment of a temporary Assistant Master on Rs 30 per mensem for the class in G.O. no. 293 Edl dated 15th May 1907. This sanction expires on the 31st instant.

2. The D.P.I. now states that the second form of the Madrasa-i-Azam continues to be more than 40 strong and that since January last it has been working as two sections - one under ~~the~~ a permanent teacher and the other under the temporary Asstt Master sanctioned in G.O. no. 293 Edl dated 15th May 1907. In these circumstances, the Director requests that sanction may be accorded to the retention of the temporary Asstt Master until the 31st Dec. 1908.

3. In 1907 the second form contained 46 pupils, but as its average attendance was not expected to be much above 40, the Director considered a second teacher was not necessary - Vide - D.P.I.'s letter no. 400 D. 21st March 1907

on page 1 of G.O. no. 293 dtd 1st May 1907. The Director now simply states that the form continues to be more than 40 strong but does not give its present strength.

4. In these circumstances it is for consideration whether the retention of the temporary assistant up to the 31st Dec. 1908 may be sanctioned.
