Up to, and including, the year 1906-07, the D.P.I. was allowed to expend a sum of Rs 500 on ^{the} temporary establishment required for the compilation of statistics for the Report on Public Instruction. Please see G.O. Ruo. 44 Edl dated 6th March 1906 and G.O. Ruo. 170 Edl dt 27-3-05.

2. During 1907-08 the D.P.I. was allowed an expenditure of Rs 900 on temporary establishment ^{required for this purpose} in consideration of the fact that a quinquennial report on education had to be prepared. Please see G.O. no. 224 Edl. dt 15th April 1907 & G.O. no. 502 Edl. dated 27th July 1906.

3. The D.P.I. now requests sanction to an expenditure of Rs 700 on temporary establishments during 1908-09. The amount applied for is Rs 200 in excess of the amount (Rs 500) usually allowed. No explanation has been offered for the increased amount applied for.

4. It is for consideration whether the increased amount of Rs 700 asked for may be sanctioned.

Previously to 1904, the amount ^{usually} allotted for the temporary establishment for the collection of statistics for the Public Instruction Report was Rs 360 - vide G.O. No. 140 R., dated 19th March 1903 and G.O. No. 171 R., dated 18th March 1901. In the year 1902-03, a sum of Rs 200 was allowed in addition to the usual allotment of Rs 360, in order to meet the cost of the additional establishment required in connection with the preparation of the quinquennial report - vide the D.P.G. letter No. 2174 dated 15th March 1902, in G.O. No. 161 R., dated 20th March 1902. ~~In~~ the year 1904, the lump provision for this purpose ^{was} put down at Rs 500 - vide G.O. No. 98 R., dated 12th March 1904. No explanation was however then given for the increase.

2. The amount sanctioned for the last quinquennial report was Rs 900, including Rs 180 for pay of a temporary typist. It is for consideration whether the D.P.G. may be asked to explain the need for an allotment of Rs 900, as against the usual sum of Rs 500.

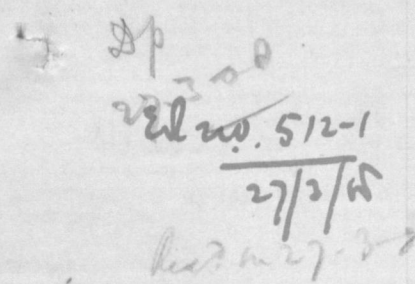

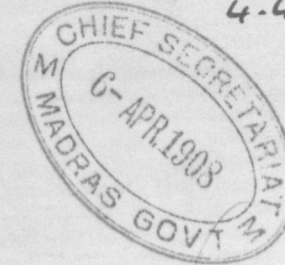
