As the sanction accorded in G.Os. No. 494 Educational dated 18th July 1905 and No. 678 Educational dated 17th October 1905 for the retention, respectively, of the services of the Art Instructor and peon of the Art class attached to the Kumbakonam College will expire on the 31st instant, I have the honour to request that Government will be pleased to accord sanction to the continuance of the two appointments for a further period of two years from 1st April 1908. The Principal recommends the continuance of the class and states that it is working in an efficient condition.

2. The Municipal Council, Kumbakonam, has expressed its willingness to continue the usual contribution paid by it towards the pay of the art instructor for the two years for which

which his retention is recommended.

Retention of the Art Instructor of the Art class attached to the Government College, Kumbakonam for a further period of two years from 1st April 1908.

Please see paragraphs 1 to 3 of the printed note flagged S placed below which gives a full history of the Art Class at Kumbakonam.

2. The retention of the Art instructor (salary Rs.50 per mensem) and of the peon attached to the Art class (salary Rs. 5 per mensem) for a period of three years from 1st April 1905 was sanctioned in G.O. No.494 Educational dated 18th July 1905 and 678 Educational dated 17th October 1905.

3. The Director of Public Instruction now requests sanction for the retention of the instructor and the peon for a further period of two years from 1st April 1908. The Principal of the College recommends the continuance of the class and states that it is working in an efficient condition. The Municipal Council of Kumbakonam which contributes a moiety of the pay of the instructor has consented, it is stated, to continue the contribution for a further period of two years.
