In Government Order No. 25 Miscellaneous, dated 10th January 1908, Educational Department, the transfer of the services of Mr. Suryanarayana, Superintendent of Hill Schools Karsepatam Range, to the District Board of Koraput for employment as a Supervisor of Primary Schools under that body on a salary of Rs 50 per mensem, was sanctioned. Suryanarayana is not now willing to accept the appointment. He states that he

that he would be given its full sanctioned
pay viz: Rs 60 rising to Rs 75 by annual increments
of Rs 3 and that it would not pay him to
accept a less pay. I therefore propose to cancel
his appointment and accordingly have the honor
to request that the Government may be pleased
to cancel their order sanctioning the transfer
of his services to the District Board of Koraput.
The 2nd assistant teacher in the Board Lower
Secondary School at Jypore, is already acting
as Supervisor on probation and I am awaiting
the recommendation of the Inspector of Schools,
I circle, as to his eligibility for Confirmation.
