The D.P.I. requests that M.R.Dy.H. Srinivasa pattachari, Mathematical Assistant, Kumbakonam College (pay Rs 100 per mensem) may be permitted to undertake the work of private ^{tuition} ~~tuition~~ to the eldest ward of the Chokkappa Mudaliyar's estate from the 1st April 1908 to the close of the current calendar year and to receive a monthly fee of Rs 35.

2. The D.P.I. states that the work will not interfere with the legitimate duties of Srinivasa pattachari in the College.

3. Under para 3 of G.O. no. 542 Bdl dated 14th August 1906, officers of the Edl. Dept. may be permitted to ~~take~~ undertake private tuition and to receive remuneration for the same under Article 74 of the C.S.R. for the period of one scholastic term or one long vacation.

4. As in the case of R. Satagopa Aiyangar disposed of in G.O. no. 59 Bdl of 4th Feb. 1907 the Govt. may sanction the acceptance of the fee
