In G.O. No. 172 Mis. Educational dated 22nd March 1899, a special grant of Rs 3,000/- payable in three equal instalments was sanctioned towards the cost of furniture, apparatus &c for Hindu High School, Triplicane. Again in their order No. 35 Mis. Educational dated 20th January 1905, Government extended the time for drawing the full grant of Rs 3,000/- sanctioned in the G.O. quoted above until 31st March 1908. Accordingly the management submitted on the 26th March last through the Inspector vouchers to the extent of about Rs 1,400/- for payment of the last instalment of the grant; but payment of grant on this sum could not be authorized before the close of the last official year as the allotment for the year for grants for furniture, apparatus and other special objects was fully spent by the time the vouchers reached my office. I have, in these circumstances, the honour to request that permission be
