He has passed all the tests except the Precise Writing Test in which he is reported to have failed twice. The post is reserved for Mappilla but qualified men of that community are seldom available. He has been doing very good work these three years and his permanent exemption from passing the Precise-Writing Test is	8									
strongly recommended, on the grounds that it is difficult for a Mappilla to pass the Test and that being the only Mappilla graduate in the inspectorate it is not easy to replace him by a suitable person in the event of his leaving the Department out of discontent.	9
