No: 310 Educational Department dated 29th April 1908, I had been to the asst. J. G. of police, as the J. G. was out of the Station, to request him to recommend me for exemption. But the asst. J. SUBJECT.

Petition for exemption from the matriculation examination for enlistment as a Sub Inspector of Police.

Petitioner's application for exemption from the ^{matriculation} examination was disposed of in G.O. No. 310 Sd. dated 27th April 1908. Petitioner now states that he saw the Assistant Inspector General of Police & requested that officer to recommend him for exemption, and was told that he could not be entertained as a Sub Inspector, as the Govt. had refused to grant exemption in similar cases recommended by the I.G. of Police. Petitioner therefore again prays for exemption.

2. Attention is solicited to the notes of the Honble Mr. Forbes on pages 13 & 14 of G.O. No. 341 P. dated 8th July 1907, pages 4 of G.O. No. 587 Sd. dated 7th September 1907 & pages 7 & 8 of G.O. No. 687 Sd. dated 10th October 1907, in which he has strongly expressed himself against the enlistment of non-matriculates in the Police Department.
