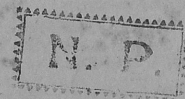

2. In that order the Government raised the limit of pay of the appointments for which educational qualifications are required from Rs. 15 to Rs. 20 and requested the Commissioner for Government Examinations to prepare and submit a draft of the alterations in the Public Service Notification rendered necessary by the raising of the limit of pay from Rs. 15 to Rs. 20.

3. The Commissioner for Government Examinations now submits the draft called for and it runs as follows:—
