Sir

I have the honour to request that Government be pleased to exempt S. Manikkam Pillai, 4th compositor on Rs 15 in the District Press, from the operation of the examination rules in view to his being confirmed as permanent 3rd compositor on Rs 20.

2. S. Manikkam Pillai has passed the Primary examination and held the post of compositor in this District Press on Rs 12 from 16th November 1893 to 25th September 1905 and on Rs 15 from 26th September 1905 to 13th February 1907 having been already exempted by Government in their order No. 682, dated 24th October 1905 from passing the Upper Secondary examination for promotion to a post on Rs 15.

W. 3. Though the post has been vacant since 14th February 1907 and applications from passed men have been invited by notification in the Fort St. George Gazette, none have been presented till now.

4. Manikkam Pillai has already acted in the vacant post since 14th February 1907 and deserves confirmation
