In G.O. no. 224 bdl dated 23rd March 1908, the Govt. permitted the Asstt Suptd. and First Instructor, Medical School, Rayapuram, to occupy rent-free the quarters provided for the Superintendent of the hostel attached to the Medical School, Rayapuram, so long as he performed the duties of the Suptd. of the hostel.

2. Referring to the above order, the A.G. enquires whether it is the intention of Govt. that the Asstt Suptd. should be allowed to occupy the quarters rent-free from the 6th February 1907, the date on which he actually occupied the quarters or from the 23rd March 1908, the date of the order permitting him to occupy the quarters.

3. In reply to the question when the Asstt Suptd. began to do the duties of the Superintendent of the hostel, the D.P.I. states

that the Asst Supdt. has been doing the duties of the Supdt of the hostel from the 13th September 1903, the date on which the hostel was opened and that he occupied the quarters provided for him on the 6th Feb. 1907.

4 - It is for consideration whether the Asst. Supdt. may be allowed to occupy the quarters rent free from the 6th Feb. 1907, the date on which he occupied them. If he is to be allowed to occupy them rent free from the 6th Feb. 1907, the draft placed below may issue with the concurrence of the Financial Department.
