I have the honour to solicit the sanction of
Government to the exemption from the Matriculation
Examination for appointment as a Sub-Inspector of Police

2. He comes of a respectable Travancore family, his
father being now the Superintendent of the Trivandrum
Central Jail. He is the brother of Mr. L.P. Swyny, whose
exemption from the Matriculation Examination was sanction-
ed in G.O., No. 56, Mis., Educational, dated 21st January
1908.

2. He was educated at St. Joseph's College in
Coonoor and studied up to the Matriculation class. He
can read and write Malayalam and would probably be useful

in Malabar. He is 21 years of age and an exceptionally good athlete. He has also been a Sergeant in the Nilgiris Volunteer Rifles. I consider him a thoroughly suitable candidate and, as I have before represented to Government, we badly want some country-born Europeans of good status.
