In para 5 of G.O.No.302-L.dated 27-2-1908, Government raised the allotment of Teaching Grants from Rs.12,380 (provided from the Local Funds) to Rs.46,370, and credit was taken for a provincial subsidy of Rs.37,270 in addition to Rs.21,730 sanctioned already. This subsidy is shown to be for "Teaching Grants and other purposes" in Government endorsement No.976-1 L.dated 13-3-1908. I have the honour to request you to be good enough to let me know what "other purposes" is.

2. The total contribution from Provincial funds on account of Education is Rs.61,470 (Vide appendix to G.O. No.302-L.dated 27-2-1908). I gather that the details of expenditure for this amount are as shown below.

I have no information on the question raised by the President, but it seems to me that the words "other purposes" have no special significance so far as this Board is concerned as the whole of the subsidy of Rs 37,270/- and more will be required for payment of teaching grants seeing that the allotment for the purpose entered by Government in the Board's budget for 1908-1909 is Rs 46,370/- only instead of Rs 56,370/- proposed by me.

2. The provision of Rs 61,470 in the District Board budget on account of contribution from Prov. funds appears to be correct. The amount is made up of the following items:-

Subsidy for revision of establishments in Board Schools.	Rs 217 30
Subsidy for teaching grants and other purposes.	Rs 372 70
Yeomiah allowance on account of Orphan School, Arcot.	Rs 2470
Total	Rs 61,470

Please see remarks in Col. 8 on pages 10th of the Budget statements with G.O. no. 302 L dated 27th February 1908.

3. The yeomiah allowance of Rs 2,470 does not come from the Educational budget. Yeomiah allowances are all shown under in the C.B.E. under 2 - Assignments and Compensations, and this particular item appears to be included under 2 F miscellaneous compensation.

The Madras office has not ^{yet} been able to trace the G.O. sanctioning this yeomiah allowance.
