Read G.O., No. 323 Educational dated 1-5-08 stating
that in deference to the representations of the Council, the
Government will be prepared to accept the book value of the
Government Girls' school (i.e. Rs 7204) as a contribution from
the Municipal Council of Madura towards the cost of constructing
a new building for the school and will not insist upon the --
Municipal Council's giving over to them the site known as Andi-
kadai pottal or contributing Rs 23,000 for the acquisition of
Doraisami Aiyar's house and also stating that it must be clearly
understood that, in view of these concessions, the site known
as Andikkadai pottal must not be utilised for any building pur-
pose at any future time, but must be reserved in its entirety
as an open space.
