I have the honour to request that Government will be pleased to sanction, under article 137(a) of the Civil Account Code, a special advance of Rs 50/- for the hostel attached to the Government Training School, Villupuram, similar to the advances sanctioned for the hostels attached to the Teachers' College, Saidapet and the Government Panchama Training School, Madras, Vide G.Os. Nos. 374 Educational dated 5th July 1901 and 167 Educational dated 10th March 1904. The Inspector of European and Training Schools reports that the advance is chiefly intended for purchasing the provisions required for the year when the articles of food-stuff are sold cheap, and storing them up for consumption and that this would
