The balance of the Waltair Orphan Asylum on the 31st March 1908 was Rs. 207-3-2. There are now in the Civil Orphan Asylum only two orphans belonging to the Waltair Foundation and from paragraph 4 of the office-note on page 3 of G.O., No. 276, Educational, dated 9th April 1908, it is observed that they will in the ordinary course continue in the asylum until July and September 1909 respectively. At the rate of Rs. 15 per mensem for the maintenance of each pupil, the balance on hand will be inadequate to meet the cost of maintenance of the two remaining pupils till their discharge. Under paragraph 1 of G.O., No. 482, Educational, dated 29th June 1894, the Government will have to meet the balance of the cost required. When the balance on hand has been exhausted, the Civil Orphan Asylum will come up for this contribution.
