SUBJECT.

The Supdt. Govt. Museum, requests the sanction of Govt. for the employment of a temporary draftsman on Rs 30 per mensem, for one month or six weeks, to assist Mr. Bruce Foote in painting numbers on specimens of the pre-historic collection, which is now being fin arranged.

2. There is no provision in the Museum Budget to meet this charge; the Supdt. therefore proposes a reappropriation from the amount provided for "Establishment, Commemorative Public Library - Sub-Librarian."

3. The question for consideration is whether the employment of the draftsman is to be sanctioned for a month or six weeks. Submitted that the employment may be sanctioned for six weeks so as to avoid a further reference on the subject from the Commr.
