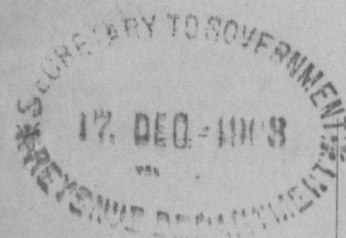

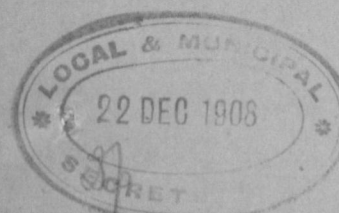

2. The draft may be sent to the Rev. Department for acceptance.

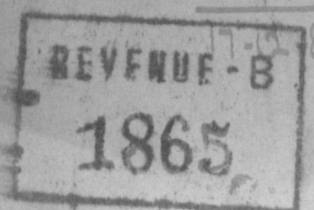
