I have the honour to request that Government will be pleased to approve of the appointment of Mrs. M.D. Paul as headmistress of the Government Training School for Muhammadan Women to be newly opened at Guntur from 1st January next with reference to G.O. No. 183 Educational dated 13th March 1908. Under G.O. No. 608 Educational dated 7th October 1904, the post of headmistress of the School, which was then in Gunnairheed is intended for a European or a Eurasian : but the Inspectress of Girls' Schools, Northern Circle, states that no such teacher is available, that she received applications from only two candidates—one a Muhammadan mistress of the lower secondary grade without much experience of teaching work and the other from a native Christian mistress holding a trained teachers' certificate of the secondary grade and with a knowledge of Hindustani and with about ten years' service as headmistress

of a Muhammadan School- and that the latter who is the better⁴ qualified of the two should be appointed. In these circumstances, I beg to request that the increased rate of pay fixed for the post may be allowed to Mrs. Paul. She will be appointed on probation for a year in the first instance and will be confirmed after the expiry of the period if her work is reported to be satisfactory.

In G.O. no. 608 Bdl dated the 7th October 1904 the Govt. fixed the pay of the post of headmistress of the Govt. Training School for Muhammadan women at Guntur at Rs 5-0 per mensem in order that a European or Eurasian might be appointed as headmistress.

2. In G.O. no. 183 Bdl dated 13th March 1908 the Govt. sanctioned the transfer to Guntur of the Govt. Training School for Muhammadan women at Guntur.

3. The School is to be opened at Guntur in January next and the D. P. I. states that no European or Eurasian teacher is available for appointment as headmistress. He has therefore selected a native Christian mistress, Mrs. M. D. Paul ^{Mrs Paul} for the appointment. ~~She~~ holds a trained teacher's certificate of the Secondary grade (matriculation standard); knows Hindustani and has put in ten years' service as headmistress of a Muhammadan School.
