Referring to your letter, marked Dis. No. 815 of 1911, dated 14th February 1911, item 2 to wit:- "that the work <sup>be</sup> completed before the 31st of July 1912," I have the honour to say that the work is nearing its completion and that the contractor is speeding the work, <sup>as</sup> much as possible, having now some 150 men in employ thereon, but it may be possible that the building will not be quite completed by the 31st of this month, but that it will surely be completed a month later and I therefore have the honour to request you to be good enough to grant us extension of time for one month namely until the 31st of August 1912.
