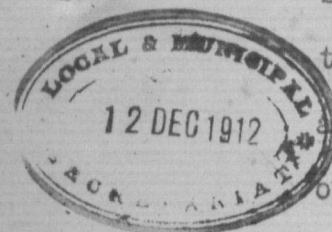

I have the honour to bring to your notice that the
(1) Government Order No. 608, dated 9th July 1912, which placed only
Rs 1,000/- at the disposal of the Council for this year, towards
the construction of a building for the Municipal Elementary
School at Nunepalli village, within our Municipal limits, for
which we had applied to you. In consultation with the local
Educational authorities, as it was found that no suitable
building, bearing in mind the instructions given in your letter
Ref on Cur No. 2729/12, dated 20th April 1912, could be con-
structed within the amount sanctioned, an estimate for Rs 3000/-
has been prepared after the same was carefully checked by the
permanent Overseer and acting Sub Divisional Officer, Public
Works Department, Nandyal. The same was sanctioned by the
Council and tenders are called for. As more than the collection
of materials to some extent cannot be done for Rs 1,000/-
sanctioned by Government for this year, I request you will be
kind enough to see that the Government allots the balance of
Rs 2,000/- for us during next official year. If you can kindly
assure me of this sanction, I shall not allow the work to be
stopped after its progress to the value of Rs 1,000/- but shall

continue

continue it in anticipation of the sanction. I request you
will kindly do this.
