In continuation of my letter to Government Ref on Cur No. 2935 /12, dated 21st August 1912, I have the honour to submit herewith a rough plan and two estimates aggregating Rs 9,082/- for extensions and improvements to the hostel buildings attached to the Teachers' College, Saidapet, and to request that you will be so good as to obtain the approval and sanction of Government for the work and for its execution departmentally.

2. The additions have been considered necessary on account of the increased number of students now admitted for training in the L.T. section of the College. Taking into consideration the accommodation available at present and the number of students who reside in the college hostel, accommodation will have to be provided for at least 30 additional students. The construction of a block of rooms in view to provide quarters for this number

will prevent the overcrowding now complained of.

2. I consider that the work should be done departmentally for the following reasons:-

1. the extension is not a large piece of work requiring elaborate plans and estimates;

and
it will follow the design of the existing blocks;

2. the work will be done more cheaply and more expeditiously by the contractor who built the existing hostel buildings than by the Public Works Department

and

3. all the hostel buildings as they now stand, were built departmentally from time to time as necessity for their extension arose.

The enclosed plan and estimates have accordingly been obtained from a local contractor.

4. The estimates do not include the cost of painting the doors, windows &c., which will come to about Rs 300/-. I request that an expenditure of Rs 9,382/- on the whole. [Rs 9,082 the total of the two estimates plus Rs 300 for painting &c.] may be sanctioned for the work.

5. The charge can be met from the Imperial grant for the purpose during the current year. The proposed expenditure of Rs 9,382/- exceeds the forecast by Rs 338, but this increase was to some extent anticipated -vide my letter Ref on Cur No.

2935/12, dated 21st August 1912.

Dr. No. 1004-Es, of 14-11-12 the Govt. 26-11-12 approved of the improvements to the hostel attached to the Teachers' College, Saidapet as one of the objects for which the Imperial grant for hostels might be expended. The amount therein proposed was Rs. 6000 for this work as against Rs. 2800 now recommended. It is highly desirable that as much of the hostel grant should be appropriated within the year. In this view at least, the proposal to adopt the departmental management for the execution of the work may be supported in this department, if it will conduce to speedy completion.
