X With reference to Government Order, Educational,
No. 991, dated 11th November 1912, I have the honour, by
direction of the Syndicate, to request that the Government
will provide in the Budget for 1913-14 the sum of Rs17,000
to meet the expenditure of the Tamil Lexicon Committee for
that year.

2 The Syndicate has accepted as a working basis the
rough estimate of expenditure arrived at by the Committee at
its meeting held on 7th October 1911, and in addition to the
annual expenditure of Rs12,000 so estimated a further sum of
Rs5,000 is now being requested from the Government to meet
the probable initial cost of a new font of type which it is
anticipated will have to be purchased.

Under the head 22- Education- University a sum of Rs 1,05,500 has been provided in the budget estimates for 1913-1914. This sum includes Rs 65,000 recurring grant sanctioned by the Govt. of India, Rs 20,000 for meeting charges connected with the travelling allowance of Fellows, Rs 20,000 for meeting expenditure on the Tamil Lexicon and Rs 500 on account of the Johnston of Cammelock Scholarships. Thus a sum of Rs 20,000 has already been provided for meeting the expenditure connected with the preparation of the Tamil Lexicon. The Syndicate now states that only Rs 17,000 will be required for expenditure on Tamil Lexicon in 1913-14. The balance of Rs 3,000 provided in the budget may be allowed to stand in case it is required for increased grants to the University for meeting the travelling allowance of Fellows &c.

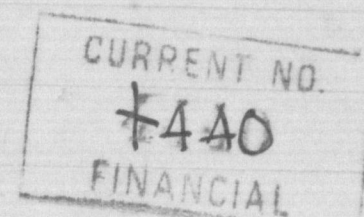
