Sir,

With reference to G.O. No. 915 Mis., Educational,
dated 12th October 1912, the Principal, Teachers' College,
has submitted an indent for Europe Stores the cost of
which is £.199-17-7. It cannot be complied with before the
close of the current official ^{year} and there is no provision
in the next year's budget from which the expenditure can
be met. I am not in a position to say whether with
reference to G.O. No. 355 Fl., dated 20th August 1910, the
amount required can be found next year by reappropriation
without reference to Government. I have, therefore, the
honour to request orders as to whether I may forward the
indent for compliance in anticipation of savings which may

be available elsewhere in the course of the next year.

SUBJECT. Re: transmission of indent for Europe stores required for the Teacher's College, Saidapet.

The D.P.G.'s power of transmitting indents for Europe stores to the India office is subject to the condition, among others, that there is budget provision to meet the cost of the articles indented for or that the amount required can be met by re-appropriation without reference to Govt.

2. In the case now under reference there is no budget provision nor is the D.P.G. in a position to say whether the amount required can be found next year by reappropriation without reference to Govt. Hence the reference. ~~no explanation is furnished as to why the expenditure cannot be provided for in the next year's budget.~~

3. The best course seems to be to move the Financial Dept. to increase the provision for the purchase of European stores for the Teacher's College in the C.B.E. for 1913-14 by Rs 3,000 and when that is done to inform the D.P.G. accordingly. The file may be forwarded to the Financial Department w.o.

~~PP~~ 9.1.13. The fact that funds would be needed for the indent in issue was already placed before Govt., who directed the D.P.G. to apply for allotment later on if he was not then able to meet the charge from savings.

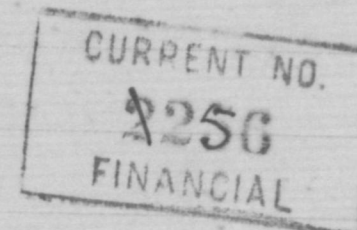
