The Superintendent reports that the boy has been suffering from Hystero - Epilepsy for some <sup>time</sup> past and gets fits almost regularly every morning and recommends his discharge as he has to be continually watched and cannot undergo the training of the school. The boy was admitted into the School on the 8th June 1910 and would in the ordinary course be discharged on the 7th June 1915.

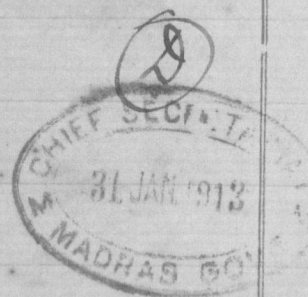
