Sir,

The Secretary to the Commissioner for Government Examinations brings to my notice that the form "Upper Secondary Examination Certificate" was, by an oversight, not included in the list of special forms standardized in G.O. No. 538 Educational, dated 10th September 1910. He states that it is required now for the issue of duplicate certificates and for the preparation of certificates for candidates who complete the partial success achieved by them prior to the abolition of the Examination. He further states that the form need not be standardized but that a supply may be made once for all.

2. According to Rule 99 of the rules printed in

G.O.

G.O. No. 523 Financial, dated 21st August 1912, no form, not included in Appendix XII shall be printed unless at least 50 copies of it are required per annum. In the present ^{case} not more than 25 copies are required annually.

I have the honour to request that Government will be pleased to sanction as a special case the printing of 100 copies of the certificate at the Government Press which will probably suffice for the purposes indicated without the necessity of further supplies.

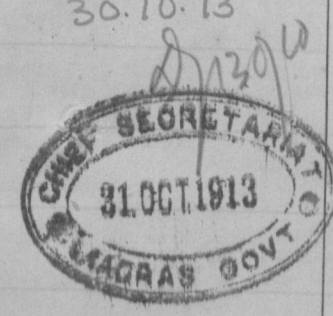

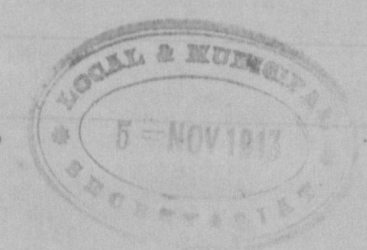
