Sir,

I have the honour to submit the following for --
the orders of Government.

2. B. Bheemalinga Achari, 2nd clerk in the District Forest Office, Ganjam, on Rs. 30-2-40 wishes to appear -- for the Account Test so as to qualify for promotion to -- the post of Accountant in the Forest Department. He -- passed the Middle School Examination of the Madras University in the 1st class in 1890 and the Forest Departmental Test in the 1st class in 1913 and he must pass the Account Test to become eligible for the post of Accountant in a District Forest Office. He has put in 20 years' service in the Forest Department with a break of 5 years during -- which his services were, with the permission of the Board of Revenue, lent as a Revenue Inspector to the Parlakimedi Estate under the Court of Wards where his work was highly commended by the Estate Manager. He worked for about -- 2½ years as Accountant in the District Forest Office and his work has given satisfaction to the last 3 District -- Forest Office Messrs. Fischer, Cox and Bennett.

(V) 3. G.O. No. 54, Educational., dated 31st January -- 1910, granted permission to certain clerks in District -- Forest Offices to appear for the Account Test Higher -- during 1910, 1911 and 1912, but as B. Bheemalinga Achari was in Estate service in 1910 and 1911, he did not appear for the examination in these years, while in 1912 after --

he had returned to the District Forest Office the Office was in such an unsatisfactory condition that the 2 months' leave which B. Bheemalinga Achari applied for in order to study for the examination was not granted as his services could not be spared. He, however, appeared for the -- examination in 1912 and failed.

4. As an exceptional case I request that Government will be pleased to grant B. Bheemalinga Achari permission to appear for the Account Test in 1914 and 1915.

exemption granted to all clerks in

the Account test, Bheemalinga Achari
applied for the examination held
in 1912, but failed. The case of ~~those~~

in St Forest offices who did not
pass the test within the period allowed
in the above G.O. was disposed of
in G.O. No. 824 Sd^o, dated 6th September
1913. Bheemalinga Achari is neither
a head-clerk nor an accountant in
any of those offices. ~~The~~ The Collector
applies for the grant of permission
to him to appear for the Account test.

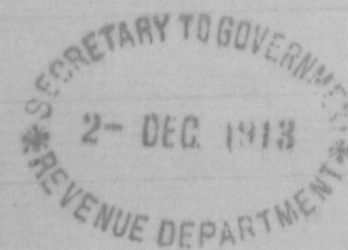
