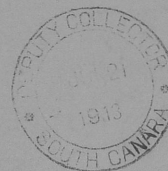
I most humbly beg to submit the follow-

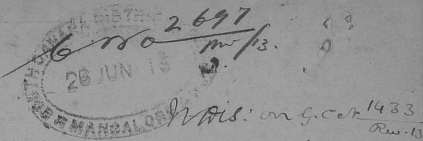

In the adjoining District of Malabar, deserving Moplah young men have been granted exemptions & the Government in order to encourage the Community & this policy has ^{produced} good results. There are at present about half a dozen Moplah Graduates in Malabar such exemptions are still being granted - This District is still exceedingly backward & I think a few such exemptions will go a long way to improve matters.

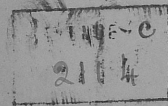
