The Inspectress of Girls' schools, Northern Circle, reports that attempts have been made at the teaching of drawing in all the Government Girls' schools in the circle but that the work is extremely crude as the teachers are ignorant of the very first principles of drawing. For the benefit of these teachers she proposes to arrange with the drawing-masters employed in the secondary schools for boys in some of the large towns to hold classes for two hours on Saturdays on payment to them of a small remuneration. The names of Government Girls' schools, and the number of teachers in them, the names of schools to which the drawing-masters referred to are attached and the amount of remuneration proposed to be given to each of them, are shown in the enclosed statement. The classes are to be held for six months and the total cost, viz., the remuneration payable to the drawing-masters, will be Rs. 70 per mensem or Rs. 420 per annum.

2. The proposal commends itself to me and I have the honour accordingly to recommend that sanction be accorded to it and to the payment of the remuneration of Rs. 420 for the whole course to the drawing-masters referred to for the additional work they have to do.

3. The proposal does not involve any other expenditure.

4. I beg to submit the necessary reappropriation statement for meeting the charge.

[SUBJECT.—*Proposals for the teaching of drawing to teachers employed in Government Girls' schools in the Northern Circle.*]

*From the Director of Public Instruction, dated 28th July 1913, No. 4329.*

Submitted that the Director of Public Instruction's proposals which involve a non-recurring expenditure of only Rs. 420 may be sanctioned.

2. From the reappropriation statement it is observed that it is proposed to meet the cost from the special Imperial grant of 23 lakhs. From paragraph 8 of the Director of Public Instruction's memorandum printed with G.O. No. 264, Educational, dated 27th March 1913, it will be seen that one lakh has been earmarked for temporary training schools. Out of this amount, Rs. 22,200 have been allotted for grants to managers to training institutions for payment of stipends to students under training, and Rs. 60,374 for meeting the cost for the current year of training an extra batch of teachers in Government training institutions, leaving a balance of Rs. 17,426 from which the small sum of Rs. 420 required in the present case can be provided.

## INSTRUCTIONS FOR THE SECRETARIAT.

(a) If a paper is marked to be printed urgently, the Superintendent of the section concerned should sign the Press slip. The Superintendent should exercise a careful discretion in the matter.

(b) Each letter, memorandum, or order, or set of orders, in the file of correspondence should be headed in succession with the Roman numeral I, II, III, etc., the number being written in red ink or blue chalk above the item. The particular papers to be printed in the special issue-copies should be indicated by the Roman numeral (I, II, etc.) by which that item has been headed in the correspondence file. All matter, including marginal remarks or references, to be printed should be written in ink and matter which should not be printed should be encircled. Initials and signatures that are not quite legible should be re-written distinctly.

(b<sup>1</sup>) For rules regarding printing of notes, see rule 315 of the office Manual.

(c) The number of copies and the details of distribution should be filled in by the Superintendent or Referee concerned.

(d) In the absence of special instructions to the Press to keep matter standing for a specified period, ordinary papers of 8 pages and under will be kept standing for one week, and larger papers for two weeks only. The type of notes and of all confidential papers is distributed immediately after striking.

(e) This slip, properly and completely filled in, should accompany every paper sent to Press; it will be returned by the Press when proofs are furnished; it should be sent to the Press when a call is made for revised proofs or when a corrected proof is sent for striking. When finally returned by Press it should be filed with the original order or letter.

## INSTRUCTIONS FOR THE PRESS.

(a) If, in the opinion of the Superintendent of the Press, a paper has been marked urgent unnecessarily, he should send the Press slip to the Registrar with a remark to that effect.

(b) Unless a note to the contrary is made against the matter, pencil entries should not be printed. The Superintendent of the Press may bring to the notice of the Registrar any instance of incomplete or careless editing.

(c) Signature copies of letters to the Secretary of State or to the Government of India should be printed on hand-made paper.

(d) This slip should be returned by the Press to the Secretariat when proofs are furnished; it will be sent back to the Press when proofs are returned corrected and should be finally returned to the Secretariat when struck-off copies are supplied.

(e) The names of the Secretary and Members should be printed in full when they occur on the right hand side, only the first time when they appear on the left side, the initials alone being printed later.
