(S) In G.O.No/785/ Educational, dated 26th August 1912, sanction was accorded for the opening in a rented building at Egmore, of a hostel for Brahmin Widows in connection with the Presidency Training School for Mistresses with effect from 1st September 1912. A hostel with a strength of six was accordingly opened at Egmore in a small building on a monthly rent of Rs. 23 against the sanctioned rent of Rs. 25/- ~~per mensem~~. The Inspectress of Girls' Schools, Central Circle, now reports that as the strength of the hostel has increased to 12 and three more widows are seeking admission into it the building, in which the hostel is located at Egmore is not spacious enough to meet the present requirements and she

consequently proposes to remove the hostel to Triplicane.
As a sufficiently commodious building cannot be had at
Triplicane for a less rent than Rs. 75 per mensem, I have
the honour to request ^{that you will be so good as to obtain} the sanction of Government for the
payment of a house rent ~~of~~ not exceeding Rs. 75/- per
mensem for the hostel with effect from 1st October 1913.

The extra amount required for the five months of the
current year will be Rs. 250/- for meeting which I submit
herewith the necessary reappropriation statement. ^{h. S. S. S. S. S.}

SUBJECT.

Shifting of the Brahman widows' hostel from Egmore to Triplicane & the renting of a building to locate the hostel in the latter place.

Para 2 of D.P.I.'s letter, page 2 of No. 586 dated 24.6.13

The proposal to remove the Brahman widows' hostel from Egmore to Triplicane was made by the D.P.I. in March last when he proposed the establishment of a Govt. Secondary school for girls with a training school attached, in Triplicane. His proposals were approved in G.O. No. 586 Educational dated 21st June 1913.

(F) 2. He now states that a building will have to be rented for the hostel at Triplicane & requests sanction for the payment of a rent of Rs 75 per mensem, as a sufficiently commodious building cannot be had at the place for anything less than that amount.
