 25-1-1914. The Educational authorities have reminded me of *(N) 2-3-14*
 the subject and have been urging on me the necessity of early action in the matter in the interests of the efficiency of the schools.

3/. As has been frequently reported to Government, the Taluk Board is unable to allot from its own funds any sum for the purpose and must depend upon Government for a grant in order that the indent furnished by the educational authorities may be complied with.

4/. I have the honour to request therefore, that you will be so good as to obtain from Government the grant of Rs. 6,640/- referred to in para 1 supra at as early a date as possible so that I may be enabled to equip the schools concerned in full before the close of the current official year.

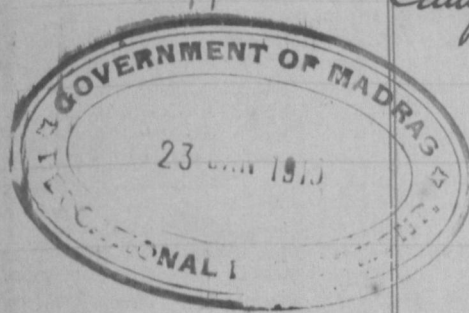
